#### **Background:**

#### **Monthly Summary**

Veolia Water Canada has prepared a summary of the water and wastewater operations over the past month.

#### Ripley Lagoon Blower Building Repairs

The controls that are used during the spring and fall lagoon discharge at the Ripley Lagoon are contained within a building at the south end of the lagoon property. The building sustained some roof damage earlier this year and repairs are required before fall discharge begins.

#### Ripley Wells 3 & 4 Contamination Investigation

From June – November 2021, the raw water samples from the new wells near the Ripley Elevated Tank resulted in low levels of coliform and E. Coli bacteria. Although the weekly samples have been clear of any contamination since that time, Township staff continue to investigate potential causes of this issue. A pumping test was conducted by our hydrogeologist from May 17-18, 2022 to help determine a

potential source of contamination. The conclusion of the report issued on June 29<sup>th</sup> indicated that a leak in the piping between one of the wells to the elevated tank was the most likely source of contamination.

#### **Well Video Inspections**

On July 4, 2022, Council awarded the video inspections of the municipal drinking well in Whitechurch, Huronville and Murdoch Glen.

# **Huronville SCADA Upgrades**

On April 18, 2022, Council awarded SCADA upgrades at the Huron S Pumphouse.

#### Ripley and Whitechurch DWS Inspections

Drinking Water Systems (DWS) are inspected on an annual basis by the Ministry of Environment, Conservation and Parks.

#### **Discussion:**

#### **Monthly Summary**

The summary prepared by Veolia Water Canada is attached to this report.

#### Ripley Lagoon Blower Building Repairs

The moldy ceiling and attic insulation has been removed by a restoration contractor and we are currently waiting for the roofing contractor remove and replace the roof shingles. We are expecting this work to be done by Sept. 2<sup>nd</sup>. We will then be able to proceed with replacing the ceiling, installing new light fixtures and insulating the attic.

### Ripley Wells 3 & 4 Contamination Investigation

On Aug. 5<sup>th</sup>, our Operating Authority, Veolia Canada, conducted a pressure test under the supervision of our consulting engineer. The purpose of this test was to determine if a leak could be detected using the normal pressure in the system. The results of this test did not indicate any detectable leaks. The next step will be to bring in a pump to pressurize the system at a higher than normal pressure to see if a leak is observed.

# Well Video Inspections

Both wells in Whitechurch have now been inspected and are deemed to be in good condition. Murdoch Glen is scheduled to be completed in September and Huronville in October.

# **Huronville SCADA Upgrades**

The original plan was to complete this work in October so the site would be ready for the Township to supply water to Kincardine in late October, however, we currently don't have a delivery date for some of the equipment and it appears that it will not arrive before November at this point. Therefore, the upgrades will have to be delayed until after Kincardine is supplied water.

#### Ripley and Whitechurch DWS Inspections

The score for Ripley was 97% and the score for Whitechurch was 100%.

#### **Financial Impacts:**

The repairs to the Ripley Lagoon blower building will be funded through the 2022 Operating Budget. Ripley Wells 3 & 4 Investigation and the Huronville SCADA Upgrades are included in the 2022 Capital Budget.
