

# The Corporation of the Township of Huron-Kinloss



## BY-LAW

### 2022-153

---

Being a By-law to Appoint Aird & Berlis LLP as the Integrity Commissioner  
for the Township of Huron-Kinloss

---

**WHEREAS** the Municipal Act, 2001, c. 25 (the Act) Sections 8 and 9 (1) provide municipalities with the powers of a natural person to enable them to govern their affairs as they consider appropriate under this or any other Act and to enhance their ability to respond to municipal issues;

**AND WHEREAS** Section 223.2 of the Act, as amended, authorizes a municipality to establish a code of conduct for members of the council of the municipality and of its local boards;

**AND WHEREAS** Section 223.3 of the Act, as amended, authorizes a municipality to appoint an Integrity Commissioner who reports to council and who is responsible for performing in an independent manner the functions assigned by the municipality;

**AND WHEREAS** By-Law 2020-109 passed on the 19<sup>th</sup> day of October, 2020 outlines the duties and responsibilities of the Township's integrity commissioner;

**AND WHEREAS** The Council for The Corporation of the Township of Huron-Kinloss deems it expedient to appoint an Integrity Commissioner for the Township of Huron-Kinloss;

**NOW THEREFORE** the Council of The Corporation of the Township of Huron-Kinloss enacts as follows:

- 1.0 That The Corporation of the Township of Huron-Kinloss Council hereby appoints Aird & Berlis LLP as the Integrity Commissioner for the Township of Huron-Kinloss with the term to commence September 19, 2022 and end on December 31<sup>st</sup>, 2023.
- 2.0 That The Corporation of the Township of Huron-Kinloss Council hereby authorizes entering into an agreement with Aird & Berlis LLP which is attached as Schedule "A" and forms part of this By-Law.
- 3.0 That the Mayor and Clerk are hereby authorized to sign on behalf of the Council for The Corporation of the Township of Huron-Kinloss, any contracts and other documents required to authorize the agreement and to affix the corporate seal of the Township of Huron-Kinloss.
- 4.0 That By-Law No. 2020-110 being the Integrity Commissioner Agreement By-Law (Elston) is hereby repealed.
- 5.0 This By-law shall come into full force and effect upon its final passage.
- 6.0 This by-law may be cited as the "Integrity Commissioner Agreement Aird & Berlis LLP By-Law".
