## **BY-LAW**

#### 2022 - 181

Being a By-law to Grant Specific Authority to Individuals Engaged in Winter Maintenance Services on Behalf of the Township of Huron-Kinloss

**WHEREAS** the *Municipal Act S.O. 2001*, c 25, Section 5(3), as amended provides that a municipal power, including a municipality's capacity rights, powers and privileges under section 9, shall be exercised by by-law;

**AND WHEREAS** Section 170 (12-15) of the Highway Traffic Act, R.S.O. 1990, c. H8 authorizes a municipality to appoint officers to carry out then provisions of this act;

**AND WHEREAS** The Council for the Corporation of the Township of Huron-Kinloss deems it expedient to grant authority to plow operators to call tow trucks to remove vehicles interfering with winter maintenance operations;

**NOW THEREFORE BE IT RESOLVED THAT** the Council of The Corporation of the Township of Huron-Kinloss **enacts** as follows:

- 1.0 That the Council of The Corporation of the Township of Huron-Kinloss hereby declares that the individuals listed on Schedule "A" attached to and forming part of this by-law, while engaged in the activity of winter maintenance on behalf of the Township of Huron-Kinloss, shall be deemed to be By-Law Enforcement Officers and shall be granted authority under Section 170 (12-15) of the Highway Traffic Act, R.S.O. 1990, c. H. 8 and under Section 5.2.1 (i) of By-Law 99-20 (as amended) to, upon discovery of any vehicle parked or standing in contravention of Section 170 (12) of the Highway Traffic Act or Section 5.2.1 (i) of By-Law 99-20 (as amended) cause it to be moved or taken to and placed or stored in a suitable place and all costs and charges for removing and storage thereof, if any, are a lien upon the vehicle.
- 2.0 That By-Law No. 2020 03 is hereby repealed
- 3.0 This by-law shall come into full force and effect upon final passage.
- 4.0 This by-law may be cited as the "Plow Operators Specific Authority to Tow By-Law, 2022".

READ a THIRD TIME and FINALLY PASSED this 7th day of November, 2022.
