### Invermay Bridge Closing For Winter Season

**Bruce County, Ontario:** Please take notice that the Invermay Bridge, located on Concession Road 6 in Arran-Elderslie, west of Mill Road, will be closed to vehicles and pedestrians for the winter season. This closure will be in effect from Friday, November 13, 2020 to approximately Thursday, April 15, 2021.

The Invermay Bridge closes each winter due to load limits that will not support snow clearing equipment.

Signage and barricades will be in place, and alternate routes are available.

Thank you for your understanding and for continuing to drive with caution on Bruce County roads during the winter season.

### Housing Stability Fund assisting individuals, couples, and families in Bruce County

**Bruce County, Ontario:** In response to COVID-19, Bruce County will receive \$680,180 in funding for Phase 2 of the Social Services Relief Fund from the Ontario government. These funds flow through the Community Homelessness Prevention Initiative (CHPI) and support Bruce County's Housing & Homelessness Plan objectives.

\$335,000 of this funding will help grow Bruce County's Housing Stability Fund, which is being used to assist renters who are in a precarious financial situation due to COVID-19, are at risk of becoming homeless, and/or have had to look for alternate accommodations.

This assistance for renters will be administered by expanding the Housing Stability Fund guidelines to be more flexible with assistance for residents experiencing rent arrears, utility arrears, and first and last month's rent instability.

People who live in Bruce County and are eligible can apply online for assistance. The application and a full listing of guidelines and eligibility are available at the following link:
