

# **Board and Management Committee Highlights**

As the AMCTO President, I cannot say thank you enough for all that you accomplished during your last term of council and for setting the groundwork for a successful 2022-2026 term. As you continue to come down from the busy election season, here are a few of the highlights from our last AMCTO Management Committee and Board of Directors meetings:

Management Committee Meeting – October 21, 2022

# 2023-2025 AMCTO Operating Budget

AMCTO staff presented the proposed operating budget for 2023-2025. Highlights include a
moderate increase in revenues and key investments to kick-start the implementation of the
Association's new Strategic Plan.

#### **Municipal Ethics Simulation Program**

 A topic that is of continuous interest to AMCTO's membership, especially those in leadership positions, is municipal ethics. To meet this demand in a relatively unique manner, AMCTO is looking to work with Choice Point Solutions to create an ethics simulation program. Staff will look to develop this program in time for the fall of 2023.

Both items, the 2023-2025 operating budget and Municipal Ethics Simulation Program were debated and approved at Management Committee as well as at the November 18 Board of Directors meeting.

# **Board of Directors Meeting – November 18, 2022**

#### **Annual Zone Report**

 The Board of Directors were pleased to be joined by many of our dedicated Zone Chairs or designates. The Zone representatives provided an overview of the busy 2022 calendar.
 Many also took the opportunity to let the Board know about where some of the challenges and opportunities exist at the local level. Thank you all for your hard work and I recommend that all AMCTO members consider being part of your Zone Executive in 2023!

The day before the Board meeting, we were also grateful to attend a joint Zone Executive/Board of Directors leadership training session. At the session, we invested equal time to understanding ourselves as leaders as well as how we can uncover and address unconscious bias.



#### **Municipal Research Facilitation**

• Through the Association's State of the Membership survey, we know that our membership values municipal-specific research and would like AMCTO to do more within this area. At the Board meeting, AMCTO Policy and Government Relations staff presented a research facilitation plan, which will see AMCTO investing in greater access to academic and sector research sources and conducting its own research in policy areas within our Issue Profile.

#### **Provincial Legislation**

- You have probably already heard about a slew of new municipal legislation being introduced and passed by the Ontario Government. As a Board, we have been tracking these legislative processes and, with the support of staff, voicing our concerns. We will continue to provide updates to you, our members, through advocacy updates and our ongoing policy and government relations work.
- At the Board meeting, we discussed the most recent legislation, Bill 23, and continue to
  express our disappointment with the complete lack of consultation with AMCTO members as
  well as the negative financial impact this Bill will have on many local government budgets.

Again, thank you for all you do and for your commitment to AMCTO. On behalf of the Board, I want to wish you a happy holiday season and we look forward to working and connecting with you in 2023!


