



2022 FIRE DEPARTMENT TRAINING

2022 provided to be a very productive year for Fire Department Training. This was our first full year post COVID-19 where all training returned to normal operations and was completed in person. The Fire Department Training Officers continued to provide an impressive level of dedication to developing our newest firefighters and to engaging more senior and experienced members with a diverse program of skills and scenario based training exercises.

Training topics covered throughout the year consisted of fire suppression, search and rescue, firefighter self-rescue, rapid intervention, incident command, vehicle extrication, emergency medical response and patient care, first responder mental health awareness, hazardous materials, radio communications and occupational health and safety. All Fire Service specific subjects are delivered through in-class, skills practice and scenario based methods. Our training programs are focused on the National Fire Protection Association (NFPA) Standards which we use as the foundation for all training delivered within our fire services allowing us to maintain continuous compliance with industry best practice.

The Huron-Kinloss Fire and Emergency Services had previously adopted a requirement that all fire department personnel obtain the appropriate NFPA Certifications. In 2022 this commitment was further strengthened by the introduction and adoption of provincial legislation in the form of the Firefighter Certification Regulation. That being Ontario Regulation (O/Reg.) 343/22. This regulation legislates that all personnel in the Fire Service must obtain and maintain the minimum NFPA Professional Qualifications (certification) as determined for the job each firefighter performs.

The Township of Huron-Kinloss continues to operate and utilize its own Fire Training Facility with the ability to conduct live fire training exercises, for the purposes of ensuring NFPA Skills and Certifications are achievable and current.

2022 FIRE PREVENTION and PUBLIC EDUCATION

The Fire Protection and Prevention Act, 1997 (FPPA) requires all municipalities in Ontario to establish a program which must include public education with respect to fire safety. Public fire and life safety education aims to increase awareness about fire prevention and safety to reduce the loss of life and property within the municipality.

The Huron-Kinloss Fire and Emergency Services brings life-saving messages to the community through many public fire safety education programs and activities.

These programs and activities target fire risks identified through a community risk assessment that considers previous fire losses, building stock and the demographic profile of the municipality. The Fire Departments also partner with a variety of community groups and organizations to provide leadership in public fire safety education within the community.

In 2022 all in person and community organised public events attendance and all in person public education delivery resumed to its full capacity.

The Fire & Emergency Services continue to post messages and information related to smoke alarms, carbon monoxide alarms, home escape planning and general fire safety subjects, emergency management and general community well-being subjects using the Townships website and social media platforms.

Additionally, The Township of Huron-Kinloss has an up to date Fire Prevention Program Policy that details the Smoke Alarm and Carbon Monoxide Alarm programs of the Fire Department. It is the policy of the Huron-Kinloss Fire and Emergency Services that no home will be left unprotected. Every time the Fire Department attends a residential occupancy for anything other than a medical call, a Smoke and CO Alarm inspection is conducted. In cases where a smoke or CO alarm is found to be missing or inoperable the Fire Department replaces the smoke/CO alarm with a fully functioning alarm.








2022 FIRE INSPECTIONS and INVESTIGATIONS

2022 EMERGENCY MANAGEMENT ACTIVITIES

In 2022 The Township of Huron-Kinloss met our full compliance requirement of the Emergency Management and Civil Protection Act as informed by the Office of the Fire Marshal and Emergency Management.

This includes:

- Annual Exercise conducted and completed for Emergency Control Group
- Annual Training conducted and completed for Emergency Control Group
- Semi-Annual Community Emergency Management Program Committee Meetings conducted and completed
- Annual Hazard Identification Risk Analysis review and update completed
- Annual Critical Infrastructure list reviewed and updated.
- CEMC and A/CEMC attended Bruce Regional Sector Meetings
- Annual Public Education requirements were met

In addition to this the Fire Chief participated in the annual Emergency Management Training and Exercise components of the Township of Ashfield-Colborne-Wawanosh Emergency Management program as part of the Fire Chief management duties provided under agreement to the Township of Ashfield – Colborne-Wawanosh.

Additionally, 2022 saw the introduction of a new position within the organizational structure for the Township of Huron-Kinloss. The need for this position was identified through attrition and growth. The newly created position is titled the "Emergency Services/Health and Safety Coordinator"

In 2022 the Emergency Services/Health and Safety Coordinator focused on training, certification and job shadowing along with completing administrative duties associated with the coordination of the Township of Huron-Kinloss' Emergency Management Program. In December of 2022 the Emergency Services/Health and Safety Coordinator completed all job shadowing, training, and certification components to be appointed as the primary Community Emergency Management Coordinator for the Township and was duly appointed by Council as such.
