RE: Physician Recruitment and Retention

Your Worship Don Murray,

As you may know, a delegation from the Municipality of Kincardine attended the ROMA conference and participated in meetings with both our local MPP, the Honourable Lisa Thompson, Minister of Agriculture, Food, and Rural Affairs, and the Minister of Health to highlight the challenges of adequate access to health care in rural areas and the need to fund recruitment and retention programs for physicians and nurse practitioners.

We asked that the Province support physician recruitment and retention efforts in order to access equitable health care services in rural areas. We proposed that the Province acknowledge and financially support the work Municipalities have undertaken to recruit and retain physicians in rural communities, and create a rural grant program for the recruitment of healthcare positions, and increase financial contributions for funding of nurse practitioners, as well as include them as a practitioner in the OHIP system.

We believe that it is at the Provincial level where funding for local health care comes from. However, we also know that in the absence of that senior government funding our communities look to the local government to help make improvements to their day to day lives, including health care.

Kincardine has invested in physician recruitment and retention activities in our municipality to mitigate the current situation of doctor shortages occurring across all of Ontario, especially acute in rural areas. We appreciate the funding that has come from Huron Kinloss in the past to offset some of our local recruitment and retention initiatives.

Additionally, Council has supported paying 60% of the cost of an additional full-time nurse practitioner to support the local Family Health Team.

Our request to you as our neighbouring municipality is that you work with us to advocate for more funding from the Province to go towards rural health care, including physician
