**BEING A BY-LAW TO AMEND BY-LAW NO. 2018 – 98, BEING THE  
COMPREHENSIVE ZONING BY-LAW OF THE  
TOWNSHIP OF HURON-KINLOSS  
McClory**

**WHEREAS** Section 34 of the Planning Act, R.S.O. 1990, Chapter 13 authorizes the Councils of Municipalities to enact and amend zoning by-laws which comply with an approved official plan;

**AND WHEREAS** the Council of The Corporation of the Township of Huron-Kinloss has enacted By-law 2018-98; a zoning by-law enacted under Section 34 of the said Planning Act;

**AND WHEREAS** the Council of The Corporation of the Township of Huron-Kinloss desires to amend By-law 2018-98;

**NOW THEREFORE BE IT RESOLVED THAT** the Council of The Corporation of the Township of Huron-Kinloss **ENACTS** as follows;

1. THAT Schedule 'A' to By-Law No. 2018-98, as amended, is hereby further amended by changing thereon from Environmental Protection (EP) to Residential One-Holding (R1-H) and from Residential One – Holding (R1-H) to Environmental Protection-Special Zones (EP-25.174) lands described as HURON CON A PT LOT 7 RP;3R9664 PT PART 1 Township of Huron-Kinloss (Former Huron Township) attached to and forming a part of this By-Law.
2. THAT By-law No. 2018-98, as amended, is hereby further amended by adding subsections to Section 25, as follows:  
  
25.174 Notwithstanding the provisions of Section 2.10, Interpretation of Zone Boundaries, the area zoned as EP-25.174 includes the area 70 metres from the rear lot line for the entire width of the lot. No buildings or structures are permitted within the EP-25.174 zone.
3. That this by-law takes effect from the date of passage by Council, and subject to the provisions of the Planning Act, R.S.O. 1990, as amended.
4. That this by-law may be cited as the "Zoning Amendment By-law – Z 2022-117-McClory" By-law
