AND grants an exemption to the Noise By-Law at the Lucknow Community Centre, 694 Willoughby St, Lucknow Friday, June 23 from 11:00 p.m. to Saturday, June 24 at 1:00 a.m. and Saturday, June 24 from 11:00 p.m. to Sunday, June 25 at 1:00 a.m. for a Lucknow Kinsmen ball tournament and beer garden;

AND at 5 Queen Street, Ripley on Saturday, August 5 from 11:00 p.m. to Sunday, August 6 at 1:00 a.m. for a wedding reception with a live band.

### **Background:**

The Township of Huron-Kinloss By-Law No. 2005-101 being the By-Law to control noise outlines prohibitions of noise by time and place. The By-law prohibits the production of amplified sound between the hours of 11:00 p.m.one day to 7:00 a.m. the next day (9:00 a.m. Sunday). Council may by resolution grant an exemption to the Noise By-Law.

The Township received two requests for an exemption to the Noise By-Law;

694 Willoughby St, Lucknow Friday, June 23 from 11:00 p.m. to Saturday, June 24 at 1:00 a.m. and Saturday, June 24 from 11:00 p.m. to Sunday, June 25 at 1:00 a.m. for a Lucknow Kinsmen ball tournament and beer garden and 5 Queen Street, Ripley on Saturday, August 5 from 11:00 p.m. to Sunday, August 6 at 1:00 a.m. for a wedding reception with a live band.

#### **Discussion:**

The requests were circulated to Township Staff. No concerns were noted. Staff recommends approval of the exemption request for the event and will encourage the applicants to notify their neighbours in proximity of the event. If approved, the Township By-Law Officer and South Bruce O.P.P will be notified by the Deputy Clerk.
