A 6-Circuit 120vac power bar shall be installed at the cab console.

#### **Duplex Receptacle**

A 120 volt AC duplex receptacle shall be installed beside the cab console and shall be wired to the shore line circuit.

#### **Duplex Recept Comp R1**

A 120 volt AC duplex receptacle shall be installed high in compartment R1 and shall be wired to the shore line circuit.

# **Duplex Recept Comp R2**

A 120 volt AC duplex receptacle shall be installed high in compartment R2 and shall be wired to the shore line circuit.

# **Duplex Recept Comp R3**

A 120 volt AC duplex receptacle shall be installed high in compartment R3 and shall be wired to the shore line circuit.

#### **Power Bar**

Three (3) 120vac 4-circuit power bars shall be provided.

## **Indicator Lamp**

There shall be a Green LED Master-Battery-On lamp installed at the skirt below the driver cab door. The lamp shall illuminate when the mastery battery switch is on.

#### **Air Pump**

A Kussmaul Air Pump shall be installed. The Auto Pump AC is a 120 volt 60 Hz shaded pole A.C. motor operating a single cylinder air compressor designed specifically for installation on vehicles with air brakes. During long idle periods of the vehicle, when even the slightest seepage can cause an air brake system pressure to drop below the brake lockup pressure, the Auto Pump AC automatically starts to maintain the pressure.

The Auto Pump AC motor is directly coupled to the compressor section eliminating all belts and pulleys and assuring long life and reliable operation. A heavy duty pressure switch is adjusted to start the compressor when the system pressure drops below 75 PSI and stops the compressor when 95 PSI is attained. The start up pressure is field adjustable - the pressure differential between start up and stopping is fixed. The moisture trap provided permits routine draining of accumulated moisture in the Auto Pump output line.

#### **Tire Pressure Monitor**

There shall be a Real Wheels Tire Pressure Monitor Kit installed on the apparatus. The kit shall include six (6) valve stem pressure sensors, one (1) for each tire. Upon installation, the sensor records the tire pressure and if the pressure drops by 8psi, a Red LED lamp will flash on the sensor to alert and indicate a low tire pressure.

\* the kit shall be shipped loose for fire department installation after apparatus is placed in service \*

#### **Axle Trim**

There shall be Chromed ABS Axle Trim installed on the front & rear axles. The trim shall be single-piece and cover the axle and wheel lugs to provide a pleasing appearance.

#### Antennas & Mobile Radio(s)

There shall be two (2) mobile radio antenna cables installed on the chassis cab roof. The cables shall be routed to the cab console for hook-up to the mobile radios.

\*\*\* Mobile Radio to be supplied by the Fire Department \*\*\* OEM to Install Radio \*\*\*

#### **Backup Camera**

An FRC inView TrueSight Back-UP Camera shall be installed with the following features:

- \* one (1) 7" cab monitor
- \* one (1) heated back-up camera
- \* one (1) hood front center camera

### **Winch Receiver Front**

There shall be a 2" Winch Receiver Tube installed on the front-center of the bumper extension.

#### **Winch Power Cables, Front Bumper**

Heavy-Duty Battery Cables shall be routed from the chassis batteries to the front bumper for 12 volt power

supply to the winch. The cables shall be placed in loom and properly secured along the chassis frame rails.

## Bumper Extension 24" w/ (2) Speed Lays OBM

The chassis front bumper shall be extended 24" forward with 3/8" steel plate channels. The top surface shall be enclosed with polished aluminum checkerplate to provide a pleasing appearance. A re-inforcement structure shall be included to support the bumper sides trailing edges.

#### Polished Bumper

The bumper shall be fabricated from polished stainless steel, including the left and right bumper trailing edges. The assembly shall be designed to maximize the available usable space for fire service applications.

## Speed Lay Compartment

There shall be an aluminum transverse speed-lay compartment installed ahead of the chassis grille with two (2) hose lays to carry 200' of 1.5" hose each. A polished aluminum checkerplate lid shall be attached with stainlesss steel piano hinge. Rubber door holders are included to support the lid in the open position and a stainless steel latch to secure the lid in the closed position. Two (2) black vinyl tarps shall be attached, one (1) at each side of the speed-lay cover. Bungee cord shall be sown onto the bottom corners to secure the tarps.

#### RC Monitor OS

The front officer-side of the bumper extension shall allow for a RC Monitor installation.

#### **Bumper Antennas w/ LED**

There shall be two (2) stainless steel guide poles mounted at the front corners of the extended bumper. The purpose of the guide poles are to give the driver a visual indication of the location of the front corners of the bumper.

#### Led Lights

Amber LED lights at the top of each guide pole shall be wired to the truck accessorie curcuit.

#### **Pump House**

The pump house shall be integral to the body at the front. The pump house shall be a fabricated aluminum sub-structure, fully enclosing the pump assembly. Access panels are located at the top, the driver-side & the officer-side.

#### Pump Panels

The pump house driver-side & officer-side pump panels shall be 14 guage brushed stainless steel. Rubber sealing washers are positioned over the intake and discharges to retain heat. Stainless steel flanges are placed over top of the sealing washers and fastened in place. The upper portion of both pump panels shall be hinged and latched with 1/4 turn stainless steel latches.

#### **Heat Pan**

An aluminum heat pan shall be installed below the pumphouse to close-off for winter heat retention. All four (4) sides of the heat-pan are precision fit to the best of ability as heat retention is of utmost importance. Two (2) removable heat pans shall be installed. One pan shall insert into the heat pan enclosure from each side. Spring pins are used to retain the pans.

## **Roll-Up Doors, PumpHouse**

Roll-Up doors shall be installed to enclose the driver-side and officer-side pump panels.

# **Heaters Pumphouse**

There shall be one (1) Red Dot 35'000btu heater installed in the pumphouse on the left-side, at frame level. Coolant shall be routed through 5/8" thermal hose from the engine for the source of heat. Quarter-turn brass ball valves shall be installed at the engine. This allows the user to close the circuits if required. The activation switch shall be at the cab dash within convenient reach of the operator.

#### **Heat Exchanger Engine**

There shall be a stainless steel stacked plate heat exchanger installed in the pumphouse compartment to assist in cooling the engine in hot climates. This heat exchanger shall be spliced into the pumphouse heater coolant supply/return lines. A 3-way valve shall be installed at the heat exchanger.

With the 3-way valve in the summer position, the hot coolant shall bypass the pumphouse heaters and flow through the heat exchanger and back to engine. Placing the 3-way valve in the winter position, bypasses the heat exchanger and allows hot coolant to flow through the pumphouse heaters and back to engine.

A quarter-turn brass valve shall be installed at the pump operators panel. Water from the fire pump discharge manifold shall be piped to this valve and on to the heat exchanger. A water strainer shall be installed to strain the cooling water before it enters the heat exchanger. A flush line shall be piped from the dirty side of the strainer to the pumphouse side panel with a 3/4" lift handle style brass ball valve. The pump operator can periodoically open this valve to flush the strainer.

The cooling water valve shall be labeled Engine Cooler, and the flush valve Cooling Water Flush.

#### **Engine Cooler**

There shall be an engine cooler water supply circuit installed. A 1/4-turn valve shall be installed at the pump operators panel. Water supply shall be taken from the pump discharge manifold, plumbed through this valve and routed to the inlet of the engine heat exchanger. An inlet strainer shall strain the water before it enters the heat exchanger. This cooling water shall then be routed back to the booster tank.

## **Pump Cooler**

There shall be a pump cooler circuit installed. A 1/4-turn valve shall be installed at the pump operators panel. Opening this valve allows water to flow from the discharge side of the pump manifold to the booster tank.

# **Waterous Fire Pump**

There shall be a Waterous Model CSPA (1250 US GPM) Single Stage PTO Fire Pump installed.

#### **PUMP**

The pump shall be of single stage construction and shall comply with all applicable requirements of the latest standards for automotive fire apparatus of the National Fire Protection Association, NFPA 1901-2016, and shall have a rated capacity of 1250 US-GPM (1050 Imp Gal). The Pump shall be free from objectionable pulsation and vibration under all normal operating conditions.

## **PUMP BODY**

The pump body shall be close-grained, gray iron and must be horizontally split in two sections for easy removal of the entire impeller shaft assembly, and designed for complete servicing from the bottom of the truck without disturbing setting of the pump in the chassis or apparatus piping which is connected to the pump. Pump body halves shall be bolted together on a single horizontal face to minimize leakage and facilitate reassembly.

#### DISCHARGE MANIFOLD

The discharge manifold shall be cast as an integral part of the pump body assembly and shall provide at least three full 3-1/2 inch openings for ultimate flexibility in providing various discharge outlets for maximum efficiency, and shall be located as follows:

- One outlet on the right side of the pump body
- One outlet on the left side of the pump body
- One outlet directly on top of the pump discharge manifold

#### **IMPELLAR**

The impeller shall be bronze with double suction inlets, accurately balanced (mechanically and hydraulically), labyrinth type, wear rings that resist water bypass and loss of efficiency due to wear.

## **WEAR RINGS**

The wear rings shall be bronze, and shall be easily replaceable to restore original pump efficiency and eliminate the need for replacing the entire pump casing due to wear.

#### **IMPELLER SHAFT**

The impeller shaft shall be stainless steel, accurately ground to size. The impeller shaft shall be of two-piece construction separable between the pump and pump transmission to allow true separation of the transmission

from the pump without disassembly of either component.

#### ANTI-FRICTION BEARINGS

The impeller shaft shall be supported at each end by oil or grease lubricated anti-friction ball bearings for rigid and precise support. Bearings shall be protected from water and sediment by suitable seal housings, flinger rings, and oil seals. No sleeve type bearings shall be used.

#### PUMP TRANSMISSION

The pump transmission shall be rigidly attached to the pump body assembly and be of latest design incorporating a high strength, involute tooth form Morse™ HV chain drive capable of operating at high speeds to provide smooth, quiet transfer of power.

#### **Chelsae PTO**

There shall be a Chelsae "Hot-Shift" Power-Take-Off installed on the left-side of the chassis transmission. This PTO shall power the fire pump and can be used for both stationary and pump-and-roll applications. The PTO shall be pressure lubricated with synthetic oil from the chassis allison automatic transmission.

## Slip Shaft

There shall be a 1410 Series Drive-Shaft Slip-Shaft installed. One end shall be connected to the PTO. The other end shall include a slip-yoke and attach to a support shaft passing through the 4x4 transfer-case frame assembly. The drive-shaft assembly shall be machine balanced prior to installation.

#### **Support Shaft**

There shall be a support shaft with two (2) pillow block bearings installed at the 4x4 transfer case. This support shaft allows power to be transferred from the drive-shaft at the PTO to the drive-shaft at the fire pump. This support shaft is necessary as there is not sufficient space for a 1410 series drive-shaft to clear the transfer-case frame assembly.

## Slip Shaft

There shall be a 1410 Series Drive-Shaft Slip-Shaft installed. One end shall be connected to the support shaft. The other end shall include a slip-yoke, attached to the fire pump. The drive-shaft assembly shall be machine balanced prior to installation.

#### **Fire Pump Frame**

The fire pump frame shall be manufactured from 3/8" mild steel plate. Angles shall be bolted to both chassis frame rails with grade 8 bolts. These angles shall have flanges formed for the pump frame channels to bolt onto. Four (4) Rubber Vibration Isolation Mounts shall be installed between the pump frame and chassis frames to assist in reducing drivline & pump vibration. All frame components shall be painted with a rust prevention coating.

#### **Pump Seal**

There shall be a mechanical spring-loaded pump seal installed on the fire pump.

#### **Pump Overheat Protection**

There shall be a pump overheat protection system installed. The system shall include a thermal valve at the pump discharge manifold that opens automatically when the water temperature reaches 140 degrees F and dumps to atmosphere. An LED lamp shall be installed at the pump operators panel that flashes once the water temperature reaches 180 degrees F. A push-button switch shall be included to test the lamp function.

## Fire Pump Engage Switch (Cab)

There shall be a pump-engage switch installed at the chassis dash to engage the Fire Pump Power-Take-Off.

# **Fire Pump Engage Switch (Pump-House)**

There shall be an additional fire pump engage switch installed at the pump operators control panel. This allows the pump operator to open the tank-to-pump valve to flood the fire pump prior to engaging the fire pump. It also allows for shutting-down the fire pump without having to climb into the chassis cab.

<sup>\*</sup> shall require the engine to be at idle to function \*

\* shall require the engine to be at idle, the transmission to be in neutral and the park brake to be engaged to function \*

#### **Primer AirPrime**

A Trident AirPrime pump primer shall be installed. The system shall utilize chassis air pressure to prime the fire pump through a ventura. An Auto-Prime feature is included that will sense pump discharge pressure and automatically re-prime fire pump as pressure drops.

#### **Remote Prime**

A remote prime option shall be included to allow the operator to prime to the following locations:

- \* Main Pump Body
- \* Driver-Side Intake
- \* Officer-Side Intake
- \* Rear Intake

Each remote prime option shall include an individual primer control.

#### **6" Intake Bleeders**

There shall be Intake Bleeder valves installed for the following intakes, to bleed air from the intakes when receiving water supply from a positive pressure supply source, when the valve are closed.

- \* the Driver-Side 6" intake
- \* the Officer-Side 6" intake
- \* the Rear Intake

## **Foam Proportioner**

There shall be a Waterous Aguis 3.0 Electronic Foam Proportioner installed, with the following features:

## **Control Box:**

Microprocessor Controller:

A 16-bit mixed signal microcontroller with a 60 kB flash memory, 2kB RAM and 12-bit analog to digital convertor. Receives flowmeter flow rate and operator specifications through the OIT and provides the necessary voltage to the pump motor driver.

Pump Motor Driver:

Receives signals from the microprocessor controller and powers the electric motor in a variable speed duty cycle to ensure the correct amount of foam concentrate set by the operator is injected into the water stream.

#### Operator Interface Terminal

The Operator Interface Terminal (OIT), mounted on the pump operator's panel allows the operator to perform the following functions:

- \* Push button control of foam proportioning rates:
- \* Class A concentrate: .1% to 1% in increments of .1%
- \* Class B concentrate: 1%, 3% or 6% Calibration of water flow rate.
- \* Adjustable units of measurement.
- \* Simulated water flow.
- \* Optional lockout.
- \* Warning of low foam concentrate supply:
- \* Flashes and the displays a steady "low concentrate" warning when the concentrate tank runs low. Note that system will shut down after two minutes.
- \* Flashes a "no concentrate" warning when the concentrate tank is empty. Warning of an electronic malfunction: Flashes and "error" warning when the concentrate tank is empty. If apparatus has dual foam concentrate tanks, allows selection of tank A or B and displays which tank is in use. Operation in manual mode as a backup. A separate panel plate with operation instructions is furnished.

#### Flowmeter

A paddlewheel-type flowmeter, installed in the process manifold upstream of the foam injection point, connects to the microcontroller. A flowmeter tee, constructed of brass with Victaulic groove outer connections and

threaded NPT inner connections at each end of the tee, is provided for connection to the apparatus plumbing.

#### Foam Pump

Consists of an electric motor, positive displacement triplex plunger pump and control box mounted on a bracket. Electric Motor: 1/2 HP (.4 kW) 12 or 24 volt. Protected with an electrical load circuit breaker of 80 amps for 12 VDC and 50 amps for 24 VDC.

Pump Rating: 3.0 GPM @ 150 psi (11.5 L/min @ 10 bar) with intermittent operating pressures up to 450 psi (31 bar).

Pump Construction: Equipped with an anodized aluminum crankcase, oversized ball bearings, forged brass pump body and manifold, solid ceramic plungers, stainless steel inlet and delivery valves and piston guides. Buna packing and preset pressure regulating valve.

#### **Control Cables and Connectors**

Separate industry standard M12 connectors for connection of OIT and flowmeter to foam pump control box. Consists of shielded cables to prevent radio frequency or electro-mechanical interference. Furnished as follows: OIT connection to control box: 6 meters long Flowmeter connection to control box: 3 meters long Foam concentrate tank level switch to foam pump control box: 4 meters long

#### **Low Tank Level Switch**

A low tank level float switch, installed in the foam concentrate tank and connected to the control unit, alerts the operator to low foam supply conditions.

# Foam System Support

The AQUIS is equipped with a USB interface for PC-connectivity which allows a qualified technician to perform upgrades, diagnostics and monitor system functions in real time. The system can also be remotely monitored through the USB interface using any PC with internet access, allowing technicians to easily connect to the Waterous dedicated website to assure proper operation and to update the foam system hardware by uploading new features and functions as they become available.

# Intake 6" Driver-Side (Gated-Elec)

There shall be a 6" M NH intake installed on the left-side of the fire pump. The intake shall include an electric butterfly valve, installed inside the pumphouse. This keeps the valve in a warm winter-time environment and removes the traditional bulk of a piston-intake-valve from the out-side. The valve controller is installed at the pump operator control panel.

A waterous non-pilot type intake relief valve shall be installed.

A 3/4" lift-style drain valve shall be included.

The intake and drain valve shall be labelled to indicate their function. The label shall be color-coded burgundy.

## Intake 6" Officer-Side (Gated-Elec) w Rr Int Opt

There shall be a 6" M NH intake installed on the right-side of the fire pump. The intake shall include an electric butterfly valve, installed inside the pumphouse. This keeps the valve in a warm winter-time environment and removes the traditional bulk of a piston-intake-valve from the out-side. The valve controller is installed at the pump operator control panel. The intake shall include an option for installation of a rear of apparatus pump intake.

A waterous non-pilot type intake relief valve shall be installed.

A 3/4" lift-style drain valve shall be included.

The intake and drain valve shall be labelled to indicate their function. The label shall be color-coded burgundy.

#### Intake 5" Rear-Body-Right (Gated)

There shall be a 5.0" Aux Pump Intake installed, plumbed with 6.0" stainless pipe through the poly tank to the back of the body right-side. All plumbing shall be stainless steel. A Waterous Jamesbury Electric Butterfly Valve is included, installed inside the pumphouse. The valve controller shall be installed at the pump operator control

panel.

A waterous non-pilot type intake relief valve shall be installed.

A 3/4" lift-type bleeder/drain valve shall be installed at the pump operators panel. Installed on the inlet at the back of the body is a 5.0" NH adapter w/ strainer and chromed cap. Color coded labels shall be included.

#### **Intake 2.5" #1 Aux Left-Front**

There shall be a 2.5" Auxiliary Intake installed at the left-side pump panel ahead of the Main Intake. An Akron Brass ball valve with composite ball and remote valve actuator shall be included. The valve actuator shall be a direct mount lever located beside the valve. The intake shall include a 2.5" female swivel adapter and chromed plug, chained to the pump panel. A strainer shall be included. The threads shall be CSA.

A 3/4" lift-style bleeder/drain valve shall be installed on the intake. The intake and drain valve shall be labeled with a color-coded label.

## Intake 2.5" #2 Aux Right-Front

There shall be a 2.5" Auxiliary Intake installed at the right-side pump panel ahead of the Main Intake. An Akron Brass ball valve with composite ball and remote valve actuator shall be included. The valve actuator shall be a direct mount lever located beside the valve. The intake shall include a 2.5" female swivel adapter and chromed plug, chained to the pump panel. A strainer shall be included. The threads shall be CSA.

A 3/4" lift-style bleeder/drain valve shall be installed on the intake. The intake and drain valve shall be labeled with a color-coded label.

#### **Intake - Tank to Pump (Dual Elec Ctrls)**

There shall be a 3.5" stainless steel tank-to-pump supply line installed. An Akron Brass 3.0" Ball Valve with composite ball and KZCO Electric Valve Actuator shall be included.

Two (2) Electric Valve Switches shall be installed at the following locations:

- \* one (1) at the pump operator panel
- \* one (1) at the cab console next to the driver

Color-coded labels shall be provided.

#### **Tank Fill Line**

There shall be a 2.0" tank fill line installed. An Akron Brass 2.0" Ball Valve with composite ball and remote valve actuator shall be included. The valve actuator shall be a positive locking t-handled lever at the pump operator panel. The lever shall be labeled with a color-coded label. High-Pressure flexible hose shall be use to route the line from valve to tank. Stainless steel fittings are crimped to the end of hose.

### **Discharge Manifold**

There shall be a Waterous Cast Iron Discharge Manifold assembly installed on the fire pump. The manifold shall feature numerous discharge port options to facilitate multiple discharge pluming/routing options.

## Discharge 2.5" #1 Left-Front

There shall be a 2.5" Discharge located on the left-side of the pump-house towards the front. An Akron Brass 2.5" ball valve with composite ball and remote valve actuator shall be included. The valve actuator shall be a positive locking t-handled lever at the pump operator panel. A push-pull cable shall be installed between the valve lever and the valve. The discharge shall include a 30 degree droop and chromed cap, chained to the pump panel. The threads shall be CSA.

There shall be a 2.5" stainless steel dual-scale Psi/Kpa discharge pressure gauge installed for this discharge.

A 3/4" - lift-style bleeder/drain valve shall be installed for the discharge at the base of the pump panel. The valve lever and drain valve shall be labeled with a color-coded label.

## Discharge 2.5" #2 Left-Rear

There shall be a 2.5" Discharge located on the left-side of the pump-house towards the rear. An Akron Brass 2.5" ball valve with composite ball and remote valve actuator shall be included. The valve actuator shall be a positive locking t-handled lever at the pump operator panel. The discharge shall include a 30 degree droop and chromed cap, chained to the pump panel. The threads shall be CSA.

There shall be a 2.5" stainless steel dual-scale Psi/Kpa discharge pressure gauge installed for this discharge.

A 3/4" - lift-style bleeder/drain valve shall be installed for the discharge at the base of the pump panel. The valve lever and drain valve shall be labeled with a color-coded label.

# Discharge 2.5" #3 Right-Front

There shall be a 2.5" Discharge located on the right-side of the pump-house towards the front. An Akron Brass 2.5" Ball Valve with composite ball and remote valve actuator shall be included. The valve actuator shall be a positive locking t-handled lever at the pump operator panel. The discharge shall include a 30 degree droop and chromed cap, chained to the pump panel. The threads shall be CSA.

There shall be a 2.5" stainless steel dual-scale Psi/Kpa discharge pressure gauge installed for this discharge.

A 3/4" - lift-style bleeder/drain valve shall be installed for the discharge at the base of the pump panel. The valve lever and drain valve shall be labeled with a color-coded label.

# Discharge 4.0" #4 Right-Rear

There shall be a 4.0" discharge located on the right-side of the pump-house towards the rear. An Akron Brass 3.0" 8900 series Ball Valve with composite ball and remote valve actuator shall be included. The valve actuator shall be a rotary hand-wheel style at the pump operator panel. The discharge shall include a 30 degree x 4.0" storz droop and storz cap, chained to the pump panel.

There shall be a 2.5" stainless steel dual-scale Psi/Kpa discharge pressure gauge installed for this discharge.

A 3/4" - lift style bleeder/drain valve shall be installed for the discharge at the base of the pump panel. The valve lever and drain valve shall be labeled with a color-coded label.

## Discharge 2.5" #5 Hose-Bed Pre-Con

There shall be a 2.5" pre-connect discharge located at the right-front of the hose-bed. An Akron Brass 8900 series 2.5" ball valve with composite ball and remote valve actuator shall be included. The valve actuator shall be a positive locking t-handled lever at the pump operator panel. A push-pull cable shall be installed between the valve lever and the valve.

There shall be a 2.5" stainless steel dual-scale Psi/Kpa discharge pressure gauge installed for this discharge.

A 3/4" - lift style bleeder/drain valve shall be installed for the discharge at the base of the pump panel. The discharge and drain valve shall be labeled with a Green color-coded label. The threads shall be CSA.

## Foam Manifold (A)

There shall be a 2.5" stainless steel foam manifold (A) installed. An Elkhart Brass check valve shall be included to prevent foam solution to back flow to the clean water manifold. A 3/8" brass drain valve shall be installed at the lower pump panel to drain the foam manifold. The drain valve shall be labeled Foam Manifold Drain.

## Foam Manifold (B)

The foam distribution manifold shall include the following discharges:

- \* four (4) 2.0" discharges
- \* one (1) 2.5" discharge

#### **Speedlay #1 Foam, Front Bumper**

There shall be a 1.5" F NPSH speedlay hose-bed installed transvers at the front extended bumper as speed-lay #1. An Akron Brass 2.0" ball valve with composite ball and remote valve actuator shall be included. The valve actuator shall be a positive locking t-handled lever at the pump operator panel, with push-pull cable. High-Pressure flexible 2.0" hose with stainless steel crimped end fittings shall be used to route the discharge

from valve to hose-bed.

There shall be a 2.5" stainless steel dual-scale Psi/Kpa discharge pressure gauge installed for this discharge.

A 3/4" - lift style bleeder/drain valve shall be installed for the discharge at the base of the pump panel. The intake and drain valve shall be labeled with an Orange color-coded label. **This discharge shall be foam capable.** 

## **Speedlay #2 Foam, Front Bumper**

There shall be a 1.5" F NPSH speedlay hose-bed installed transvers at the front extended bumper as speed-lay #2. An Akron Brass 2.0" ball valve with composite ball and remote valve actuator shall be included. The valve actuator shall be a positive locking t-handled lever at the pump operator panel, with push-pull cable. High-Pressure flexible 2.0" hose with stainless steel crimped end fittings shall be used to route the discharge from valve to hose-bed.

There shall be a 2.5" stainless steel dual-scale Psi/Kpa discharge pressure gauge installed for this discharge.

A 3/4" - lift style bleeder/drain valve shall be installed for the discharge at the base of the pump panel. The intake and drain valve shall be labeled with an Orange color-coded label. **This discharge shall be foam capable.** 

# **Plumbing Front Bumper Monitor**

There shall be plumbing installed and routed to the front bumper for installation of a remote controlled monitor. The plumbing shall be a combination of 2.0" stainless piping and high-pressure flexible hose with crimped stainless steel end fittings. The hose shall be secured along the under-side of the chassis next to the chassis frame rails.

An auto-drain valve shall be installed at the lowest point to automatically open and drain the piping when pressure drops below 8psi. *This discharge shall be Foam Capable.* 

#### **Monitor TFT Front Bumper**

A Task Force Tips Tornado model # Y2-E88A electric remote controlled monitor shall be installed. The monitor shall be controlled by a monitor mounted membrane switch panel with functions that control rotation, elevation and nozzle patterns, oscillate, park, auxiliary 1 and auxiliary 2.

The monitor shall have the following travel capabilities: full horizontal rotation with travel 185 degrees left and right of center, full 135 degrees of vertical travel with field changeable vertical stops at 45 degrees above and 20 degrees below horizontal, field changeable rotation stops shall be provided 90 degrees left and right of center, flow capability of 500 GPM with no more than 25 PSI loss, maximum operating pressure of 200 PSI.

The electrical components for the monitor shall be waterproof and utilize current limiting and position encoders to protect the drive train at the ends of travel. Monitor shall have waterproof plug for power and control cable connection for easy removal. An electrical connection for a TFT remote control nozzle shall be provided. The monitor shall be equipped with manual override knobs for use in the event of power failure.

For resistance to corrosion the monitor shall be constructed from hardcoat anodized aluminum with a silver powder coat interior and exterior finish.

The monitor shall be configured with a 2" female NPT inlet with quick disconnect with locking pin and 1-1/2" male NH outlet. The unit shall be covered by a five-year warranty.

## **Monitor Joystick**

A Task Force Tips model # Y4E-JS-GT joystick style control station for Task Force Tips Tornado series remote control monitor shall be installed. The joystick shall be mounted in an enclosure and control horizontal rotation, vertical elevation and nozzle stream pattern and have a momentary trigger button that can control an optional Task Force Tips valve with interface box by squeezing if desired. The monitor speed is proportional to the joystick movement. A sliding switch shall allow for flow control by adjusting the Task Force Tips gateable valve operation. The control requires 12 or 24 volt DC power.

The enclosure shall include membrane switches and LED lights to program and control programmable park and oscillate functions, and a toggle switch to control an optional Task Force Tips valve with interface box. Two additional membrane switches are included to control optional, auxiliary equipment such as a light. LED lights show gateable valve status and operation. A ten foot long, four-conductor cable with four-pin plug to connect to the optional valve interface box shall exit the enclosure.

The joystick enclosure box shall include a circuit board to communicate with the Task Force Tips remote control monitor and optional valve interface. Internally mounted switches shall be included for the ability to choose which control station shall be dominant where additional controls are used, and to retain oscillate programming if desired. All joystick components and circuitry are mounted to the top portion of the enclosure and can be removed for console mounting. A storage bracket for the handheld control shall be included and shall comply with NFPA 1901 Section14.1.11. The unit shall be covered by a five-year warranty.

#### Monitor Nozzle

A Task Force Tips Ultimatic 125, model # B-TO-ERP-120 automatic nozzle with electrically operated pattern control shall be provided. The nozzle design shall allow for straight stream through dense wide fog patterns and be able to be flushed without shutting down.

The electric drive unit shall develop over 400 pounds of torque, be enclosed in a waterproof cast aluminum housing and include a manual override device in the event the power source fails. The unit shall be compatible with 12 or 24 volt power systems and require no more than a 3 amp power draw and include a 6" connection cable with plug.

Nozzle stream shaper actuator shall have position encoder for smooth transition between straight stream and fog pattern with fine stream adjustment. Nozzle stream shaper shall stop and pause at full fog position. A second electrical actuation of the stream shaper shall move the shaper to the flush position for removing debris from the nozzle.

For corrosion resistance and durability the nozzle shall be constructed from hardcoat anodized aluminum alloy, a protective rubber bumper with fog teeth, laser engraved serial number, reflective labeling and five year warranty.

The nozzle shall have a 1-1/2" female NH swivel rocker lug coupling and a flow range of 10-125 GPM at 120 PSI. A waterproof six-pin electrical connection for use with TFT remote control monitors shall be included. The nozzle shall be designed to accept the TFT FJ-U or FJ-UMX FoamJet low expansion air aspirating attachments.

# Monitor Electric Valve

A Task Force Tips electric gateable valve kit for Tornado series remote control monitors shall be installed. The valve package shall include an akron valve with controller mounted on valve, and an interface box for connection of joystick control, monitor and power. The valve kit electrical components shall be compatible with 12 or 24 volt direct current.

The enclosure shall be weatherproof and utilize weatherproof components such as a silicone seal, hardware with o-rings and liquid tight electrical connections with strain relief fittings.

The enclosure shall include the following: A preconnected 20 foot, four-conductor cable with waterproof, four-pin connection plug for power and communications connection to the monitor; A preconnected 20 foot, six-conductor cable with waterproof, six-pin connection plug for connection to valve controller; A preconnected 15 foot, two conductor cable with stripped ends for connection to vehicle power; A four-pin receptacle with cap for connection to joystick control; An unused strain relief fitting for an additional operator station cable.

The valve shall have 2" NPT female inlet and outlet, stainless steel ball and housing, valve position indicator, and six-conductor cable with waterproof plug for connection to enclosure valve control cable. The valve kit shall be covered by a written five-year warranty.

\*\* The Monitor shall be installed on the front center of the bumper \*\*

#### **Plumbing, Hose Reel**

There shall be a discharge installed for one (1) hose reel supply at the officer-side running boards. A KZCO 1.5" stainless steel valve with electric actuator shall be included. The valve switch shall be located at the pump operators panel.

A 3/4" - lift style bleeder/drain valve shall be installed at the base of the pump panel. The discharge and drain valve shall be labeled with a color-coded label. **This discharge shall be foam capable.** 

## **Hose Reel (Officer-Side)**

There shall be one (1) 1.0" Hannay Hose Reel supplied and installed beneath the cab on the officer-side rear of the crew-cab chassis, behind the running boards. The reel shall be equipped with 12v electric rewind. A hose roller guide shall be installed. The reel shall be powder coated Red.

#### **Hose for Hose Reel**

There shall be 100' of 1.0" rubber discharge hose installed on the hose reel. The hose shall be yellow in colour and rated at 300psi.

#### **Nozzle Wildlands**

One (1) Akron Brass model #1602 1.0" ProVenger Nozzle shall be provided. The 1" ProVenger SG fire hose nozzle is the selectable gallonage style for the ProVenger Series Nozzles. ProVenger SG is a constant gallonage (flow remains the same in all patterns) with various flow setting for frontline flow control. ProVenger SG is an unbeatable value with the performance that you demand.

Low flow options, starting at 5 gpm (19 lpm), are available within the 1" (25 mm) ProVenger line. The new, lower flows aid firefighters in regulating the amount of water needed to extinguish various fires. The 1" nozzles are perfect for wildland and gas cooling applications. Find an Akron Brass distributor near you to learn more about this fire hose nozzle.

#### **Hose Line Blow-Outs**

There shall be an air blown-out line plumbed to the foam manifold to remove standing water from all foam capable hose lines. Injecting compressed air to the manifold will evacuate the water from hose lines to prevent freezing.

A quarter-turn valve shall be installed at the face of the pumphouse. The air source shall be plumbed from the chassis air tanks, though a pressure protection valve that closes the supply line when air drops below 70 psi.

# **Electrical System**

An electrical power distribution system shall be installed installed. The switch panel shall be located in the cab convenient to the operator. Remote power modules are installed in stretegic locations on the apparatus to reduce wiring harness requirements.

## Power Distribution Panel

All body electrical equipment installed by the apparatus manufacturer shall conform to current automotive electrical system standard, the latest Federal DOT standards, and the requirements of the applicable NFPA Apparatus Standard. Twisted pair shielded wire shall be provided within the electrical system for noise reduction.

The wiring harness shall conform to SAE J-1128 with SXL temperature properties. All exposed wiring shall be run in loom with a minimum 200 degree Fahrenheit rating. All wiring looms shall be properly supported and attached to body members along the entire run. All wiring shall be mounted so as to provide protection from water and heat. All connections shall be crimp type with heat shrink tubing with insulated shanks to resist moisture and foreign debris such as grease and road grime. Weather-resistant connectors shall be provided throughout to ensure the integrity of the electrical system. All wiring looms shall be properly supported and attached along the entire run. At any point where wire or looms must pass through metal, rubber grommets shall be installed to protect the wire from abrasion.

All wiring shall be individually coded every 2" on the insulation to allow for easy identification. The numbering shall be continuous, along the entire length of the harness.

The main low voltage chassis to body interface point and distribution panel shall be provided at the rear of the

body in a location providing easy service access. The distribution panel shall be labeled and shall contain the body electrical power distribution equipment. The distribution panel shall be located so as not to reduce useable compartment space. An electrical harness quick-disconnect shall be provided to facilitate easy removal of the body, should such a procedure become necessary.

## **Pressure Governor and Engine Monitoring Display**

A Fire Research PumpBoss series PBA401-A00 pressure governor and monitoring display kit shall be installed. The kit shall include a control module, intake pressure sensor, discharge pressure sensor, and cables. The control module case shall be waterproof and have dimensions not to exceed 6 3/4" high by 4 5/8". The control knob shall be 2" in diameter with no mechanical stops, have a serrated grip, and a red idle push button in the center. It shall not extend more than 1 3/4" from the front of the control module. Inputs for monitored engine information shall be from a J1939 databus or independent sensors. Outputs for engine control shall be on the J1939 databus or engine specific wiring. Inputs from the pump discharge and intake pressure sensors shall be electrical.

The following continuous displays shall be provided:

Engine RPM; shown with four daylight bright LED digits more than 1/2" high

Check engine and stop engine warning LEDs

Engine oil pressure; shown on a dual color (green/red) LED bar graph display

Engine coolant temperature; shown on a dual color (green/red) LED bar graph display

Transmission Temperature: shown on a dual color (green/red) LED bar graph display

Battery voltage; shown on a dual color (green/red) LED bar graph display

Pressure and RPM operating mode LEDs

Pressure / RPM setting; shown on a dot matrix message display

Throttle ready LED.

A dot-matrix message display shall show diagnostic and warning messages as they occur. It shall show monitored apparatus information, stored data, and program options when selected by the operator. All LED intensity shall be automatically adjusted for day and night time operation.

The program shall store the accumulated operating hours for the pump and engine to be displayed with the push of a button. It shall monitor inputs and support audible and visual warning alarms for the following conditions:

High Battery Voltage

Low Battery Voltage (Engine Off)

Low Battery Voltage (Engine Running)

High Transmission Temperature

Low Engine Oil Pressure

High Engine Coolant Temperature

Out of Water (visual alarm only)

No Engine Response (visual alarm only).

The program features shall be accessed via push buttons located on the front of the control module. There shall be a USB port located at the rear of the control module to upload future firmware enhancements.

The governor shall operate in two control modes, pressure and RPM. No discharge pressure or engine RPM variation shall occur when switching between modes. A throttle ready LED shall light when the interlock signal is recognized. The governor shall start in pressure mode and set the engine RPM to idle. In pressure mode the governor shall automatically regulate the discharge pressure at the level set by the operator. In RPM mode the governor shall maintain the engine RPM at the level set by the operator except in the event of a discharge pressure increase. The governor shall limit a discharge pressure increase in RPM mode to a maximum of 30 psi. Other safety features shall include recognition of no water conditions with an automatic programmed response and a push button to return the engine to idle.

The pressure governor and monitoring pressure display shall be programmed at installation for a Cummins Engine.

#### **Water Tank Level**

An Innovative Controls Soft-Glo Series Water Tank Level Monitor System shall be installed.

The display modules shall each receive an input signal from a dedicated pressure transducer. These stainless steel sender units shall be installed on the outside of the water tank near the bottom. All wiring, cables and connectors shall be waterproof without the need for sealing grease.

## **Water Tank Level Lights (Remote)**

There shall be two (2) LED Remote Water Tank Level Lights installed. The lights shall be driven by the master water tank level display located at the pump operators panel.

The lights shall be installed in the following locations:

- \* one (1) at the left-side of the apparatus body at the front-upper
- \* one (1) at the right-side of the apparatus body at the front-upper

#### **Foam Tank Level**

An Innovative Controls Soft-Glo Series Foam Tank Level Monitor System shall be installed.

The display modules shall each receive an input signal from a dedicated pressure transducer. These stainless steel sender units shall be installed on the outside of the water tank near the bottom. All wiring, cables and connectors shall be waterproof without the need for sealing grease.

#### **Master Gauges & Test Ports**

There shall be one (1) Master Vacuum and one (1) Master Pressure gauge assembly installed at the pump operators panel. The gauges shall be stainless steel, 4" diameter. The vacuum gauge shall have a scale of -30 to 400 psi (0-2750 kpa). The pressure gauge shall have a scale of 0-400 psi (0-2750 kpa). Two (2) pump test ports shall be included. The gauges and the test ports shall be part of a chromed bezel for a pleasing appearance.

#### **Master Drain Valve**

There shall be a Master Pump Drain Valve installed at the base of the driver-side pump panel. The valve shall be Trident Brand, 10-port rotary type with a single-point drain.

#### **Water/Foam Tank Poly**

An 800 Imp-Gal poly water tank shall be installed. The tank shall be NFPA compliant, manufactured by UPF (United Plastic Fabricating).

\* A 6-bolt flange shall be welded at the driver-side rear wall for a 2.5" firemans friend valve installation \*

#### Foam Tank, Poly

A 25 Imp-Gal poly foam tank shall be installed. The tank shall at the front-right corner, integral to the water tank.

#### Direct-Tank-Fill 2.5" (1)

There shall be one (1) 2.5" Stainless Steel Direct-Tank-Fill Valve installed at the back of the water tank. The valve shall include a spring-loaded plunger that opens automatically when pressure is applied, and closes automatically when pressure falls below 8psi. A 1/4-turn bleeder valve is included with a 30 degree x 2.5" droop adapter and cap. Threads shall be CSA.

\* The location shall be on the Rear, Officer-Side of the apparatus \*

## **Drain Valve Water Tank**

A 1.5" brass gate valve shall be installed at the base of the tank for the tank drain.

#### **Body c/w Integral PumpHouse**

The PumpHouse & Body shall be supplied as an Integral Single-Body Unit. The pump operators panel shall be inset into the front driver-side compartment. The officer-side panel shall be inset into the front officer-side compartment.

#### **Body Sub-Frame**

The subframe shall consist of aluminum structural square tubing and aluminum structural rectangular tubing.

Heavy Duty square tubing's shall extend outwards into the wheel well openings, in front of and behind the chassis rear wheels. These crossmembers shall then be connected to the floor braces of the wheel well compartment floors with vertical structural members. This design shall transfer body loads directly to chassis frame via the aluminum structure instead of welded joints resulting in exceptional strength. Heavy Duty ectangular tubing's shall extend full width from side to side at the front and the back of the body. The body compartments shall receive cut-outs, through which these structural tubing's shall insert, again resulting in body loads being transferred to the sub-frame via structure instead of welded joints.

All other crossmembers shall be rectangular tubing, welded rigidly to provide a high strength base for proper support of the poly water tank.

The alloy shall be 6061-T6 and shall be welded by CWB (Canadian Welding Bureau) certified welders using the semi-automatic mig welding process. The sub - structure shall be re-enforced with gussets in high stress areas. The sub-frame design shall include sufficient crossmembers to ensure adequate water tank support.

#### **Body Aluminum**

The aluminum body shall be an Extruded Aluminum Body, consisting of proprietary aluminum extruded profiles. These aluminum profiles shall be produced from 6061 series aluminum alloy and shall be of sufficient strength to carry the weight of the body & equipment. The extrusions shall transfer the body & equipment weights to the under-body sub-frame, which shall transfer directly to the chassis frame. This design eliminates any of the compartment walls from functioning as load-bearing members, which could result in body cracking.

All extrusion joints shall be properly prepared/beveled in advance of the welding process. All welding shall be performed by CWB certified welders.

The aluminum material shall be (3/16") 5052 (marine grade) providing enhanced resistance to corrosion and high weld joint efficiencies. The body shall be computer modeled before construction ensuring correct configuration and geometry. After modeling, the sheet-metal parts shall be flattened (electronically) and produced on CNC sheet metal cutting equipment. This will ensure extremely high part tolerances resulting in excellent fit/finishes. Compartment floors shall receive tabs which when assembled, will insert into grooves cut into the compartment side walls. Tab and groove construction removes a high portion of stress loads from welded joints.

Tab and Groove construction also eliminates double wall joints which can trap moisture and encourage corrosion. To prevent (oil canning) all compartment floors shall be re-enforced with a minimum of two (2) structural re-enforcements. All floors shall be of the sweep-out design allowing easy cleaning.

#### **Body to Chassis Frame Attachment**

The aluminum body shall be fastened to the chassis frame using custom bolted frame assemblies. This attachment design also allows for easy body removal should such a procedure become necessary.

## Rubber Isolator (Frame to Body)

A full length/width of 1/4" neoprene rubber shall be bonded to the chassis frame before the body is installed. This shall serve as an isolator for dissimilar metals.

#### **Body Compartments Driver-Side**

L1

There shall be one (1) compartment at the left side front of the body. This compartment shall house the pump operators panel and additional storage. Rough opening shall be 59.0" wide x 66.0" high.

L2

There shall be one (1) compartment on the left side over the rear wheels. Rough opening shall be 56.0" wide x 36.0" high.

١3

There shall be one (1) compartment on the left side behind the rear wheels. Rough opening shall be 51.0" wide  $\times 58.0$ " high.

#### **Body Compartments Officer-Side**

R1

There shall be one (1) compartment at the right side front of the body. This compartment shall house the officer pump panel and additional storage. Rough opening shall be 59.0" wide x 66.0" high.

R2

There shall be one (1) compartment on the right side over the rear wheels. Rough opening shall be 56.0" wide x 36.0" high.

R3

There shall be one (1) compartment on the right side behind the rear wheels. Rough opening shall be 51.0" wide x 58.0" high.

#### **Body Compartment Rear**

**B**1

There shall be one (1) compartment at the back of the body. Rough opening shall be 50.0" wide x 41.0" high.

Note: Please refer to dimensional drawing for compartment measurements.

Each compartment shall be sealed before an interior coating is applied using a high quality paintable caulking. This will ensure the compartments to be leak free at any of its seams. All compartments will feature vents to allow air re-circulation. The tops of each compartment shall have aluminum checkerplate attached. This will provide for a skid resistant walkway.

## **Bumper Body Rear w/TH**

There shall be a bumper installed at the back of the body. Heavy-duty steel plates shall be custom cut and formed to provide a rigid frame for the tailboard to attach to. The bumper support frame assembly shall be fully independant of the body frame, and shall be fastened to the chassis frame rails with grade 8 bolts. The tailboard shall be formed from embossed aluminum polished checkerplate to promote slip-resistance. A heavy aluminum channel shall be welded to the underside for additional support.

#### Tow Eyes

There shall be two (2) 1-1/4" chrome plated tow eyes installed at the back of the body. Independant brackets shall be used to attach the tow eyes to the frame rails. This is to prevent stresses from towing to transfer to the body & bumper mounting frames.

#### Trailer Hitch

A trailer hitch receiver tube shall be installed at the back bumper.

#### **Trailer Plug**

A 7-Way RV Style Trailer Plug shall be installed at the back trailer hitch.

## **Fenderetts**

There shall be stainless steel fenderetts installed on the body wheel well skirts, fastened to the skirts with stainless steel hardware.

#### **Liners Wheel Well**

There shall be wheel well liners installed in each body wheel well. The liners shall be 3/16" non-corrosive ABS material. The liners are fastened with stainless steel hardware, nylon shoulder washers and corrosion control paste on the bolt holes.

## **Mud Flaps**

There shall be heavy-duty mud flaps installed at the rear wheels, attached to the body with stainless steel hardware. The mud flaps shall be 14" high x 24" wide and have an ACRES logo molded onto one side.

# **Rub Rails Body**

There shall be anodized aluminum rub rails installed on the sides of the body, ahead of and behind the rear wheels. Plastic end caps shall be included on each end of the rub rails to provide a pleasing appearance. Stainless steel hardware shall be used to fasten the rub rails. Nylon shoulder washers are installed on each bolt, corrosion control paste is applied to each bolt hole prior to hardware insertion on the lower body.

#### **Stairway**

There shall be a collapsible stairway installed at the back driver-side of the body to access the upper-body. The assembly in its deployed state, shall extend past the back bumper to provide an ergonomic angled stairway. The bottom portion shall hinge-up and neatly fold above the brake/tail/turn lights, collapsing into a vertical compact unit. An over-center latch is used to captivate for storage.

The threads shall incorporate an agressive thread pattern to offer secure slip-free footing.

Handrails shall be attached to both upper stairway stringers for additional support. Additional Handrails are included at the top of hose bed.

#### Step Platform

An embossed aluminum threadplate step/walkway shall be attached to the back-top of the body to allow users to step off the stairway and access the hose bed.

## **Portable Step**

A portable step shall be supplied with the apparatus to access side compartments. The step shall have the ability to clip into place at side compartment floors and be stored with quick-removable fastener at body rear left-side panel.

#### **Shelving Comp (L2) Over Wheel**

There shall be one (1) aluminum shelve installed in compartment L2, left-over-body-wheels. The shelve shall be precision cut from 3/16" aluminum sheet, then polished and formed with a 2.5" vertical lip all around. All four corners of the shelve shall be left open for proper drainage.

The shelve shall be installed in the compartment on four (4) vertically adjustable aluminum rails. Rubber interlocking floor tile shall be placed on the shelve.

# **Shelving Comp (L3)**

There shall be two (2) aluminum shelves installed in compartment L3, on the left-side behind the body wheels. The shelves shall be precision cut from 3/16" aluminum sheet, then polished and formed with a 2.5" vertical lip all around. All four corners of the shelve shall be left open for proper drainage. The shelves shall be installed in the compartment on four (4) vertically adjustable aluminum rails. Rubber interlocking floor tile shall be placed on the shelve.

# **Shelving Comp (R3)**

There shall be two (2) aluminum shelves installed in compartment R3, Right-Back-Of-Wheels. The shelves shall be precision cut from 3/16" aluminum sheet, then polished and formed with a 2.5" vertical lip all around. All four corners of the shelve shall be left open for proper drainage. The shelves shall be installed in the compartment on four (4) vertically adjustable aluminum rails. Rubber interlocking floor tile shall be placed on the shelve.

## **Shelving Comp (B1)**

There shall be one (1) aluminum shelve installed in compartment B1, Back-of-Body. The shelve shall be precision cut from 3/16" aluminum sheet, then polished and formed with a 2.5" vertical lip all around. All four corners of the shelve shall be left open for proper drainage. The shelves shall be installed in the compartment on four (4) vertically adjustable aluminum rails. Rubber interlocking floor tile shall be placed on the shelve.

#### Roll-Out Tray (L3)

There shall be one (1) Slide-Master Roll-Out Tray installed, in body compartment L3, left-side behind body wheel. The slides shall be by SlideMaster with a 600lb capacity, 100% extension and include a lock-in and lock-out device. An aluminum tray with 2" up-turned flanges and rubber interlocking floor tile shall be included. The slide-out frame shall be powder-coated Black.

# Roll-Out Tray (R3)

There shall be one (1) Slide-Master Roll-Out Tray installed, in body compartment R3, Right-Back-Of-Wheel. The slides shall be by SlideMaster with a 600lb capacity, 100% extension and include a lock-in and lock-out device. An aluminum tray with 2" up-turned flanges and rubber interlocking floor tile shall be included. The slide-out frame shall be powder coated Black.

# **Roll-Out Tip-Down Trays (L3)**

The assy shall be installed in compartment **R1.** 

# **Tool Storage Drawer(s) (L1)**

There shall be a 4-Drawer Tool Storage assembly installed on the floor of a body compartment. The storage system shall be fabricated from aluminum sheet. Heavy-Duty ball-bearing slides shall be used for the drawers. Dividers are included to insert as desired for compartment sizing.

\*\* The drawer assembly shall be installed in compartment L1, Left-Front-Of-Wheel \*\*

# **Tool Storage Drawer(s) (R1)**

There shall be a 4-Drawer Tool Storage assembly installed on the floor of a body compartment. The storage system shall be fabricated from aluminum sheet. Heavy-Duty ball-bearing slides shall be used for the drawers. Dividers are included to insert as desired for compartment sizing.

# Medical Cabinet (L1)

A medical cabinet shall be installed in the upper section of compartment L1 rearward. The cabinet shall be full compartment width. A hinged door is installed with latch and door seal.

Two (2) adjustable shelves lined with floor tile are included.

# **Hose Bed Flooring**

The top of the poly tank shall be grooved to allow for drainage forward and backward.

# **Hose Bed Divider**

There shall be two (2) hose bed dividers installed in the upper hose bed. The dividers shall be produced from 3/16" aluminum sheet, and formed for rigidity. The top of the dividers shall have a flange, providing a flat surface for support for the hose bed tarp.
