Being a By-law to accept a quote for the purchase of a Spartan Custom Chassis FC-94 Q-Flo Model Pumper Truck for the Lucknow District Fire Department (Dependable Emergency Vehicles)

WHEREAS Section 8(1) and 9 of the Municipal Act, 2001, S.O. 2001, c. 25, as amended, provide that the powers of a municipality under this or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues and has the capacity, rights, powers and privileges of a natural person for the purposes of exercising its authority under this or any other Act;

AND WHEREAS it has been determined that there is a need for a Pumper Truck for the Lucknow District Fire Department as discussed in Report FIRE 2023-02-11, FIRE 2023-03-15, FIRE 2023-06-25 and FIRE 2023-06-28;

AND WHEREAS an application has been made for Near-Term Investments Funding in the amount of \$300,000 to purchase the Pumper Truck;

AND WHEREAS the Township of Ashfield-Colborne-Wawanosh passed a resolution on April 4, 2023 to support the Lucknow and District Fire Board's decision to purchase a new pumper truck for the Lucknow Fire Department in 2024;

AND WHEREAS the source of funding for the difference between the purchase price and the Near-Term Investments Funding, and the Ashfield-Colborne-Wawanosh contribution shall be the Fire Equipment Reserve as outlined in Report Fire 2023-06-25;

NOW THEREFORE the Council of The Corporation of the Township of Huron-Kinloss **ENACTS** as follows:

- 1. That the quote of Dependable Emergency Vehicles for the supply of a Spartan Custom Chassis, FC-94 Q-Flo Model Pumper for the Lucknow District Fire Department in the amount of \$657,598.00 (excluding the non-refundable portion of HST), be hereby accepted.
- 2. That the source of funding for this purchase be the Near-Term Investments Funding, with contributions from the Corporation of the Township of Ashfield-Colborne-Wawanosh and with the source of funding for the difference between the purchase price and the Near-Term Investments Funding and Township of Ashfield-Colborne-Wawanosh contributions being the Fire Equipment Reserve.
- That the Fire Chief and the Clerk be authorized and directed to execute on behalf of The Corporation of the Township of Huron-Kinloss any contracts and other documents required to authorize such work to commence.
- 4. That this by-law shall come into full force and effect upon its final passage.
- 5. That this by-law may be cited as the "Lucknow District Pumper Truck (Dependable Emergency Equipment) Quote Acceptance By-law".
