

# The Corporation of the Township of Huron-Kinloss



## BY-LAW No.

**2023 - 112**

---

Being a By-Law to appoint Jodi MacArthur as Chief Administrative Officer  
of the Township of Huron-Kinloss

---

**WHEREAS** Section 8(1) and 9 of the Municipal Act, 2001, S.O. 2001, c. 25, as amended, provide that the powers of a municipality under this or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues and has the capacity, rights, powers and privileges of a natural person for the purposes of exercising its authority under this or any other Act;

**AND WHEREAS** the Municipal Act, 2001 S.O. 2001, c.25 section 229 permits a municipality to appoint a chief administrative officer who shall be responsible for:

- (a) exercising general control and management of the affairs of the municipality for the purpose of ensuring the efficient and effective operation of the municipality; and
- (b) performing such other duties as are assigned by the municipality. 2001, c. 25, s. 229.

**AND WHEREAS** the Municipal Act S.O. 2001, c 25, Section 286(2), provides that a municipality may appoint a Deputy Treasurer who shall have all the powers and duties of the Treasurer under the Municipal Act and any other Act;

**AND WHEREAS** the Municipal Act S.O. 2001, c 25, Section 228(2), provides that a municipality may appoint a Deputy Clerk who shall have all the powers and duties of the Clerk under the Municipal Act and any other Act;

**AND WHEREAS** the Council of The Corporation of the Township of Huron-Kinloss deems it expedient to appoint Jodi MacArthur a Chief Administrative Officer for the Township of Huron-Kinloss, to fill a vacancy in the position which will occur due to a planned retirement on March 31, 2023;

**NOW THEREFORE** the Council of The Corporation of the Township of Huron-Kinloss **ENACTS** as follows;

1. That Jodi MacArthur be appointed Chief Administrative Officer for The Corporation of the Township of Huron-Kinloss effective as of April 1, 2024; and shall exercise all the authority, powers and rights which by statute or by-law are or may be conferred or imposed; and shall perform all duties and obligations assigned, legislated and required of a Chief Administrative Officer.
2. That Jodi MacArthur be appointed as Deputy Clerk, and Deputy Treasurer for the Township of Huron-Kinloss.
3. That By-law No. 1999-1 and 2018-110 be repealed, effective as of April 1, 2024.
4. That this by-law shall come into full force and effect on April 1, 2024.
5. That this by-law may be cited as the "Appointment of Chief Administrative Officer (Jodi MacArthur) By-law".

**READ a THIRD TIME and FINALLY PASSED** this 6<sup>th</sup> day of November, 2023.
