THAT the Township of Huron-Kinloss Committee of the Whole hereby receives for information Report CLK-2024-03-10 prepared by Kelly Lush, Deputy Clerk;

AND grants an exemption to Noise By-Law No. 2005-101 to permit music at a wedding reception on June 15, 2024, until 1:00 a.m. on Sunday, June 16, 2024 at 684 Havelock Street in Lucknow;

AND FURTHER grants an exemption to Noise By-law No. 2005-101 for the Dungannon Tractor Pull and Demolition Derby on the evening of June 14th, 2024 until June 15th at 1:00 a.m. and the evening of June 15th until June 16th at 1:00 a.m providing a special event permit is approved for the event.

Background:

The Township of Huron-Kinloss By-Law No. 2005-101 being the By-Law to Control Noise outlines prohibitions of noise by time and place. The By-law prohibits;

3.5 The operation of any electronic device or group of connected electronic devices incorporating one or more loudspeakers or other electromechanical transducers, and intended for the production, reproduction or amplification of sound between the hours of 2300 one day to 07 00 next day (09 00 Sundays).

Council may by resolution grant an exemption to the Noise By-Law.

Discussion:

The Township received a noise exemption request from Chris Clark to have music played at a wedding reception on Saturday, June 15, 2024 from 9:00 p.m. until 1:00 a.m. on Sunday, June 16, 2024 located at 684 Havelock Street in Lucknow.

The Lucknow and District Kinsmen submitted a noise exemption request to host the Dungannon Super Pull and Demolition Derby on June 14th and 15th, 2024. The event will take place at Graceland at 577 Walter Street Lucknow. The noise will include gas and diesel engines until 10pm and lives bands will play until 1:00 a.m. both evenings.

Additional information on the Dungannon Super Pull and Demolition Derby event and a request for in-kind support from organizers will be included in forthcoming Staff report.

The requests were circulated to Township staff. No concerns were noted. Staff recommends approval of the exemption requests and will encourage the applicants to notify their neighbours. If approved, the Township By-Law Officer and South Bruce O.P.P. will be notified.
