#### BY-LAW No.

2024 - 19

Being a By-Law to Levy the Cost of Work Undertaken on the Wilken Municipal Drain in the Township of Huron-Kinloss

**WHEREAS** under Section 74 of the Drainage Act, R.S.O., 1990 and under By-Law No. 28-66, the Township of Huron-Kinloss is responsible for maintenance of the Wilken Municipal Drain at the expense of all upstream owners of lands and road assessed therein;

**WHEREAS** the work undertaken was to repair tree root obstructions on the west side of Pt. Lot 33, Con 3, Huron, repair tile from the east side of lane to the west property line and repair a hole in the agricultural lands portion of Pt. Lot 33, Con 3.

**WHEREAS** the sum of \$1460.26 shall be assessed against all upstream lands and roads in the watershed of the Wilken Municipal Drain, prorate with the last revised schedule of assessment for said drain;

**WHEREAS** the last revised schedule of assessment on the Wilken Municipal Drain is contained in a report by Skelton, Gibson & Associates and adopted as Township of Huron-Kinloss By-Law No.28-66.

**NOW THEREFORE** the Council of The Corporation of the Township of Huron-Kinloss enacts as follows:

- 1.0 The amount \$1460.26 shall be prorated as outlined in Schedule "A" attached to the By-law.
- 2.0 The amount assessed to lands used for agricultural purposes shall be reduced by the one third grant if available in accordance with Section 85 (a)(ii) and 87 (1)(a) of the Drainage Act, R.S.O. 1990.
- 3.0 All assessments in the Township of Huron-Kinloss, except for the assessment to roads and net assessments that are \$5.00 or less, shall be due 30 days after receipt after which time the amount due will be added to the 2024 collection roll together with interest at 1.25% per month.
- 4.0 The assessments against roads shall be due when billed.
- 5.0 Net assessments that are \$5.00 or less shall be paid from general funds of the Township of Huron-Kinloss.
- 6.0 This By-law shall come into full force and effect upon final passage.
- 7.0 This By-law may be cited as the "Wilken Municipal Drain Repair 2024 By-Law".

**READ a FIRST and SECOND TIME** this 18<sup>th</sup> day of March 2024.

**READ a THIRD TIME and FINALLY PASSED** this 18<sup>th</sup> day of March 2024.
