Being a By-Law to appoint Jeff Bradley as Fire Chief of the Township of Huron-Kinloss

WHEREAS Section 8(1) and 9 of the Municipal Act, 2001, S.O. 2001, c. 25, as amended, provide that the powers of a municipality under this or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues and has the capacity, rights, powers and privileges of a natural person for the purposes of exercising its authority under this or any other Act;

AND WHEREAS the Fire Prevention and Protection Act, 1997, R.S.O. c.4 as amended, permits a Council to enact a By-law to appoint a Fire Chief or Chiefs under Section 6;

AND WHEREAS Section 15 of the Police Services Act, R.S.O. 1990, c. P.15, as amended permits council's to appoint Municipal Law Enforcement Officers to enforce municipal by-laws;

AND WHEREAS the Township of Huron-Kinloss Council passed By-law No. 2022-189 which appointed a previous Fire Chief as alternate emergency management program coordinator for the Township of Huron-Kinloss;

AND WHEREAS the Township of Huron-Kinloss Fire and Emergency Services include the Ripley-Huron Fire Department and the Lucknow and District Fire Department;

AND WHEREAS the Council of The Corporation of the Township of Huron-Kinloss deems it advisable to appoint a Fire Chief and alternate emergency management program coordinator for the Township of Huron-Kinloss due to a vacancy in that position;

AND WHEREAS the Council of The Corporation of the Township of Huron-Kinloss deems it expedient to appoint Jeff Bradley as an alternate By-law Enforcement Officer for the Township of Huron-Kinloss, to assist in the enforcement of by-laws;

NOW THEREFORE the Council of The Corporation of the Township of Huron-Kinloss **ENACTS** as follows;

1. That Jeff Bradley be appointed Fire Chief and Chief Fire Official for The Corporation of the Township of Huron-Kinloss effective as of March 25, 2024; and shall exercise all the authority, powers and rights which by statute or by-law are or may be conferred or imposed; and shall perform all duties and obligations assigned, legislated and required of a Fire Chief and Chief Fire Official.
2. That Jeff Bradley be appointed as alternate Municipal Law Enforcement (By-law Enforcement Officer) for the Township of Huron-Kinloss.
3. That Jeff Bradley be appointed as Alternate Community Emergency Management Coordinator for the Township of Huron-Kinloss.

4. That By-law No. 2024-10 be repealed, effective as of March 25, 2024.
5. That this by-law shall come into full force and effect upon its final passage.
6. That this by-law may be cited as the “Appointment of Fire Chief Jeff Bradley By-law”.

READ a FIRST and SECOND TIME this 18th day of March, 2024.

READ a THIRD TIME and FINALLY PASSED this 18th day of March, 2024.
