6.2 Lucknow District Fire Department Budget Estimates 2024, LDFB-2023-12-11

The Fire Chief elaborated on the capital requests in the budget.

Self Contained Breathing Apparatus replacement schedule is estimated to be 5 cylinders per year, or whoever many may be purchased within the budget. This will mirror the equipment already available at the Ripley Station. Operating Costs include an increase in insurance to keep the secondary pumper covered. Uniform costs are additionally increased.

The Board inquired about the different uses proposed for the secondary pumper. Staff confirmed that the secondary pumper could be useful in a field fire, but does not have the remote head turret. A brush truck would be more suited but is not included in the current capital request.

The business plan includes demo packs for SCBA. At 5 per year, the estimated replacement time is 3 years. The compressor will also need to be upgraded.

The Board inquired about the process for long-term budget planning. The Fire Chief will provide an estimated replacement time and price for large purchases, and each Council will consider allocating reserve amounts in their respective budgets. The Board does not have reserves, each respective Council determines the amount saved.
