Introduction & Highlights

From managing housing and infrastructure challenges to embracing digital transformation and more, municipalities are at the forefront of key community issues and changes. It is clear there are increasing demands and responsibilities for municipalities, but these need to be met with the appropriate resources. This has been the central theme of our advocacy to the Province over the last few months.

Though summer break was called early for the Ontario legislature, it has not been without a flurry of business. Several proposed bills affecting the municipal sector advanced through the legislative process from being discussed and considered at Standing Committees to receiving Royal Assent. The following notable legislation passed: the *Get it Done Act, Building a Better Ontario Act* (Budget Measures) and *Cutting Red Tape to Build More Homes Act*. We saw decisions on several policies related to municipal planning and housing as well as infrastructure funding. More recently introduced was Bill 194, *Strengthening Cyber Security and Building Trust in the Public Sector Act,* 2024 (see Policy Spotlight below for more details).

In addition to monitoring these issues, this spring we initiated some early research and analysis for our second edition of the *Local Government Priorities for the Provincial Election* document as there have been rumours of an early provincial election.

In the meantime and where appropriate, we will continue monitoring and contributing to the development of legislation and changes related to digital transformation, protection of privacy, municipal codes of conduct, and municipal financial sustainability.

Support for Asylum Seekers and Refugees

We recently added our voice to the growing number of municipalities and associations calling on the federal and provincial governments to work with municipalities to better support asylum seekers and refugee claimants. This may be through provision of shelter, health and other social and settlement services.

While traditionally, AMCTO has not addressed issues related specifically to social services or immigration, the financial and operational impacts of managing an influx of claimants locally is adding more strain to an already overburdened municipal system from a financial and resource perspective. Consequently, the issue speaks to the financial planning and resilience and service and administration principles of our Issue Profile. It is also consistent with our support of the Association of Municipalities of Ontario's (AMO) call for a Social and Economic Prosperity Review. It is part of the bigger picture for municipalities and discussion with levels of government on 'who does what'.

As settlement and receiving municipalities are still being identified, it is important for the municipal sector to speak as a collective voice, to have the greatest impact. AMCTO supports municipalities in advocating for proper coordination and resourcing to accommodate asylum claimants arriving in Canada. Access and availability of supports ensures asylum claimants can settle successfully, bringing economic, social and cultural benefits to their communities.

REVIEW OUR LETTER OF SUPPORT

Red Tape Reduction

This spring, in response to Bill 185, *Cutting Red Tape to Build More Homes Act*, we made submissions to call on the Province for better government-wide approaches to modernizing newspaper notice provisions, the *Line Fences Act (LFA)* and other municipal services. Our submissions outline opportunities to reduce administrative burden while supporting enhanced local service delivery.

Reducing red tape and the administrative burden continues to be a top concern as the Ontario and federal governments impose costs on municipalities requiring significant administrative capacity. Notice requirements must offer flexibility balancing operational and administrative needs, capacity, resources and available technology with the importance of ensuring community members are kept up to date about various local matters and decisions. Similarly, municipalities working within the *LFA*, which tend to be small and rural communities, should be able to fulfill requirements in the way that best suits their individual, local needs.

We continue to understand where there is consensus from members on the most burdensome reports and thank those members who have shared their concerns and experiences. If you haven't done so already, we encourage you to share your feedback with us so we can bring clear examples of municipal reporting burden to the Province.

SHARE YOUR FEEDBACK

OMERS

OMERS Sponsors Corporation board is considering adjusting the way members make contributions to their pension plans at their June 2024 meeting. The potential adjustment follows an OMERS review of contribution rates, which they advised given its diverse membership, was meant to assess fairness of allocations of contributions. Among other things, the review found there were changing demographics of pension plan members prompting OMERS to consider changes. According to OMERS, if approved, 70% of members would contribute less, while 30% of members would contribute more, with changes effective January 1, 2027, to provide employers and members with enough time to prepare.

Policy Spotlight

Our recent review of the *Municipal Freedom of Information and Protection of Privacy Act* (*MFIPPA*) and *Municipal Elections Act* (*MEA*) highlighted that municipal administrators require the right legislative tools and guidance to manage risk, security, and other impacts of evolving technology on service delivery. Given the impacts and opportunities from online voting, digital permitting, artificial intelligence (AI) and virtual assistants on the municipal administration and operations, we are pleased to see the Province begin to address some of the needs of the sector through Bill 194 *Strengthening Cyber Security and Building Trust in the Public Sector Act, 2024*. From a municipal point of view, there needs to be a balance within the regulations, which are still to come, to minimize risks and protect privacy while at the same time avoiding stifling innovation.

Earlier this month, on behalf of our members and municipal staff, we provided comments on on the respective Regulatory Registry posting, outlining preliminary considerations for the Province should they apply the framework to municipalities:

- Provide tools to leverage digital opportunities including updating legislative tools such as MFIPPA and the MEA, and related legislative frameworks, policies, guides and training, among other resources
- Collaborate and co-design with municipalities and subject matter experts considering the differences in municipal structures, size, and digital maturity
- Minimize the administrative and reporting burden while balancing accountability where considering additional reporting and recordkeeping requirements.

While Bill 194 only proposes privacy-related amendments for the *Freedom of Information and Protection of Privacy Act (FIPPA)*, we took the opportunity to provide some early thoughts on implications for *MFIPPA* in case similar amendments are contemplated in the future.

We also reiterated that a comprehensive review and update of *MFIPPA* is required. We encourage members to support our *MFIPPA* modernization advocacy by downloading our toolkit that contains resources you can use within your own day-to-day work including a template council resolution.

We know that digital transformation is affecting all municipalities in different ways. To advocate effectively, we rely on members to provide insights and advice on issues impacting your work. If

Policy Updates

Canada Community Building Fund Renewed - The federal and provincial governments, with the City of Toronto and Association of Municipalities of Ontario, renewed the Canada Community Building Fund agreement. The federal government will invest \$4.7 billion over the next five years, starting with \$895 million in 2024-25.

Bills Passed & Government Bills:

Bill 200, *Homeowner Protection Act, 2024* - (Royal Assent Received) The Bill amends various *Acts* with respect to homebuyers and homeowners, properties of cultural heritage value or interest and certain planning matters.

Bill 197, *Safer Roads and Communities Act, 2024* - (Second Reading Debated) The Bill makes various amendments to the *Highway Traffic Act*, related to targeting high-risk driving, fighting vehicle theft, enforcing commercial vehicle safety and travelling safely.

2024 - (Royal Assent Received) On May 16, 2024, the Ontario legislature passed the budget bill amending several pieces of legislation including the *Building Ontario Fund Act*, the *Fuel Tax Act*, the *Gasoline Tax Act*, the *Pension Benefits Act* and more.

(Royal Assent Received) On June 6, 2024 the Ontario legislature enacted the *Veterinarian Professionals Act, 2024* amending and repealing various acts. Intended to enable improved access to veterinary care, the legislation will create a formal scope of practice for veterinary technicians, new requirements for continuing education, modify the complaints resolution process, increase penalties for actions that could harm animals, and modify representation on the council of the regulatory college.

Bill 165, *Keeping Energy Costs Down Act, 2024* - (Royal Assent Received) The Bill makes various amendments to the *Ontario Energy Board Act, 1998*. The legislation gives the province authority to reverse the Ontario Energy Board (OEB) decision to require residential customers and small businesses to pay the cost of new natural gas connections upfront as opposed to over 40 years.

It also prohibits the operation of puppy mills.

Act, 2024 - (First Reading Ordered referred to Standing Committee on Heritage, Infrastructure and Cultural Policy) This Bill introduced by Green Party Leader, Mike Schreiner, would make various amendments to the *Planning Act* to require official plans to contain policies authorizing the use of up to four residential units in settlement areas, and require the council of each local municipality to pass a bylaw to give effect to such policies. If passed, it would also require official plans to authorize midrise housing developments from 6-11 stories on major streets, including transit corridors.

We are asking the provincial and federal governments to work collaboratively with each other and municipalities. These are complex issues that require comprehensive responses from all orders of government working together.



AMO Policy Update: AMO/OMA Resolution Campaign, SALC Regulations, and Advocacy Updates

AMO/OMA Joint Resolution Campaign on Physician Shortage

Communities across Ontario have been facing critical health-care challenges, including long waitlists for primary care, shortages of doctors and other health care workers, and emergency room closures. These cracks in Ontario's health care system are impacting economic development, health, and well-being at the local level. AMO and the Ontario Medical Association (OMA) have jointly developed a council resolution (PDF, Word) urging the provincial government to recognize the physician shortage in your municipality and throughout Ontario. By adopting this resolution, your municipality can play a crucial role in highlighting the urgent need for more healthcare resources and support.

Access to health services will be a key discussion at the AMO Conference in Ottawa from August 18-21. In addition to being a concurrent session on the topic, the OMA will be sponsoring the Rural Caucus Lunch on August 20 and has reserved meeting space at the Fairmont Château Laurier for both August 20 and 21 to meet directly with municipal leaders. New Seniors Active Living Centres Act, 2017 Regulations

The <u>new regulation</u> under the *Seniors Active Living Centres Act, 2017* intends to improve access to the Seniors Active Living Centres (SALC) program for underserved communities so more older Ontarians have opportunities to stay active and engaged. Municipalities play an important role in supporting SALC programs, however they may not have the budget to support the number of SALC programs needed in their community. The new regulation prescribes additional entities, and combinations of entities, that can make the required 20% funding contribution to better support underserved communities (e.g., Francophone, Indigenous, rural/remote).

The Ministry of Seniors and Accessibility worked with AMO to conduct two focus groups of municipal representatives to inform this regulation, and AMO provided a <u>submission</u> outlining our support for expanding the entities that can contribute to Seniors Active Living Centres. Update on AMO's Advocacy on Provincial Cyber Security Legislation

AMO <u>submitted comments</u> on Bill 194, the proposed *Strengthening Cyber Security and Building Trust in the Public Sector Act, 2024*. AMO appreciates that the province is as concerned as the municipal sector about the increased number of cyber security threats, but is concerned that a one-size-fits-all solution across the broader public sector could be challenging for municipalities to implement. We will continue to work with the province to ensure that municipal needs are reflected as cyber security regulations are brought forward.

AMO's Advocacy to the Province's Skilled Trades Special Advisor

On June 11, AMO <u>sent a letter</u> to the Minister of Labour, Immigration and Skills Development regarding the <u>recently appointed</u> Skilled Trades Special Advisor who has been given a mandate to advise the province on the needs of Ontario's workforce with a focus on manufacturing and automotive industries. AMO's letter emphasizes the urgent need to train, attract and retain workers in the construction trades so municipalities can continue to deliver growth-enabling infrastructure to support housing and economic development.
