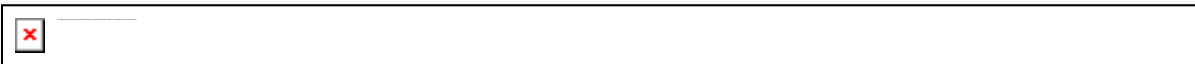
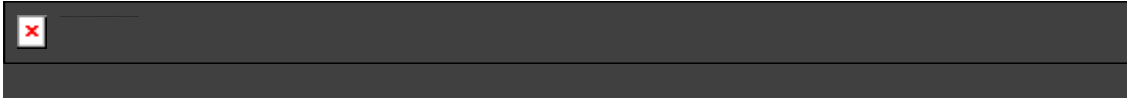

Bruce Power provides two million pieces of personal protective equipment for Ontario's COVID-19 fight



TIVERTON, ON – *October 28, 2020* – Bruce Power announced today that it has provided front-line organizations across the province with two million pieces of personal protective equipment (PPE) over the course of the COVID-19 pandemic. This represents the largest announced private-sector donation of PPE in Canada to date. PPE continues to play an important role in reducing the spread of COVID-19, helping ensure the province can restart the economy safely.

“Our commitment to the community goes beyond providing reliable electricity to the people of Ontario, and isotopes to sterilize medical equipment across the globe,” said Mike Rencheck, Bruce Power’s President and CEO. “We are playing an active role in the province’s fight against COVID-19 and will continue to support our communities through the recovery.”

The Retooling and Economic Recovery Council (RERC), a partnership between Bruce Power and its Ontario-based suppliers, has played a key role in supporting front-line PPE needs. In addition to refocusing their efforts to produce PPE such as face shields and reusable gowns, the council sponsored and distributed more than 50,000 litres of hand

sanitizer for local businesses, schools and non-profit organizations, including food banks.

The council also launched the *Strength in Numbers* online PPE portal, providing organizations with the ability to leverage collective buying power to secure PPE items at a competitive price.

Ontario Premier Doug Ford expressed his gratitude to Rencheck and Bruce Power for their ongoing commitment.

“I want to thank Bruce Power for showing the true Ontario spirit and making this generous donation of PPE to support Ontario businesses, schools, and non-profits,” said Premier Ford. “I am incredibly proud of how the Ontario business community, including Bruce Power, has stepped up during these extraordinary times to give back to their local communities, keep people safe and healthy, and ensure we defeat this terrible virus.”

Seamus O'Regan, the federal Minister of Natural Resources, also praised the company for its role in protecting others during the pandemic.

“Canadians are stepping up to the plate to help keep our front-line workers safe,” said Minister O'Regan. “Donations like this one from Bruce Power show exactly how we need to support each other and get through these tough times.”

The company worked closely with local and regional public health officials to understand what supplies and equipment were in highest demand and which organizations were in need. Among the PPE items secured by Bruce Power were masks, gloves, hand sanitizer and face shields. Supplies were distributed to health-care workers and first responders, local school boards, food banks, recovery centres in Bruce, Grey and Essex counties, Indigenous communities, and small businesses through chambers of commerce and business improvement associations.

“I’m pleased to see Bruce Power’s continued collaboration with public health officials, and their ongoing commitment to keeping Canadians safe through these difficult times,” said Huron-Bruce MP Ben Lobb. “I’d like to thank them for their hard work in the fight against COVID-19, and their ongoing support of our community.”

Today’s announcement is also being lauded by other elected members of the provincial

government.

“Since the beginning of COVID-19, Bruce Power has not only supported reliable and affordable nuclear power to millions of Ontarians, but have continuously supported front-line workers across the province with their generous donations of PPE,” said Greg Rickford, Minister of Energy, Northern Development and Mines, and Minister of Indigenous Affairs. “Thank you once again for this generous donation to help Ontarians across the province fight COVID-19.”

Hearing from our Municipal Liaison Group

Our Municipal Liaison Group (MLG) met virtually on October 22. During that time we continued our conversations on how we are supporting municipalities through this pandemic and heard from the group on continued efforts to digitize building plans and submit them to MPAC electronically, which helps us capture new



assessment.

Our MLG group also provided input on our work to redesign Municipal Connect, which is well underway. We have engaged with a group of 18 municipalities who are regularly sharing valuable user feedback as we build the new system and we anticipate municipalities will transition to the new system early in 2021.

Earlier this month, MPAC hosted a joint webinar with the Ontario Ministry of Agriculture, Food and

Rural Affairs (OMAFRA) and Agricornp to provide an overview of the Farm Property Tax Rate Program's administration, the process for municipalities from application through approval, and a discussion on consolidation and severance, Tax Incentive Approvals (TIAs) and Tax Incentive Year-ends (TIYs). Moving forward: updates to the PAN and AboutMyProperty

Next month, we are launching changes to the Property Assessment Notice (PAN) and AboutMyProperty (AMP) to enhance the customer experience for property owners.

These changes were informed by market-tested feedback and include:

- re-ordering PAN content to intuitively walk the reader through the information
- simplifying the login and registration process for AMP while still optimizing security
- a new user interface for clear and simple navigation
- enhancements to the online filing of a Request for Reconsideration (RfR), the fastest and easiest way to submit and track the progress of an RfR.

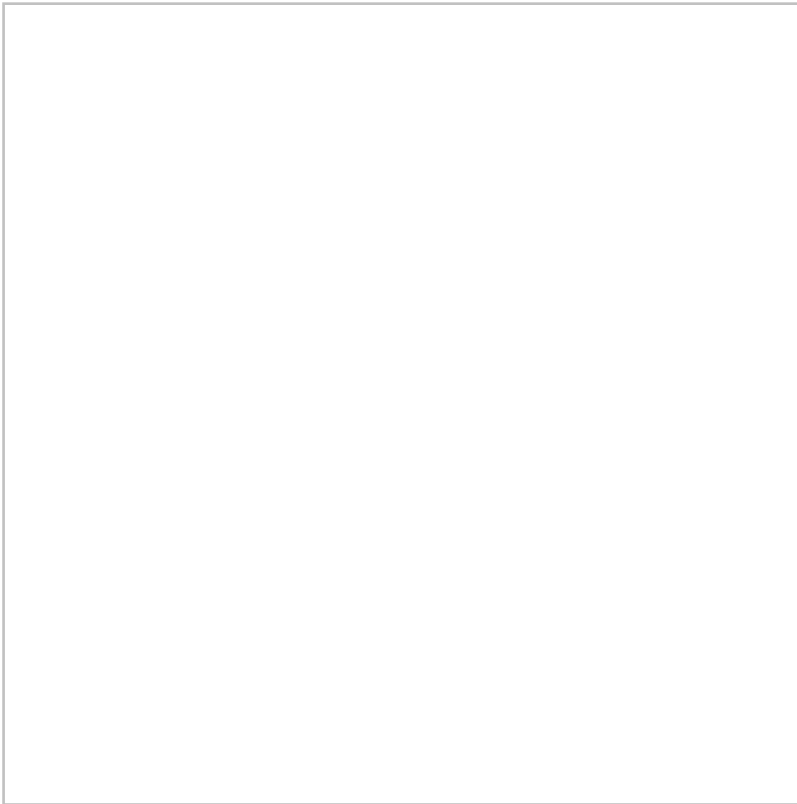
To access this information, property owners will be instructed to visit mpac.ca and log in to AboutMyProperty using the Roll Number and Access Key on their notice. Users who already have an account can log in using their existing User ID and password and they will be prompted to re-register using their email address and a new secure 11-character password.

AMO's Cyber Security tool kit

We are always looking for new ways to share information, best practices and insights with our municipal partners. During our delegation to the Association of Municipalities of Ontario (AMO)'s Digital Government Task Force earlier this year, our ISO27001 certified IT team was able to provide valuable cyber security insights that went towards developing AMO's new [Cyber Security Toolkit](#). AMO designed the toolkit to build cyber security knowledge and help its members manage the risk of a potential attack with best practices and policy considerations.

New feature in Municipal Connect

Starting November 2, 2020, municipal staff will be able to view and track the status of severances and consolidations for their municipality through WorkSight in [Municipal Connect](#). This enhancement will also provide municipalities an efficient way to access copies of completed Severance Consolidated Information Forms (SCIF), making the portal even more of a one-stop shop for our municipal partners. Your local Municipal and Stakeholder Relations team will be offering training to municipal staff throughout November.



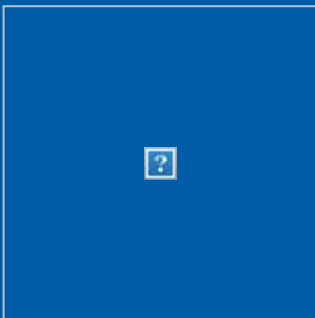
When we saw an opportunity to build greater awareness and understanding of the Farm Property Class Tax Rate Program this fall, we approached the Ontario Ministry of Agriculture, Food and Rural Affairs (OMAFRA) and Agricorp to co-host an informational webinar for the municipal sector.

"We're looking at ways to work collaboratively with our government partners to share common information with our shared stakeholders," says MPAC's James Harvey, Account Manager, Government Relations. "By co-hosting a webinar we are giving municipalities access to the same information at the same time. This format also gives municipalities the chance to have a dialogue with all of the involved parties together."

Over the summer, we worked with the Ontario Municipal Tax and Revenue Association (OMTRA) and Municipal Finance Officers' Association (MFOA) to co-host two webinars for municipalities about the Assessment Review Board appeals process to support them in navigating schedule changes and the demands of the process during the pandemic.

We are continuing to identify opportunities to make connections across the municipal sector and provide our municipal partners with resources and tools to support them in their work.

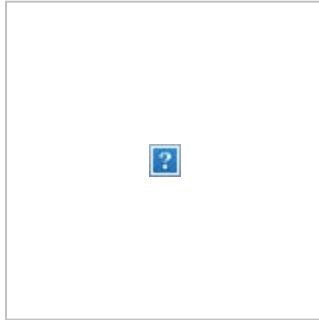

Engaged in our communities: In the coming days, OPG will make the rounds of Bruce-area municipal councils to provide updates and answer questions about activities at the Western Waste Management Facility and other OPG sites around the province. Local councils are enabling delegations such as OPG's to appear virtually, through applications such as Zoom and Skype or by teleconference. Around Ontario and beyond:

- **Health-care harvest:** OPG has [successfully completed](#) a harvest of Cobalt-60 at Pickering Nuclear Generating Station. The medical isotope is used to sterilize single-use medical devices, including syringes and COVID-19 testing swabs, and to make food and consumer products safer. About half of the world's Cobalt-60 supply comes from Ontario.
- **Clean-energy future:** OPG is [advancing design work](#) with three developers of Small Modular Reactors (SMRs): GE Hitachi, Terrestrial Energy and X-energy. "OPG is leveraging more than 50

years of nuclear experience to support the development of carbon-free nuclear technology," said Ken Hartwick, OPG President and CEO. "Our work with these three developers – along with our Global First Power partnership with Ultra-Safe Nuclear Corporation and its SMR project to support remote energy needs – demonstrates OPG's unique position to become a world leader in SMRs."

- **Collaboration hub:** In October, OPG celebrated the [official opening](#) of a home for the new Centre for Canadian Nuclear Sustainability. Located at the Pickering Town Centre, the world-class facility will attract skilled jobs, businesses and economic development to Durham Region, while advancing collaboration on research and innovation in nuclear decommissioning.
- **Path to net zero:** Canada's Minister of Natural Resources says nuclear energy is vital to fighting climate change and meeting Canada's carbon-emissions reduction targets. "We have not seen a model where we can get to net-zero emissions by 2050 without nuclear," Seamus O'Regan [told the CBC](#). "The fact of the matter is that it produces zero emissions."

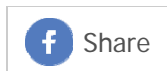

TNT(Boom) really enjoyed performing and there has already been mention that a Christmas concert might be in the works, so get practicing your carols!

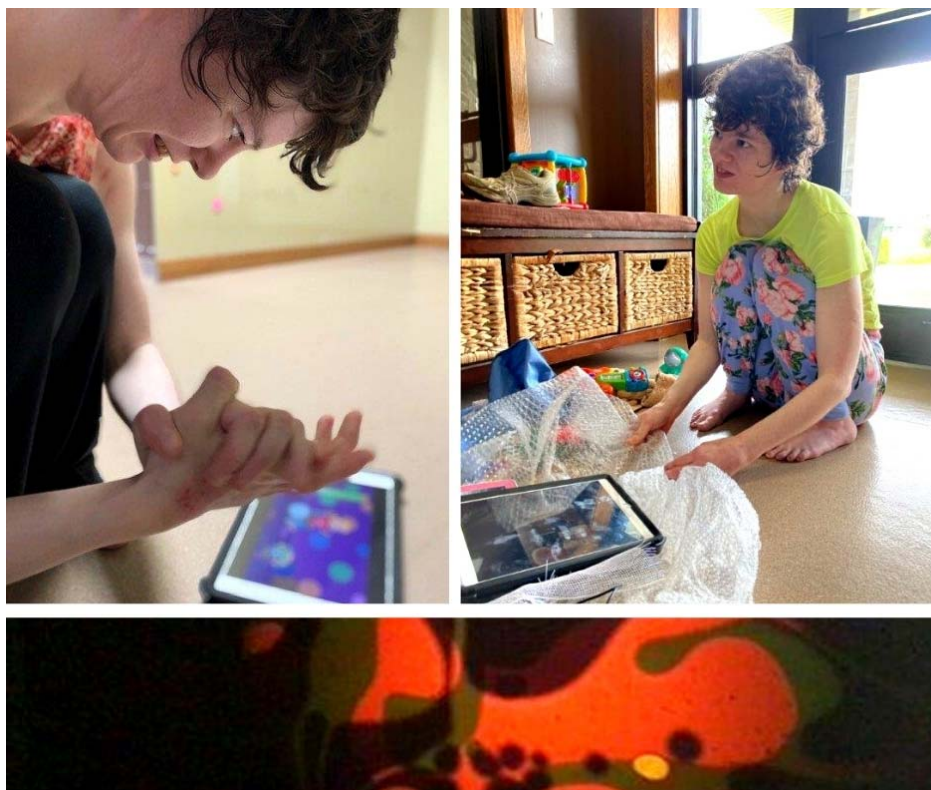
We are so grateful for the time that TNT(Boom) has given to the CPS program. Tony is a

Ottawa launches Universal Broadband Fund

Dear rural, remote, and Northern members,

Yesterday, the federal government [launched its Universal Broadband Fund](#)—a major win for rural, remote and northern communities.

This **\$1.75 billion fund** will help connect communities to high-speed Internet across the country. That's up from the \$1 billion originally allocated in Budget 2019. It also includes a [\\$150 million Rapid Response Stream](#) to accelerate shovel-ready projects.

This progress is a direct result of the tireless efforts of rural and northern municipal leaders. It responds to FCM's call to do more, faster, to bring reliable broadband to all communities—and shows the federal government is listening to the priorities of Rural Canada. We did this. Our unity of purpose has paid off.

The Universal Broadband Fund aims to fund broadband infrastructure projects that will bring high-speed Internet at 50/10 Megabits per second (Mbps) to rural and remote communities.

- In the coming weeks, Innovation, Science, and Economic Development Canada (ISED) will be hosting a [series of webinars](#) to help guide you through the application process.

Deadlines:

- The deadline for the rapid-response stream is **January 15, 2021**. Applications are being accepted and reviewed on a rolling basis.
- The deadline for the regular project stream is **February 15, 2021**.
