

# The Corporation of the Township of Huron-Kinloss



## BY-LAW

### 2020 - 135

---

Being a by-law to levy the cost of work undertaken on Stewart Branch  
'M' & 'P' Municipal Drain in the Township of Huron-Kinloss

---

**WHEREAS** under Section 74 of the Drainage Act, R.S.O., 1980 and under By-Law No. 11-68, the Township of Huron-Kinloss is responsible for maintenance of the Stewart M & P Municipal Drain at the expense of all upstream owners of lands and road assessed therein;

**WHEREAS** the work undertaken was to repair catch basin and washout;

**WHEREAS** the sum of \$1,004.18 shall be assessed against all upstream lands and roads in the watershed of the Stewart Branch 'M' & 'P' Municipal Drain, prorate with the last revised schedule of assessment for said drain;

**WHEREAS** the last revised schedule of assessment on the Stewart Branch 'M' & 'P' Municipal Drain is contained in a report by H.M Gibson and adopted as Township of Huron-Kinloss By-Law No. 11-68;

**NOW THEREFORE** the Council of The Corporation of the Township of Huron-Kinloss enacts as follows:

- 1.0 The amount \$1,004.18 shall be prorated as outlined in Schedule "A" attached to the by-law.
- 2.0 The amount assessed to lands used for agricultural purposes shall be reduced by the one third grant if available in accordance with Section 85 (a)(ii) and 87 (1)(a) of the Drainage Act, R.S.O. 1980.
- 3.0 All assessments in the Township of Huron-Kinloss, except for the assessment to roads and net assessments that are \$5.00 or less, shall be due 30 days after receipt after which time the amount due will be added to the 2020 collection roll together with interest at 1.25% per month.
- 4.0 The assessments against roads shall be due when billed.
- 5.0 Net assessments that are \$5.00 or less shall be paid from general funds of the Township of Huron-Kinloss.
- 6.0 This by-law shall come into full force and effect upon final passage.
- 7.0 This by-law may be cited as the "Stewart Branch 'M' & 'P' Municipal Drain Repair By-Law".

**READ a FIRST and SECOND TIME** this 16th day of November, 2020.

**READ a THIRD TIME and FINALLY PASSED** this 16th day of November 2020.
