Animal Control

There were seven complaints regarding dogs running at large this month. Owners who could be identified through their dogs Huron-Kinloss dog tag received education verbally and was then follow-up with a written notice.

One dog whose owners could not be identified was brought to the Township Pound without incident. No owner has come forward and the dog has been accepted into an adoption program.

Two brown female cocker spaniels' dogs were found by residents at the side of the road. Due to the dogs condition the residents took them into their own vet who scanned them for an identification chip and tattoo, none were found. The location of the dogs was not provided. The residents called to ensure that no calls were received for the lost dogs and to let the Township know of the occurrence.

Property Maintenance

Of the six property maintenance complaints, four pertained to dead trees in residential areas that are at risk of falling causing damage to adjacent properties.

The two other concerns were debris accumulation in yards. Once concerns are confirmed by inspection, property owners are notified and issued compliance dates.

Sign By-law

A complaint came forward regarding the amount of business advertisement signs that have accumulated on the road allowances and hydro poles along the lakeshore area. The complainant stated they will be requesting the hydro company remove the advertisements from their poles when they are working in the area. Staff will increase education to the public on permittable locations for both home business and commercial business signs. A list of alternative ways to legally advertise within the Township will also be provided. Notices will be sent to non-compliant businesses soon.

Ontario Wildlife Damage Compensation Program

There have been five investigations regarding the Ontario Wildlife Damage Compensation Program since August. By-law Enforcement is appointed as the Municipal Livestock Investigator to complete onsite investigations when livestock have been allegedly injured or killed by a wildlife predator. Along with the investigation, the application form is filled out and submitted for review and approval. At this time last year, there were only two investigations had occurred.
