## **Additional activity:**

- Ripley's new fire apparatus (Pumper Truck) finial inspection was completed on December 22 and the apparatus in now in the Lucknow station having radio and equipment installed. Ripley firefighter will need to complete drive time and pump testing before the apparatus will be in to service.
   This was a huge undertaking by the Apparatus committee to select a truck that will service the community for the next 15 years. Pumper 15-1 will be in service by Jan 31, 2025. Thank you, District Chief Martyn, Captain Ackert and Training Officer Vanhardeveld.
- The Fire Protection (FP) Grant program was announced in the government's 2024 Budget and is designed to support cancer prevention efforts by municipal fire departments across Ontario. The FP Grant will assist fire departments in acquiring critical equipment to enhance firefighter health and safety, and minor infrastructure at the local level. Only projects whose objectives align with at least one of the objectives in the list below will be eligible for funding.
  - (1) Cancer Prevention Equipment and Supplies
  - (2) Cancer Prevention Personal Protective Equipment (PPE)
  - (3) Cancer Prevention Minor Infrastructure
  - (4) Minor Infrastructure Modernization

Both stations were successful in receiving the Fire Protection Grant. The Township will receive \$16,460.00 to enhance our cancer prevention program for the safety of our firefighters.

A By-Law will be required to execute the funding agreement.
