Background:

Lighthouse Park Play Equipment

The Lighthouse Park play equipment and surfacing replacement is included in the 2025 capital budget.

Algae Cleaning along Lakeshore

Snobelen Ag services costs were included in the 2025 operating budget and are now contracted to service the lakeshore algae cleaning for 2025.

Municipal Office Basement Update

Staff continue to work with the insurance company and restoration specialists to move forward with repairs.

Discussion/Analysis/Overview:

Lighthouse Park Play Equipment

The Play equipment and surfacing replacement is scheduled for June 16th- June 19th, 2025, at which time the park will be closed with public use beginning June 20th. The total project is on budget \$70 000 including the nautical theme equipment from Play power for \$41 000 plus HST and safety surfacing installed by Ure-tech for \$24 500 as per the purchasing policy.

The layout of the play equipment is attached. We bring this forward for information purposes.

Algae Cleaning along Lakeshore

Snobelen Ag services schedule is attached with no changes from the 2024 schedule. The service agreement price was increased by 5% this year and is attached. The lakeshore algae cleaning for 2025 will commence in May and end in October with the bulk of servicing occurring in July and August. We bring this forward for information purposes.

Municipal Office Basement Update

Water damaged flooring, furniture, and lower drywall has been removed and itemized. Staff are working with the restoration contractors to ensure repairs and remediations continue to move forward.
