Background:

These resolutions were received from other Ontario Municipalities and organizations for consideration.

Discussion/Analysis/Overview:

- a) The Township of Champlain support the Canada Metal Processing Group (MPG Canada) in its request to the Canadian Government to immediately implement matching tariff measures, provide support for workers and businesses during this economic crisis, prevent unfairly traded imports from other countries into Canada, promote buying Canadian steel and to work with the United States to create an aligned North American steel trade market for melted and poured North American steel.
- b) The Region of Durham Municipality with the support of the Municipality of Assinick are calling on the Government of Canada to pass legislation banning with certain exceptions the public display of Nazi symbols and iconology.
- c) The Town of Bradford West Gwillimbury is requesting that the province of Ontario accelerate a resolution for the accessory dwelling and secondary rentals unit framework to address the housing crisis, introduce mediation services to

resolve disputes quickly and amicably, low cost legal assistance and to strengthen protections for tenants and landlords.

- d) The County of Bruce is calling on the federal and provincial governments to take action to ensure that municipalities have the tools they need to protect Canadian consumers and businesses by removing any impediments to municipalities preferring Canadian companies for capital projects and supplies when appropriate and feasible and to remove interprovincial trade barriers.

- e) The Township of Brudenell, Lyndoch and Raglan support the County of Renfrew's resolutions requesting that the Province of Ontario collaborate with Child Welfare agencies to develop an updated Child Welfare funding formula to ensure an equitable and proportionate distribution that meets the diverse, unique and complex needs of the communities and populations served.
