#### **Background:**

##### Point Clark Lighthouse Play Equipment

The Point Clark Play equipment was included in the 2025 Capital plan with a budget of \$70 000.00

##### Municipal Office Basement

The Municipal office basement restorations have been ongoing for three months.

##### Medical Centre / Daycare parking

There has been some concern with the lack of medical centre daycare parking.

##### RTO7 Trails Signage

Staff received 50% funding for the installation of nineteen signs for all trails in Huron-Kinloss. The project was included in the 2025 budget.

#### **Discussion/Analysis/Overview:**

##### Point Clark Lighthouse Play Equipment

The play equipment and rubber surfacing replacement were completed on June 25<sup>th</sup>, 2025, on budget. The project photo is attached.

##### Municipal Office Basement

The restorations are complete, with some minor adjustments, but the space is fully functional for staff. All staff should be commended for their cooperation with the temporary re-locates.

##### Medical Centre / Daycare parking

To provide additional parking at Medical Centre and Daycare, staff have received permission from neighbours to locate ten jersey barriers along the unopened lane south of the medical centre / daycare. This is a short-term temporary solution that will be addressed in a long-term plan. This will provide an estimated five parking spaces. We bring this forward for information purposes.

#### RTO7 Trails Signage

An approved copy of the one sign is attached for your review. We bring this forward for information purposes.
