Animal Services

Animal control services are in place to ensure that residents with and without pets or livestock can enjoy our Township. The By-Law Enforcement Officer responds to animal control complaints, but it is important to note that we do not respond to calls about cats or wildlife.

Huron-Kinloss is a pet friendly community; however, there are a few things you need to know before you add a four-legged friend to your family.

DOG LICENSING

Dog licences are valid for the calendar year and must be renewed annually. Invoices are mailed to all dog owners in January. Dog tags are permanent, there is no need to purchase a new tag each year. Dog tags must be attached to your dog's collar at all times.

The cost for a dog licence is:

- \$15.00 before March 1st
- \$25.00 after March 1st

WILDLIFE SERVICES

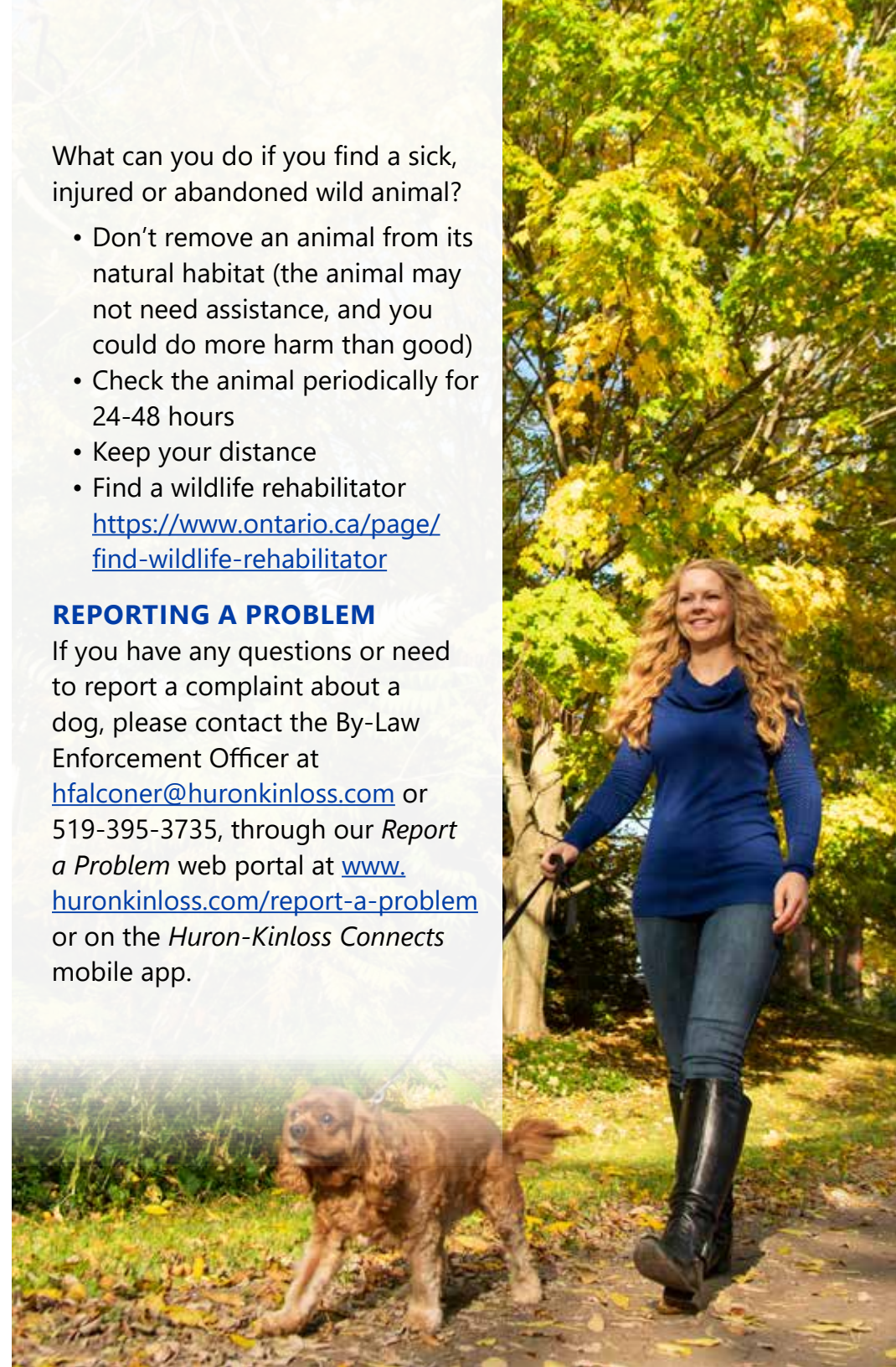
We share the Township with a number of wildlife species, many of them co-exist with us just fine. It is important to leave the wildlife alone whenever possible; however, there are some occasions when you might be concerned and want to make a report.

What can you do if you find a sick, injured or abandoned wild animal?

- Don't remove an animal from its natural habitat (the animal may not need assistance, and you could do more harm than good)
- Check the animal periodically for 24-48 hours
- Keep your distance
- Find a wildlife rehabilitator

Building Services

Before beginning any building work on your property, it is advisable to consult with the Building Department.

PERMIT APPLICATIONS

Building permit applications can be found on our website at www.huronkinloss.com/building-permits, or online at <https://ca.cloudpermit.com/login>. The Cloudpermit system allows you to submit your application online, track its progress, receive email updates and request inspections, from anywhere, at any time.

RESIDENTIAL PERMITS

Residential permits are required for new construction projects, additions, some renovations, accessory buildings, decks and swimming pools.

BUILDING PERMIT FEES

SEPTIC INSPECTION PROGRAM

The Township of Huron-Kinloss Septic Inspection Program helps to educate and ensure property owners are using and maintaining private sewage systems properly. Each year, approximately 300 septic systems are inspected.

You must have your septic system inspected under the HK-CSI program once per cycle, which is approximately every 8 years. Property owners will receive a notice when their septic inspection is due to be completed.

ZONING

The Zoning By-Law is an important document to review before planning any new construction or changes to your property. The Zoning By-Law can be found at www.huronkinloss.com/zoning.

The Chief Building Official is the Zoning By-Law Administrator for the Township.

Zoning by-laws cover such items as the use of land, where buildings and other structures may be located, the types of buildings that are permitted and how they may be used, lot sizes and dimensions, parking requirements, landscape and buffer requirements, building heights and setbacks from property lines.

The County of Bruce Planning Department provides administrative services to the municipality. To inquire about zoning by-law amendment applications, please contact a member of the County of Bruce Planning Department at 519-881-1782.



By-Law Enforcement

The Township of Huron-Kinloss Council has the authority to pass by-laws to ensure a safe, quiet and peaceful environment for residents.

Our By-Law Enforcement Officer is responsible for the investigation and enforcement of some of our municipal by-laws. Other by-laws are enforced by police or other government departments.

If you have questions or concerns related to by-laws or other enforcement issues, contact the municipal office.

FREQUENTLY ASKED QUESTIONS

Q: Can I have chickens in my backyard?

A: Backyard chickens and other agricultural animals are not permitted in the Urban Settlement areas (residential zones) according to the Comprehensive Zoning By-Law 2018-98, as amended. This is to ensure the health and well-being of residents living in close proximity to one another in the Township of Huron-Kinloss.

Q: How does the noise by-law affect me?

A: General noise must be minimized between the hours of 11 p.m. and 7 a.m. the next day (9 a.m. on Sundays). Every homeowner should be mindful of neighbouring residents at all times to not disturb the natural enjoyment of their properties. This includes persistent barking or whining of domestic pets. If you are hosting a celebration or gathering, exemptions to the Noise By-law can be obtained through Council to avoid prosecution. You must apply in writing to council at least 6 weeks advance of the function. Contact the clerk's department at info@huronkinloss.com for further details.

Q: Where can I ride my Off-Road Vehicle in the Township?

A: The Township of Huron-Kinloss Off-Road Vehicle Use By-Law 2015-89 permits off-road vehicles to drive on Township roadways if all operators and the vehicles are properly licensed and they follow all regulations under the Highway Traffic Act. Off-road vehicles are not permitted in any urban areas such as Ripley or Lucknow or in the area West of Lake Range Drive to Lake Huron except to obtain food, lodging or fuel. In no circumstances are off-Road vehicles permitted on the beach, or public trails.

Q: My neighbours yard is a mess. Is there anything the Township can do to have it cleaned up?

A: The Township of Huron-Kinloss has a Property Standards By-Law No. 2018-100, which deals with the exterior and interior of a building and the yards surrounding it. This By-Law is a minimum maintenance by-law, setting out the minimum standards in which a property must be kept. These health and safety guidelines are in place to protect neighbours as well as the property owners.

Fire & Emergency Services

The Township of Huron-Kinloss provides Fire and Emergency services, supported by the Lucknow & District Fire Department, the Ripley-Huron Fire Department, Kincardine Fire and Emergency Services, South Bruce OPP and Bruce County Emergency Medical Services (EMS).

FIRE SERVICES

The Township of Huron-Kinloss Fire and Emergency Services department provides services and programs in our community to protect lives, property and the environment. We follow the three lines of fire safety defence:

- Public education
- Inspection and enforcement
- Emergency response

We respond to service calls for fires, fire alarm activation, carbon monoxide alarms, motor vehicle accidents, rescues, emergency medical intervention with Bruce County EMS, and natural disasters.

FIRE SAFETY INSPECTIONS

Whether it's a home, education facility, office building or event venue, fire safety saves lives. If you own a building, you are responsible for ensuring it's maintained in compliance with the Ontario Fire Code which can help save lives, prevent injuries and save structures.

Please do not call 911 to request an inspection.

FIRE PERMITS

Open Air Fire Permits are required for all Township of Huron-Kinloss properties wishing to conduct open air burning or beach fires. A permit is not required for barbecues and permanent outdoor fireplaces used solely for the cooking of food on a grill. Recreational fires (campfires) and fires set in containers such as chimineas, metal tubs or fire pits do not require a permit.

- or in person at the municipal office located at 21 Queen Street, Ripley.

Open Air Fire Permits cost \$10.00 and are renewed annually (invoices will be mailed to permit holders).



Garbage and Recycling

Bruce Area Solid Waste Recycling (BASWR) provides curbside household garbage and recycling pick-up for Huron-Kinloss. For further information, or to report a missed pick up please call: BASWR at 1-800-794-9770.

We also have two landfills and a yard waste depot (seasonal) to help residents dispose of waste and recycling.

GARBAGE PICK-UP

Bag Tags cost \$2.50 each; each bag left at the curb must have a Huron-Kinloss bag tag attached and weigh no more than 11 kg (25 lbs.).

- Section 1 :** Lakeshore South-Ashfield boundary to south side of Pine River
Lake Huron shoreline east to and including both sides of Lake Range Drive & Arthur Street.
- Section 2 :** Lakeshore North-North of Pine River to Kincardine boundary
Lake Huron shoreline east to and including both sides of Lake Range Dr.
- Section 3:** All rural properties east of Lake Range Drive to and excluding Bruce Road 7 (excluding Arthur Street).
- Section 4:** All rural properties east of and including Bruce Road 7, excluding properties east of Bruce Road 1 except for Silver Lake Road.
- Section 5 :** Village of Ripley.
- Section 6 :** All rural properties east of Bruce Road 1; from and including Grey Ox Avenue north to and including Southline Ave (east of Bruce Road 1).
- Section 7 :** All rural properties east of Bruce Road 1 and south of Grey Ox Avenue; and Village of Lucknow; and Hamlet of Whitechurch.



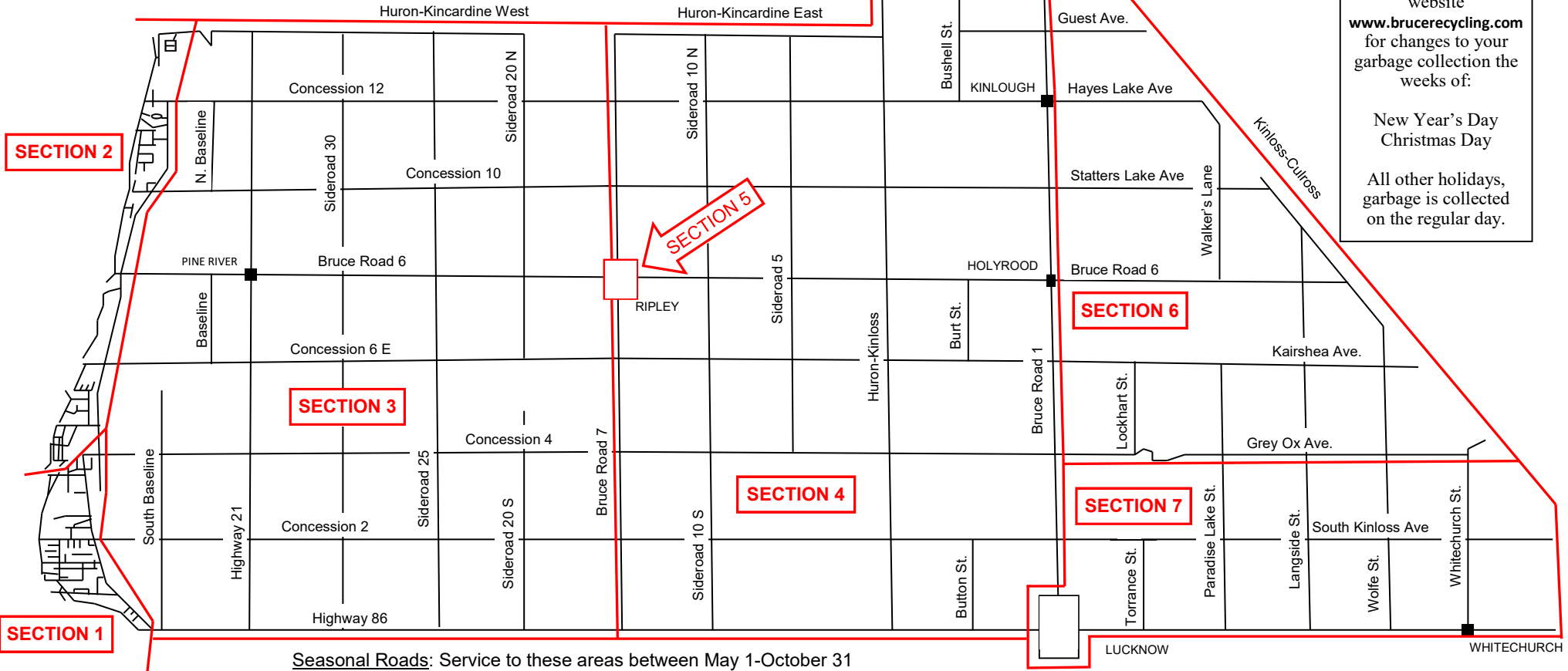

Getting Married

The Township of Huron-Kinloss offers Civil Ceremonies for couples wishing to marry in a non-religious ceremony. Our Marriage Commissioners are delighted to perform your wedding ceremony at any reasonable location of your choice. Together with you, they will design a ceremony that will make your special day one to remember.

MARRIAGE COMMISSIONER FEES

The fee for a Marriage Commissioner is \$375.00 with a \$100.00 deposit required at time of booking to reserve your date and time. All bookings and payments for Marriage Commissioner services are administered through the Township of Huron-Kinloss. Final payment is due two weeks prior to your wedding. Travel and rehearsal fees may apply and are paid directly to the Marriage Commissioner.

If cancelling, notice must be received a minimum of 30 days prior to the date of your wedding to receive a refund of \$275.00.

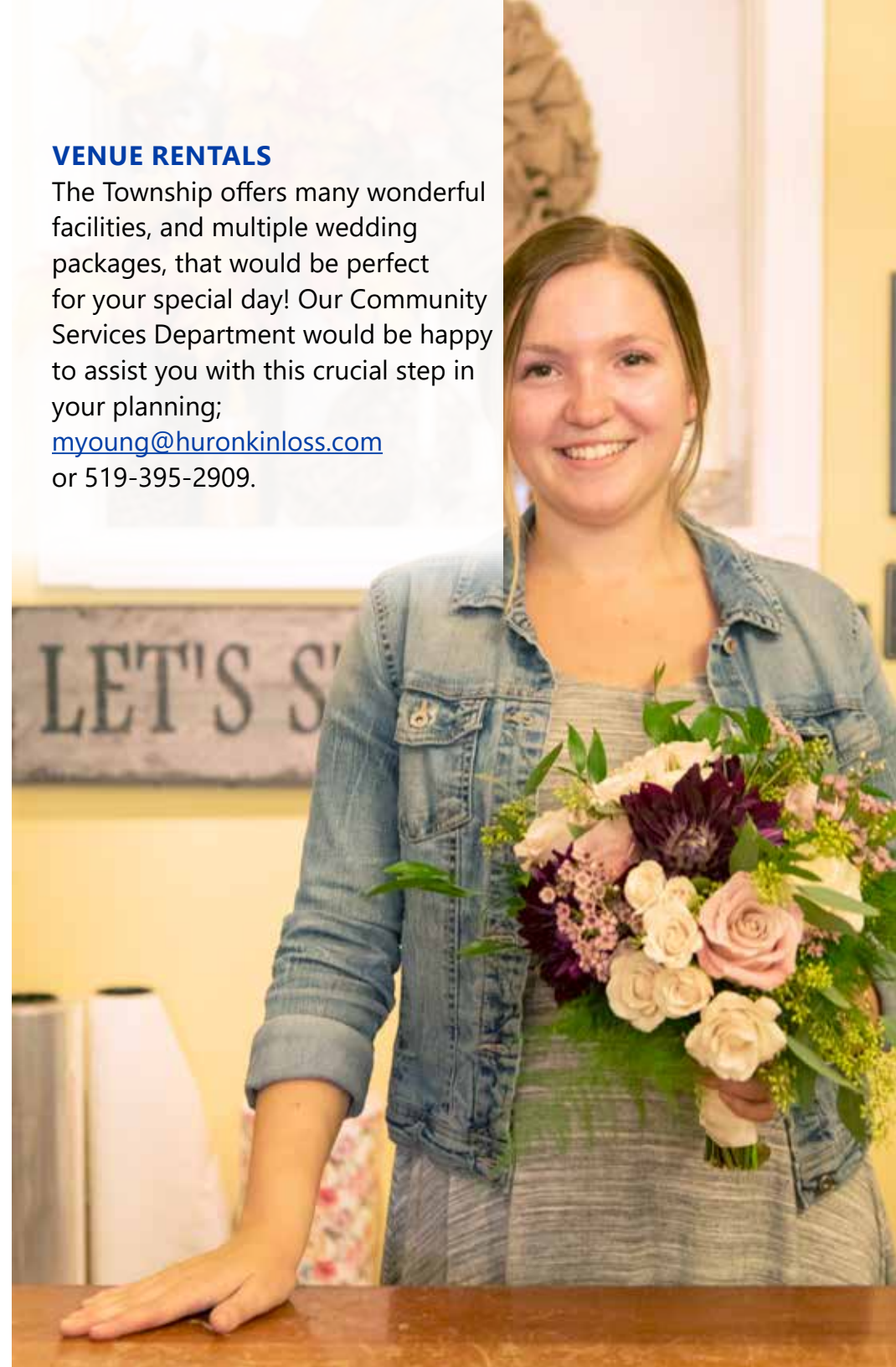
MARRIAGE LICENCE

A marriage licence is a required official permit that enables the couple to have a marriage ceremony. This is a prerequisite to obtain an official marriage certificate from the Province.

The fee for a marriage licence is \$125.00.

Property Taxes

Property taxes are a significant revenue source for the Township of Huron-Kinloss. They cover the cost of the wide variety of services we provide to our residents.

A property tax notice is issued two times per year as follows:

- Interim Tax Notice with two installments due the 1st business day of March and June
- Final Tax Notice with two installments due the 1st business day of September and December

Tax bills can be sent through email by signing up for tax e-billing at www.huronkinloss.com/tax-e-billing

Tax rates are calculated and set annually as part of the budget process; then established through a by-law passed by Council.

HOW DO I PAY MY TAXES?

The Township offers several convenient methods to pay property taxes:

PENALTY

Penalty is applicable on the first day of default and on the first day of each calendar month thereafter in which default continues as set out in the Municipal Act. The penalty rate is 1.25% per month or 15% per annum.

ANNUAL BUDGET

The Township of Huron-Kinloss is responsible for setting a budget each year. Through this process we evaluate programs and services to meet the needs of our community.

FEES AND CHARGES

Roads & Transportation

Public Works maintains, and is working to improve, approximately 381 km of roadway.

SNOW REMOVAL

Public Works staff remove snow from municipal roadways and regularly monitor road and weather conditions so that we can do so in a safe and timely way.

You can help the Township's winter maintenance efforts by considering these helpful tips:

- Remove all vehicles from the road following a snowfall.
- Do not place snow from sidewalks or driveways on the street. The Highway Traffic Act and Township Piling Snow By-Law makes it illegal to place snow or ice on a roadway.
- Be patient. Snowplows will clear the streets as soon as possible.
- Do not place hockey nets or basketball nets on the roadway or sidewalks.
- Do not block a fire hydrant by piling snow or ice around it.
- Clear snow and ice from sewer grates and culverts to help prevent flooding.

The Public Works Department does not engage in snow removal between 6:00 p.m. and 5:00 a.m. unless there is an emergency.

Overnight parking is not allowed on Township roads or boulevards from November 1st to April 30th.

ENTRANCE WAYS

When a road construction project happens on your road, and part or all of a driveway entrance that is on Township road allowance needs to be removed, the driveway entrance will be restored as per the Entrance Ways Policy.

If you are constructing a new driveway, or want to make changes to the one you have, please follow the Entrance Ways Policy and get an Entrance Ways Permit.

STORMWATER MANAGEMENT

The purpose of a roadside ditch is the control of surface drainage from the road. Before making any changes to roadside ditches, please contact the Director of Public Works at 519-395-3735 ext. 130.

To report a damaged or missing street sign, damaged sidewalk, broken streetlight, snow removal complaint or other public works issue please use our Report a Problem web portal at www.huronkinloss.com/report-a-problem or download our mobile app "Huron-Kinloss Connects" from the Google Play or Apple App store.

Water and Sewer

The Township of Huron-Kinloss Public Works Department oversees our water and wastewater systems. We are committed to delivering clean, reliable, and safe drinking water.

SHUTTING OFF OR TURNING YOUR WATER ON

When opening or closing a cottage for the season, weekend, or rental period, please contact us at 519-395-3735 a minimum of two business days before to have your water turned on or off. There is no fee for this service.

BILLING AND RATES

Fees for non-metered municipal water and sewers are a flat rate and set in the Water and Wastewater Fees By-Law. They are added to your tax bill; for more information about your tax bill, visit www.huronkinloss.com/property-taxes. Metered water is billed each quarter and invoices can be paid via phone, internet, or in-person (cash, cheque or debit).

FROZEN SERVICES

Home owners are encouraged to have their water service turned off and the lines drained prior to leaving for an extended period of time. During the winter season, running a continuous stream of cold water may help prevent freezing.

WASTEWATER AND SEWERS

The communities of Lucknow and Ripley have sanitary sewer systems. Both systems treat waste with stabilization ponds, aerated lagoons and rapid infiltration basins.

REPORTING A PLUGGED CATCH BASIN

Please call the Public Works Department at 519-395-3735 ext.133 to report a plugged catch basin.

SEPTIC SYSTEMS

Your property may have a septic system if municipal sewers are not available in your area. Septic Systems need an inspection every eight years, sometimes more often. Our Septic Inspection Program helps to protect our ground water system from toxins that might leak out of a sewage system. If you have questions about your sewage system, please call 519-395-3735.

EMERGENCY SITUATIONS

The after-hours emergency line at 1-866-299-5199 is for emergencies only. Routine turn off and turn on, locate requests for planned work and discoloured water at a location not used frequently are not emergencies. Please call 519-395-3735 during regular business hours, 8:30 a.m. to 4:30 p.m., for these issues.
