Background:

In January 2020, the NWMO announced they had secured the sufficient amount of land in Municipality of South Bruce to continue studies for the DGR. This announcement meant that the Township of Huron-Kinloss was removed from the site-selection process and no longer considered a host community for the project. Two communities remain in the Nuclear Waste Management Organization's (NWMO) site selection process to find a suitable location to store Canada's used nuclear fuel – the Township of Ignace and the Municipality of South Bruce

On Thursday, May 6, 2021, the South Bruce Community Liaison Committee will hear an overview from GHD Community Engagement Specialist Katrina McCullough on the Willingness Process Study. Well Water Sampling Program Begins

The NWMO has begun the well water sampling program in South Bruce.

The program will provide residents with assurance that their water will be carefully safeguarded, and help landowners and the NWMO better understand water resources and water quality in South Bruce around the potential repository site. This is a first step in implementing the NWMO's environmental baseline monitoring program, which was co-designed with the municipality.

Regional Early Investment in Education and Skills Program

The NWMO has committed \$30,000 for this regional program for 2021 to support regional primary and secondary schools that South Bruce and/or Huron-Kinloss residents attend.

Each school was pre-approved for up to \$2,500 to support science, technology, environmental and math learning and enrichment initiatives for youth. A total of ten schools and two robotics teams were contacted and notified about this available funding including:
