# **Report Origin**

To provide Council with an update on studies related to the South Bruce Nuclear Exploration Project.

# **Analysis**

It was identified in the Fall of 2020, that in excess of 40 studies would need to be done to explore and understand more about the Project and inform the interests of the community as described in the 36 Guiding Principles.

# 1. Funding

Funding for this study work will come from the Nuclear Waste Management Organization (NWMO) and is included in an amended agreement presented to Council on April 27, 2021. This work will continue into 2023 and future budgets will need to reflect this and a full recovery from NWMO will be needed.

The team of consultants are now engaged for the most part and are listed below. Further details can be found on the attached Summary of South Bruce Studies and Peer Reviews.

### 3. Studies

To keep council up to date on the type of studies that will be involve South Bruce. A list of the studies identified to date have been attached to this report as information. The studies identified as council is aware are derived from the 36 principles. Staff continue to review the scope of studies and work to set out the timing and planning of each study as we move forward.

# 4. Timing

The following study work is already underway:

- · Determining the willingness process,
- 2014-2019 Economic Development Strategy and the Corporate Strategic Plan Update.

To begin many of the studies additional information is require from the NWMO. This information is being prepared to present to the NWMO Board in June 2021, and subsequently to their funding organizations to describe the full life cycle costing of the project. As a result, much of this information will not be available until the Fall of 2021. The work plans from consultants indicate a process that will extend up to 8 months to be finished, and for the NWMO studies they will then feed into additional studies or be ready for Peer Review by South Bruce's consultants.

Other studies such as the Geoscience work that is being done by the NWMO is not expected to be complete until the end of 2022 with the peer review report by GHD Limited not expected until several months after that, into 2023. Based on our current information it would appear that our community will be informed by the work that is currently planned by the third quarter of 2023. Information will be made available as it is completed and for the lengthier, more detailed studies we will ask for interim reports to be prepared to keep Council and the community informed.

This timeline update is being made with the best data that can be assembled at this time. Regular updates to Council will take place as new and significant information becomes available.

Our team will be working towards an informed decision for our community.
