# Background:

The Community Services Department plans and implements annual programming and events, including summer sports, the Wolf Cub Adventure Camp, the Ripley Food Art Craft Festival and the Outdoor Pickleball Program in Point Clark.

### **Discussion:**

The Summer Sports season officially started on Monday, June 21<sup>st</sup>. The Summer Sports Committee organized the team rosters, schedule and equipment in line with Step 1 of the provinces Reopening Roadmap. At this time, maximum groups of 9 players, with one coach, can gather for training. No games or leagues are permitted at this time. Multiple groups of 10 are permitted to train on the same field or diamond, as long as they are spaced out.

The Wolf Cub Adventure Camp starts on Monday, July 5<sup>th</sup> and runs weekly for four weeks, concluding on Friday, July 30<sup>th</sup>. Camp Leaders begin on Monday, June 28<sup>th</sup> and will spend the week completing safety training and program planning. Registration numbers are as follows: Week 1 – 16, Week 2 – 18, Week 3 – 16, Week 4 – 15.

The Ripley Food Art Craft Festival is scheduled for Saturday, August 21<sup>st</sup> at the Ripley-Huron Community Centre. Staff are awaiting confirmation on maximum

gathering limits for both indoors and outdoors in order to finalize plans and complete the COVID-19 Safety Plan for the event. To date, there are 21 vendors registered, with a maximum set at 40.

Staff are finalizing plans for the start of the Outdoor Pickleball Program at the Point Clark Community Centre, which will be permitted to start in Step 2 of the Reopening Roadmap, on or before July 2<sup>nd</sup>.
