Main breaks and Leaks: 1 watermain repair on Rosinke Dr, 1 water leak on Walpole Trail. Power Outages: One power outage was reported on June 18th - water usage is high, and the Point Clark water tower got to a low level. The portable generator transfer switch at Point Clark needs to be changed to match the generator plug (has been ordered). Inquiries and Complaints: 4 curb stop issues; 3 water turn on/off requests

Lucknow

Exceedances: Cell #3 objective limits were exceeded on June 7, 2021, for CBOD and TSS. An algae bloom was noted at the time samples were collected, which can affect sample results. The GWSS effluent remains excellent. Flows for June were not available at the time of this report. Flows for May: daily max 628 m3 (84% capacity), daily avg 413 m3 (55% capacity). Non-Compliances: None

Equipment Issues: Raw sewage pump # 1 is out of service. The spare pump is at Wilsons for repair (awaiting receipt of repair parts). Aerators have been replaced and are in operation. Main Breaks and Leaks: None

Ripley

Exceedances: No chemical exceedances up to June 22, 2021. Flows for June were not available at the time of this report. Flows for May: daily max 407 m3 (68% capacity), daily avg 260 m3 (43% capacity). Note: Heavy rains on Saturday, June 26th resulted in high flows (and high-level alarms) at the sewage pump station.

Ongoing Recommendations

Water: Blairs Grove Well # 2 casing has severe corrosion (beyond repair) and will be abandoned as soon as a plan is developed. Corix has been contacted for flow meter verification (to begin in June). TSSA fuel tank inspection report still pending (Ripley Fire Hall). Ripley Elevated Tank interior inspection has been completed (report pending). DWQMS Management Review was conducted on June 24th (virtual).

Wastewater: Lucknow infiltration-inflow monitoring has been removed (reports to follow). Bypassing sewage in Ripley (if necessary) cannot be conducted as designed due to a collapse of the drainage tile adjacent to the pump station. Alternate method includes utilizing a large portable pump (being sourced).

Other: ACW locates: 2 locates were received. See Tracey for a master list. In response to the COVID-19 pandemic, Veolia staff has taken the following actions/protocol: Operators are conducting daily monitoring and documentation of their health and wellness. There are no group meetings or entry into private residences permitted. Operators have been assigned to specific work areas to avoid cross-contamination. Operators are to contact Township staff if they need to access shared spaces. Disinfection protocol is in place for vehicles and work areas and use of PPE as required.
