A drive-through clinic will be held Thursday, July 1, Canada Day, at the Grey Bruce Health Unit, 101 17th St. E. Owen Sound, **by appointment only**. Appointments for the Health Unit drive-through clinic can be made through the [Local Booking System](#). A limited number of appointments are available.

In order to book the following steps will need to be followed:

1. Select "**Community**" as vaccine site
2. Select "**Current eligible population**" as target population
3. Select "**Other Priority Population**" as reason for immunization
4. Select "**Other**" for priority group you belong to
5. Select "**Choose date**"
6. Select July 1 - it will then show the available appointment times (09:00 – 11:30).

In response to increased supplies of COVID-19 vaccine, the Grey Bruce is expanding existing clinics and adding new clinics. New pop-up clinics and last minute clinics will be added as resources permit.

The goal is to have everyone in Grey Bruce vaccinated by the end of July.

Modified Step 3 in Grey Bruce – Long-Term Care Homes

Acknowledging Grey Bruce continues to face a surge in COVID-19 Delta variant cases, the Grey Bruce Health Unit is directing all Long-Term Care Homes continue to operate with some measures from Step 2 guidance, with the purpose of increasing vaccine rates in staff and essential visitors. These measures will assist in the prevention of the spread of COVID-19 Delta variant and help to ensure the safety of some of the most vulnerable people in Grey and Bruce.

The Grey Bruce Health Unit, in consultation with the Ministry of Long-Term Care, will move towards full implementation of the provincial Step 3 in a staggered approach in order to mitigate risk. The implementation of the amendments will be reviewed regularly based on a risk assessment and any changes will be communicated as early as possible.

Instructions have gone out to all Long-Term Care Homes detailing the specific measures to be undertaken. [Modified Step 3 Long-Term Care Home Memo July 16, 2021](#). Key components are highlighted below.

At this time, surveillance testing will continue in all homes as per the practice under Step 2 guidance UNLESS the staff member/ Essential Care Giver / Visitor is fully immunized. Daily symptom screening of residents will change from twice daily to a minimum once daily. Of note, the updated definition of “fully immunized” now includes those receiving different COVID-19 vaccines for first and second doses.

Eye protection requirements will continue for all staff and essential visitors until homes achieve a full immunization rate.

Changes being implemented **with modifications**:

- Permitting all residents to go on day and overnight absences regardless of immunization status.
 - Restricted to those who are FULLY immunized at this time
- Returning to homes setting their own maximums for visitors based on operational capabilities with potential guidance on minimums.
 - Must be able to maintain 2M distance, based on homes capacity
- Permitting buffet and family style dining.
 - Family style dining permitted, but NOT buffet style.

Changes **ON HOLD**, at this time:

- Resumption of off-site group excursions for residents.
- Removing requirements/rules contingent on homes' immunization coverage rates.

Ontario entered Step Three of the [Roadmap to Reopen](#) on July 16, 2021. Grey Bruce moved to a modified Step 3 on July 16, 2021 with strong recommendations for the public instead of regulatory orders to contain the spread of COVID-19 Delta variant.

COVID-19 Vaccine and Your Business

COVID-19 within a business or workplace can cause significant impacts including exclusion of staff and possibly closure to the public, resulting in loss of revenue, and potential short and long term loss of your client base.

Having all employees fully vaccinated against COVID-19 is the most successful way to prevent COVID-19 from impacting your workplace.

The Grey Bruce Health Unit strongly recommends that all workplaces develop a vaccine policy. This policy should **strongly encourage** all eligible employees to get two doses of the vaccine, and allow employees time off to get the vaccine. The Health Unit recommends any businesses wanting to implement a more rigorous policy of mandatory vaccinations in their employees should seek legal counsel.

It is noteworthy that from July 1-15, 95% of COVID-19 cases in Grey Bruce were in individuals that were NOT fully vaccinated. The vaccine decreases a person's chance of getting the virus, as well as decreasing their likelihood of hospitalization or death.

Currently, provincial Step 3, requires all places of business to adhere to public health measures and advice and to screen ALL employees prior to starting a shift at work. All places of business must also screen their patrons. For details, please visit:

Charges Pending Related to COVID-19 Outbreaks from Local Parties

Party hosts and attendees who fail to follow either the [Provincial Regulations](#) and/or the local Section 22 [MOH Class Order](#) of April 16, 2021, currently in place from the Grey Bruce Medical Officer of Health, are liable for charges. The Grey Bruce Health Unit is working on pursuing charges against individuals who are identified as not in compliance and/or obstructing the public health investigation.

Two recent parties in the local area with high numbers in attendance resulted in outbreaks with significant additional cases, infecting the attendees as well as their families and close contacts.

Although many teens and young adults who attended these parties were forthcoming with information, some withheld information or provided incomplete information. This hindering of our investigators negatively affected our ability to reach high-risk individuals in a timely manner, potentially allowing for more spread of the virus.

Charges will be brought against those individuals that willfully obstruct a case and contact investigation, such by providing information known to be false or withholding information. Working through the case investigation process, it becomes evident as to the identity of those that have been withholding or providing false information.

Persons who willfully defy local directives and provincial regulations can face fines. For non-compliance with the Grey Bruce Health Unit's Case and Contact Management Team's direction and/or obstruction of our investigations, the fine, upon conviction, can be up to \$5000 a day. This fine can be levied retroactive to the day the initial non-disclosure occurred.

200,000 COVID-19 vaccine doses surpassed in Grey Bruce

As the Province enters [step 3 of reopening](#), and Grey Bruce enters a [modified step 3](#) of reopening, the Grey Bruce Health Unit is happy to announce a major milestone in terms of vaccination success locally. We have surpassed giving over 200,000 doses of the COVID-19 vaccine locally (up from about 140,000 last week of June). The majority of COVID-19 infections and deaths are among unvaccinated people. Vaccine is the best way to control the spread of the COVID-19 virus, especially with the recent surge of the Delta Variant. Get your vaccine.

As of end of day, on July 15th, **202,213** total doses had been given locally. That translates in to:

- **74% of the eligible population with 1 dose of vaccine** (up from 70% last week of June)
- **61% of the eligible population with 2 doses of the vaccine** (up from 24% last week of June)

While this milestone is a success, we have a couple of weeks left to ramp down the mass immunization campaign in the large Hockey Hubs, and to start ramping up the targeted immunization campaign. At the end of July, all large vaccine Hubs will be disassembled to return to community functions. Please attend a Hub to get your second dose now. Please remember, if you have an appointment to a Hub clinic in August or September, they will be cancelled.

As mass vaccination is completed and the Hubs are closed, targeted immunization strategies, utilized for the past weeks, will be the focus of our efforts after August 1, 2021, including:

- Pop-up mobile clinics (e.g. at rooming homes, unregistered shelters, ...)
- Drive-through clinics (e.g. at gyms, hockey games, malls...)
- First Nations clinics (at both Nawash and Saugeen First Nations)
- Hospital delivery (through ER as well as inpatient)
- Workplace clinics

The traditional vaccine system will also continue to play a major role in increasing coverage and providing a long term vaccine rollout:

- Pharmacy (35 locations)

- Primary Care clinics (12 locations)
- Health unit vaccine clinic, school vaccinations

Public Assistance Request Dog Bite - Clarksburg

The Grey Bruce Health Unit is seeking assistance from the public in finding the owner of a dog involved in a biting incident that occurred in Clarksburg. On Sunday, July 18, at approximately 11:36am, a man was bitten by a black, large breed dog with skinny ears and a large tail. The dog breed resembled Rottweiler or a Doberman mix. Incident occurred on a section of Georgian Trail approximately 250 meters north of Grey County Road 40. A couple was walking a dog. Man was wearing glasses, dark baseball cap, black shirt and shorts. Woman was dressed in white.

Staff of the Grey Bruce Health Unit need to confirm the dog is not infectious with rabies. By verifying the health of the dog, the victim can avoid receiving the post-exposure rabies treatment. Let's Talk to Our Kids - COVID-19 Cases in Teens and Young Adults

The current active COVID-19 Delta cases in Grey Bruce is predominantly in the teen and young adult population. Of the 132 current active cases, 76 are 10 to 29 years, with the vast majority, 95 per cent, not fully vaccinated. This results in the ongoing spread of the virus to their friends and other family members, including vulnerable grandparents.

Parents are especially asked to remind their children to consider the devastating effect the virus can have should it spread to other family members, such as grandparents who are most vulnerable. Parents are strongly encouraged to have their teens and young adult children get the COVID-19 vaccine.

Young adults are strongly encouraged to get the COVID-19 vaccine as the cases continue to occur in people who are unvaccinated.

We understand young people need to have fun activities especially after this long restrictions. We strongly encourage them to consider limiting the number of activities in which they take part per day. And to the best of their ability, to limit the number of friends and people they interact with. Interacting with 5 people per day is fine, but interacting with 20 people per day is too much. Self-limiting their participation can reduce the chances to spread the virus.

This means fewer parties, smaller gatherings and always following to the 3 W's - Wash hands frequently, Watch distance (ideally 6ft), and Wear face covering correctly, and the 2 A's - Avoid Crowds and Arrange for outdoor activities instead of indoors whenever possible.

Having everyone in the family who are eligible fully vaccinated against COVID-19 is the most successful way to prevent COVID-19. There are Drop-In Vaccine Clinics every day in Grey Bruce. [Vaccine Schedule](#)

Table 1. Vaccination status at the time of symptom onset, COVID-19 cases reported in Grey Bruce Jul 1-15, 2021

Vaccination Status	Case Count	% of total
Fully Vaccinated Cases	13	4.4%
Not Fully Vaccinated Cases	285	95.6%

Table 2. Vaccination status at the time of symptom onset, Grey Bruce COVID-19 cases admitted to hospital Jul 1-15, 2021 *

Vaccination Status	Case Count	% of total
Fully Vaccinated Cases	2	7.7%
Not Fully Vaccinated Cases	24	92.3%

Table 3. Vaccination status at the time of symptom onset, Grey Bruce COVID-19 cases admitted to ICU Jul 1-15, 2021 *

Vaccination Status	Case Count
Fully Vaccinated Cases	1
Not Fully Vaccinated Cases	7

Fully Vaccinated Cases are defined as individuals who has their complete two doses of vaccine and had a duration of 14 days pass following the second dose.

Not Fully Vaccinated Cases received no doses, or only one dose, or symptom onset less than 14 days after the second dose.

Notes: Cases include confirmed COVID-19 cases where GBHU is the investigation HU reported between Jul 1 and 15 2021. Hospitalized cases include those with an intervention date starting between July 1 and 15. Vaccination status is based on a match between a client's health card number in CCM and COVax. 15 cases missing HCN were excluded from Table 1 and the incidence rate calculations. Vaccination status is defined using the following categories 'Fully vaccinated' and 'Not Fully Vaccinated'.

*Sample size too small to provide reliable conclusions. Larger sample size (federal/provincial) confirms vaccine provides more significant protection against hospitalization.

Protect Family and Friends - Become Their Vaccine Ambassador

Over 100,000 people in Grey Bruce chose the benefit of the protection from two doses of the COVID vaccine. This was an informed decision. The Grey Bruce Health Unit asks for help from those who have received the vaccine. We ask you to become ambassadors by sharing your life experience and pass on the basis of your decision to an unvaccinated person you know to increase their confidence in the vaccine.

Would you please ask younger family and friends (12 to 45-year-olds) to spend a few minutes per day learning [about COVID-19 vaccines](#). If given motivation from family and friends and credible information, we are confident this will put them in a better position to make the best decision for themselves, their families, and the community.

The mass vaccination strategy in Grey Bruce has been successful in achieving its goal and is ramping down. We have reached the vaccine coverage target for the regular strains of COVID-19. However, the highly contagious Delta is now the dominant variant requiring a higher vaccine target of 90% coverage. In response, the Grey Bruce Health Unit and vaccine partners are ramping up the targeted strategy with pop-ups and drive-through clinics.

The Grey Bruce Health Unit works with Mayors, CAOs, and municipalities to deliver local pop-up and drive-through clinics across Grey Bruce. Our success is a direct reflection of the work and promotion dedicated by the town. Please advise family and friends they can find the vaccine where they live, work and play. Access is simplified and more available with upcoming clinics including:

- Malls/Shopping Areas
- Gyms
- Clubs/Bars
- Movie Theatres
- Markets
- Popular Parks, hiking trails
- Skate Parks or similar
- Popular youth "hang-outs"
- Big Box Stores
- Sporting Events/Racing Event
- Any other suggested area from your residents (especially the youth)
