## BY-LAW

### 2021-105

#### Being a By-law to Enter into an Agreement for the Harvesting of Timber at the Lucknow Wastewater Treatment Facility

---

**WHEREAS** the Municipal Act S.O. 2001, c 25, Section 5(1), as amended, provides that the powers of a municipal corporation are to be exercised by its Council;

**AND WHEREAS** the Municipal Act S.O. 2001, c 25, Section 5(3), as amended, provides that a municipal power, including a municipality's capacity rights, powers and privileges under Section 9; shall be exercised by By-Law;

**AND WHEREAS** The Council for the Corporation of the Township of Huron-Kinloss deems it expedient to enter into an agreement with 1567202 Ontario Inc. (operating as RJ Tree Farms) at the Lucknow Wastewater Treatment Facility Property in the Township of Huron-Kinloss;

**NOW THEREFORE** the Council of The Corporation of the Township of Huron-Kinloss enacts as follows:

- 1.0 That The Corporation of the Township of Huron-Kinloss Council hereby approves entering into a Tree Harvesting Agreement with 1567202 Ontario Inc. (operating as RJ Tree Farms) which is attached as Schedule "A" and forms part of this By-Law.
- 2.0 That the Mayor and Clerk are hereby authorized to sign on behalf of the Council for The Corporation of the Township of Huron-Kinloss, any contracts and other documents required to authorize the agreement to proceed, and to affix the corporate seal of the Township of Huron-Kinloss.
- 3.0 This By-law shall come into full force and effect upon final passage.
- 4.0 This By-law may be cited as the "2021 Timber Harvesting Agreement By-Law"
