Mayor and Council,

On March 23, 2020 at 4:15PM, an emergency bulletin was published declaring a State of Emergency for this township. First paragraph of the bulletin reads as follows:

*"Declarations of emergency are made under the Emergency Management and Civil Protection Act when an emergency requires immediate action to prevent, reduce or mitigate a danger of major proportions."*

According to the Grey Bruce Health Unit, Huron Kinloss has not recorded a single covid-19 positive case since August 7, 2021. All 73 cases recorded in this township have recovered.

What danger of major proportions are we preventing?  
What is this township's plan to lift the emergency declaration?

Part I - Freedom Discrimination

### **Services**

1 Every person has a right to equal treatment with respect to services, goods and facilities, without discrimination because of race, ancestry, place of origin, colour, ethnic origin, citizenship, creed, sex, sexual orientation, gender identity, gender expression, age, marital status, family status or disability. R.S.O. 1990, c. H.19, s. 1; 1999, c. 6, s. 28 (1); 2001, c. 32, s. 27 (1); 2005, c. 5, s. 32 (1); 2012, c. 7, s. 1.

## **PART III**

### **CONSENT CONCERNING PERSONAL HEALTH INFORMATION**

## General

### Elements of consent

**18** (1) If this Act or any other Act requires the consent of an individual for the collection, use or disclosure of personal health information by a health information custodian, the consent,

- (a) must be a consent of the individual;
- (b) must be knowledgeable;
- (c) must relate to the information; and
- (d) must not be obtained through deception or coercion. 2004, c. 3, Sched. A, [s. 18 \(1\)](#).

### Implied consent

(2) Subject to subsection (3), a consent to the collection, use or disclosure of personal health information about an individual may be express or implied. 2004, c. 3, Sched. A, [s. 18 \(2\)](#).

I will remind this Mayor and Council that any policy established by Public Health does not supersede the law.

I hope this council recognizes the trend of these events and puts an immediate halt to these unlawful policies at our community centre.

Lastly, I have filed a complaint with the Human Rights Tribunal against this township. Namely, Mitch Twolan, Mayor and Mike Fair, Director of Community Services.
