Financial Impacts:

Follow-up from the discussion in relation to the Financial Impacts detailed in report # FIRE2021-09-18 – Capitol Budget items from the Sept 08 Committee of the Whole Meeting: In the original report it was discussed that certain capitol items that where budgeted for were not purchased and the funding was re allocated to new vehicle rescue equipment. This was a discussion and request made by the Officers group at the Ripley-Huron Station. The equipment (Fire Hose and Coveralls) that was originally budgeted for was determined to not be needed in this budget cycle. We had a surplus of Fire Hose at the Fire Hall and the Medical Coveralls where in response to certain COVID dress down procedures that existed at the time of budget preparation but are no longer a procedural issue. Instead of purchasing a second set of coveralls for each person we implemented disposable medical gowns in its place.
