# **Municipal Innovation Council Update**

The Municipal Innovation Council (MIC) has numerous projects underway that will positively impact the quality of life for visitors and residents of its participating member municipalities. Projects include implementing an advanced digital mapping solution for natural disaster mitigation and climate change impact monitoring, developing a Smart Beach infrastructure program that enhances swimmer safety along Lake Huron shoreline, developing shared IT service solutions amongst member municipalities, and advancing applied research projects focusing on downtown revitalization, municipal procurement, organizational development, municipal service analysis, and IT business analysis.

# Subdivision in Port Elgin

The Planning and Development Committee approved a 50-lot residential Plan of Subdivision, known as the Woodlands Subdivision, on a 10.65-hectare parcel of land in Port Elgin. The proposal was brought forward by Snyder Development Corp Inc. and a Public Meeting was held on June 21, 2021. The subdivision is to be fully serviced by both municipal water and sewer, within Port Elgin's built-up area. The subdivision will result in 60 new dwellings, ten of which will be secondary dwellings constructed within a single detached dwelling. By providing active transportation facilities and connecting to the Town's broader recreational trail network, this subdivision is aligned with the County's Connecting and Communities Guiding Principles.

# Ag-land Severance on Bruce Road 23 near Kincardine

The Planning and Development Committee approved the severance of a 50 ha parcel on Bruce Road 23, north of Kincardine. The retained parcel is approximately 173.66 ha. The lands, located on the east side of Bruce Road 23 between Concession Road 5 and Concession Road 7, are owned by H J Sieber Farms Ltd.. Both the severed and retained parcels are vacant and will continue to be used for alfalfa hay production. The severance is strongly aligned with the County's Agricultural Guiding Principle, as the severed and retained lots are of an appropriate size and farming will continue on the lands. There will be no loss of agricultural production resulting from the severance.

## Plan the Bruce: Good Growth

The Planning and Development Committee endorsed the Plan the Bruce: Good Growth Discussion Paper as a foundation for developing policies in the new Official Plan. Recommended directions for growth management include managing the municipal servicing infrastructure, maintaining a distinct settlement area structure, planning for permanent and seasonal population growth, and develop a plan monitoring and evaluation framework. Residential themes include updating County-wide housing projections, defining a regional market area, and planning for residential intensification. Other non-residential themes focus on consistent employment area delineations, future employment lands development, well adapted employment lands, employment-supportive uses in employment areas, broad market choice on employment lands, intensification of employment lands within urban settlement areas, employment lands protection from conversion to non-employment uses, agriculture-related industrial and commercial uses on agricultural lands, mitigating land-use compatibility conflicts in urban employment areas, office development in downtowns, and a commercial land needs study that addresses the retail requirements and commercial structure. ## **Summer Company 2021**

Summer Company is funded by the Province of Ontario and provides students between the ages of 15 to 29 the opportunity to start and run their own summer business. It inspires, supports, and empowers youth to create their own summer employment opportunity and a pathway to success. Participants receive business training, mentorship, and up to \$3,000 to start and run a summer business in Bruce County. This year's participants included:

Katie Franklin (Franklin's Produce, Kincardine) - cultivates and sells fresh produce and flowers.

Jonny Pickett (8 x 8 Beach Apparel, Wiarton) - designs and sells beach volleyball apparel.

Leyah Smith (Black Excellence Art, Formosa) - designs and sells digital art printed on various gift items.

Sadie Rhan (The Ordinary Orchid, Paisley) - designs and sells decorative stickers that are 100% recyclable.

# **Bruce County Official Plan Project Update**

Over the last few months, through work on the Plan the Bruce project, Council has received Interim Reports and endorsed Discussion Papers around several of the new Official Plan's Guiding Principles. The Guiding Principles in progress focus on Homes, Communities, Good Growth, Agriculture, Natural Legacy, Business, Heritage, and Connecting (which builds on the Transportation Master Plan). The work to advance the Guiding Principles has been building a solid foundation for the new Official Plan. With the recent awarding of the Official Plan consulting assignment to the consulting firm WSP Canada Ltd. (WSP), the initial project management and detailed workplan design for the Official Plan has begun. The workplan targets a new Official Plan to be submitted for County Council to consider adoption in mid-2022. Explore more at <u>Plan the Bruce</u>.

## Wind Project Agreement

The Transportation & Environmental Services Committee approved the Assignment and Assumption Agreement between Quixote One Wind Energy Corp, 2825411 Ontario Inc., and Bruce County. On February 5, 2015, Bruce County and Quixote One Wind Energy Corp executed a Road Use Agreement. Now, Quixote One Wind Energy Corp intends to sell their Wind Project north of Kincardine to 2825411 Ontario Inc. The Assignment and Assumption Agreement transfers Quixote's contractual rights and obligations to 2825411 Ontario Inc. This project consists of one wind turbine with above ground transmission lines and one access on the County Road right of way.

# Capital Projects Status Report – September 2021



# Updates to COVID-19 Guidance: Considerations for Antigen Point-of-Care Testing (POCT)

Several updates have been recently made to COVID-19 Guidance: Considerations for Antigen Point-of-Care Testing (POCT).

These include:

- Antigen POCT is not recommended for individuals who are fully vaccinated.
- Frequency of antigen POCT of at least one time per week, and up to 2-3 times per week.
- Confirmatory testing can be done using a rapid molecular test (e.g., ID NOW) when rapid molecular tests can be reported into the Ontario Laboratories Information System.
- Self-screening can be done at home for organizations performing on-site workplace antigen screening programs. Waste generated from at-home rapid antigen screening is exempt from guidance for disposal of test kits.

Additional changes have also been made including reduced eligibility for asymptomatic lab-based PCR testing of targeted groups. For more information please visit the **website**.



# IMPORTANT ANNOUNCEMENT FOR EMPLOYERS

Good afternoon,

In response to the COVID-19 pandemic, the Ontario government made a **regulation** that changed certain *Employment Standards Act* (ESA) rules during

the "COVID-19 period." This regulation has been amended to extend the COVID-19 period to January 1, 2022.

#### During the COVID-19 period (March 1, 2020 to January 1, 2022):

- A non-unionized employee whose employer has temporarily reduced or temporarily eliminated their hours of work for reasons related to COVID-19 is deemed to be on a job-protected infectious disease emergency leave under the ESA.
- A non-unionized employee is **not** considered to be laid off under the ESA if their employer temporarily reduces or temporarily eliminates their hours of work or wages for reasons related to COVID-19.

A non-unionized employee is **not** considered to be constructively dismissed under the ESA if their employer temporarily reduces or temporarily eliminates their hours of work or wages for reasons related to COVID-19.

#### Beginning on January 2, 2022:

- Non-unionized employees will no longer be deemed to be on infectious disease emergency leave.
- The ESA's regular rules around constructive dismissal will resume. This
  means a significant reduction or elimination of an employee's hours of work
  or wages may be considered a constructive dismissal, even if it was done
  for reasons related to COVID-19.
- The ESA's regular rules around temporary layoff will also resume. For practical purposes, a non-unionized employee's temporary layoff clock resets on January 2, 2022.



**Honouring survivors:** On September 30 in Canada, we observe National Day for Truth and Reconciliation, also known as Orange Shirt Day, to honour Canada's residential-school survivors, their families and communities.

The <u>Truth and Reconciliation Commission</u> in 2008-15 found that sexual, physical and mental abuse of Indigenous children at residential schools created life-long and intergenerational trauma. Designed to kill Indigenous language and culture, the schools broke apart families, delivered deliberately poor education, increased rates of chronic and infectious diseases, and caused distress, depression, addiction and suicides. In 2021, hundreds of bodies of children were discovered at former school grounds, in unmarked graves.

We all have a role to play in reconciliation. At Ontario Power Generation (OPG), we are committed to building and growing long-term, mutually beneficial working relationships with Indigenous communities near our operations. In the Bruce area, OPG has agreements and engages regularly with Saugeen Ojibway Nation, Historic Saugeen Métis and Métis Nation of Ontario. Our relationships are developed on a foundation of respect for the languages, customs, cultural institutions and rights of Indigenous communities in Ontario. Our goal is to build and preserve openness, transparency and trust.

#### **Around Ontario and beyond:**

- Wonders of Helium-3: Laurentis Energy Partners, an OPG subsidiary, this week announced production of <a href="Helium-3">Helium-3</a>, a rare and valuable isotope used in medical imaging, border security, quantum computing and neutron research. Laurentis extracts the gas from tritium containers at the Darlington Nuclear Generating Station, then ships it through a distributor to hospitals, researchers and other end-users globally. Laurentis has offices in the Toronto and Hamilton region, New Brunswick, Romania and also here in Bruce County, where it supports the nuclear industry with field services such as inspections.
- **Nuclear for Net-Zero:** Today is the conclusion of the Canadian Nuclear Association's 2021 conference, which this year was themed "Leading Innovations to Achieve a Net-Zero World." Speakers from across Canada addressed the vital role of nuclear in helping to <u>address climate change</u>. Ontario Energy Minister Todd Smith also described this province as "ready to become an isotope superpower," adding to its production of medical isotopes at CANDU stations for use around the world. While the conference was held online to ensure safety amid the ongoing pandemic, many participants expressed hopes of returning safely to an in-person meeting in 2022.

• **Breaking barriers:** Women in OPG's Advanced Inspection and Maintenance (AIM) division broke new ground with an <u>all-female dive</u> in August, one of the first in the company's history. Samantha Hood, Elizabeth Cole, Drew Burstahler and Jaimie Dack conducted underwater maintenance on Pickering Nuclear's Fish Diversion System, a 600-metre net that prevents fish from entering the plant's cooling systems.

# Ontario Investing \$100 Million to Help Tourism Sector Rebound From COVID-19

TORONTO — The Ontario government is investing \$100 million through the new Tourism Recovery Program to help stabilize the province's tourism industry as it recovers from the impacts of COVID-19. The program will help for-profit tourism businesses in the attraction, accommodation, and leisure travel sectors protect critical jobs in communities across the province and help them prepare to reopen and safely welcome back visitors.

"The last 18-months of the pandemic have been the most challenging Ontario's tourism industry has ever faced. Previously an economic powerhouse for the province, tourism has been hit by the triple threat that COVID-19 represents – a health, economic and social crisis," said Minister MacLeod. "This critical funding will help support regionally significant businesses, while protecting jobs in communities that rely on the tourism industry."

Businesses that help drive employment and visitors to their regions are eligible to apply for the Ontario Tourism Recovery Program. These organizations are key employers and tourism generators in all regions of the province. Eligible tourism businesses include inns and lodges, boat tours, ski centres, live performance venues, cinemas, drive-in theatres, and amusement and water parks.

The Ontario Tourism Recovery Program will support tourism businesses that have experienced a loss of at least 50 per cent of eligible revenue in 2020-21 compared to 2019. Program funding will help successful applicants prepare to reopen safely, develop innovative tourism products, retain and create tourism jobs, and support tourism recovery in their region and throughout Ontario.

Successful recipients will have the flexibility to apply funds to any eligible expenses and do what makes the most sense for their businesses. Expenses could include reopening and operating costs such as staff salaries and maintenance, health and safety measures for visitors and workers, tourism product and experience development, or marketing.

Applications for this program will open on October 13, 2021.


#### **Quick Facts**

- This investment is part of the 2021 Budget, Ontario's Action Plan:
   Protecting People's Health & Our Economy. Support from the Ontario government for the tourism, culture, sports, recreation and heritage industries since the start of the pandemic now totals \$625 million.
- Tourism plays a critical role in the Ontario economy. Prior to the pandemic, tourism generated more than \$36 billion in economic activity and supported hundreds of thousands of jobs in Ontario.
- According to Statistics Canada's Labour Force Survey, tourism-related industries experienced a loss of 94,000 jobs between August 2019 and August 2021.

The building permits we receive from municipalities are an important trigger for us to review changes to a property — and the information in these permits provides valuable input for our assessments.

They also provide information and insight in the changes to Ontario's property landscape and how homeowners are investing in their properties.

#### Stay-at-home = spend on home



More than 106,000 Ontario homeowners obtained residential building permits in 2020 – a 9% increase from the year before, with permits for home improvements jumping by 15%.

#### MPAC's role in the building permit process

Municipalities rely on MPAC to take their building permits and plans and turn them into assessment. From there, municipalities tax property owners based on those assessments – so the sooner MPAC can deliver assessments, the sooner municipalities can realize new revenue.

MPAC is working collaboratively with the municipal sector to support digital permitting in Ontario. We are the only organization with a data set of all building permits in Ontario, and our understanding of this data gives us a unique perspective on ways to modernize its collection and exchange to support our municipal partners.

Given what we know about the e-permitting providers operating in Ontario, one of the collaborations MPAC is participating in is with AMO's business services arm, LAS. Together, AMO and MPAC are working to identify a preferred e-permitting vendor for Ontario municipalities through a request for proposals (RFP) process.

The RFP is to identify one or more e-permitting solutions that are scalable to the variety of sizes of municipal governments across Ontario. MPAC believes that AMO's approach will help streamline the adoption of e-permitting for municipalities, as they can leverage AMO's proven ability to negotiate and procure solutions for the sector.

The RFP committee is comprised of representatives from AMO, LAS, MPAC, the Ontario Building Officials Association, and the Municipal Information Systems Association. MPAC looks forward to sharing the results once the process is completed and will work with AMO to pilot the solution with a number of interested municipalities.

Beyond the collaboration with AMO, MPAC remains technology agnostic in what e-permitting solution municipalities may select. That is why MPAC has been working with several e-permitting providers to integrate their systems in to MPAC's systems. The goal is to work with all e-permitting providers operating in Ontario to electronically share municipal building permits and plans, making it easier for their municipal users to transfer it to that data to MPAC.

The County of Bruce has now completed the Master Transportation Plan (MTP) Study. The purpose of this MTP is to create a safe and reliable transportation system within the County that meets the ground transportation needs of all persons and businesses to the year 2035. This MTP Study forms the basis to guide future transportation decisions for the development of County roads and trails, cycling facilities, as well as the County's role in public transit services.

#### The Process

The Study was carried out in accordance with Phase 1 and 2 of the master plan process outlined in the Municipal Class Environmental Assessment (October 2000, as amended in 2007 and 2011, 2015), which is approved under the Ontario Environmental Assessment Act.

The MTP Study identified and defined existing constraints as well as opportunities to evaluate solutions in order to provide a safe, efficient, environmentally and economically sustainable, transportation network. The recommendations of the MTP study were approved by the Bruce County Transportation & Environmental Services Committee on July 8, 2021.

A Master Plan Report (MPR) has been prepared to document the planning and decision-making process for this study. 



# Bruce Power receives regulatory approval for new lifesaving medical isotope production

*TIVERTON, ONTARIO* – September 24, 2021 – Bruce Power has received approval from the Canadian Nuclear Safety Commission (CNSC) to take the next step forward for new isotope production becoming the first power reactor globally to commercially produce Lutetium-177, an innovative therapeutic isotope used in the treatment of prostate cancer and neuroendocrine tumors.

"This Project is an innovative partnership between Bruce Power, IsoGen, Saugeen Ojibway Nation (SON) and ITM and is a game changer for the supply of medical isotopes and the global medical community in the fight against cancer," said James Scongack, Bruce Power Chief Development Officer and EVP Operational Services. "This is another important step forward to utilize our CANDU reactors to provide a new large-scale capacity for production in the medical isotope supply chain, cementing Canada's place as a global

isotope superpower."

Isogen is a joint venture between Framatome and Kinectrics to enable the use of CANDU reactors to produce medical isotopes needed to treat and diagnose patients with serious diseases world-wide.

"The Framatome team conducted extensive research and development in Canada and modified German technology for use in a CANDU reactor, which resulted in the first Isotope Production System in a power reactor for commercial production of therapeutic medical isotopes," said Curtis Van Cleve, President and CEO of Framatome Canada Ltd. "We applaud our partners at Bruce Power for their commitment to innovation that supports the continuous production of both electricity and medical isotopes, and to harnessing the therapeutic power of nuclear energy."

The Isotope Production System (IPS), designed and manufactured by Isogen, will be used to produce Lutetium-177, an isotope used in nuclear medicines that allows for targeted and precise treatments, destroying cancer cells while limiting damage to surrounding healthy tissue and organs. The irradiated Ytterbium targets obtained from the IPS will be processed at ITM premises, where the highly pure no-carrier-added (n.c.a.) Lutetium-177 will be produced in pharmaceutical quality. N.c.a. Lutetium-177 will be marketed globally by ITM under the brand name EndolucinBeta® as well as leveraged for clinical supply to advance the company's own pipeline. ITM is a German based leading radiopharmaceutical biotech company focused on the development, production and global supply of medical radioisotopes and radiopharmaceuticals.

"The license granted by CNSC today marks a critical milestone for Isogen on our mission to provide lifesaving medical isotopes to the world," said David Harris, CEO of Kinectrics. "This approval showcases the advantages of bringing together the significant investments and capabilities of the partners to advance the technology, and develop the safety, engineering and licensing packages necessary to introduce such a cutting-edge technology in a safe and reliable manner without impact to normal reactor operation."

"It is great to see the progression in the installation of the Isotope Production System, which provides us with an additional reliable source to increase the scalability of our n.c.a. Lutetium-177 production for global supply as well as the further clinical development of our broad pipeline," commented Steffen Schuster, CEO of ITM. "We look forward to leveraging

our long-term partnership with Bruce Power to deliver Targeted Radionuclide Therapy to cancer patients worldwide."

Bruce Power's collaboration with Saugeen Ojibway Nation (SON) will see the partners jointly marketing new isotopes in support of the global fight against cancer while also working together in creating new economic opportunities within the SON territory by establishing new isotope infrastructure.

"It's very exciting times for SON as we move forward to the next phase of the Isotope project with Bruce Power," said Chief Lester Anoquot, Chippewas of Saugeen First Nation. "Many members of our community have been impacted by cancer in some way. We are proud to play a leadership role in the global fight against cancer, while building economic opportunities in our community."

The partnership, which includes an equity stake and revenue-sharing model for SON, is named Gamzook'aamin aakoziwin, which means 'We are Teaming up on the Sickness' in the traditional Anishinaabe language.

"The Gamzook'aamin aakoziwin project will positively impact people worldwide, well beyond the borders of our community," said Chief Victoria Smith, Chippewas of Nawash Unceded First Nation. "This project is a groundbreaking development in the fight against cancer, and represents a positive step forward for the global medical community."

The approved project will expand Bruce Power's established isotope production, and will solidify the company as an integral producer of critical medical isotopes increasingly being used in innovative nuclear medicine applications.

"Ontario continues to position itself as a world leader in the production of life-saving medical isotopes," said Energy Minister Todd Smith. "The innovation of companies like Bruce Power and its partners is critical to ensuring increased capacity of isotope production to improve global access to these essential tools in the fight against cancer. Today's announcement is a big step forward in furthering the goal of long-term, sustainable, and flexible production of medical isotopes at the Bruce Power site."

Bruce Power is one of the world's largest producers of Cobalt-60 through its partnership with Nordion, used in the sterilization of single use medical equipment and in transformative cancer treatments like the Gamma Knife.

"Thanks to the investments being made into the Bruce Power site today we can look to the future and realize a vital role in providing life-saving medical isotopes to the world, while also supplying clean, reliable and low-cost electricity to Ontario, growing the economy and fostering innovation for decades to come," said Lisa Thompson, MPP for Huron-Bruce.

Bill Walker, MPP for Bruce-Grey-Owen Sound, also offered his support and congratulations.

"The potential for growth in the isotope space provides an invaluable opportunity to leverage Ontario's established nuclear supply chain that has developed over the past several years and is recognized as a leader around the world in isotope innovation, development and production," said Walker. "Most importantly isotopes are making a positive difference in people's lives every day and I am proud to be a champion of the nuclear industry."

The work to install the Isotope Production System is a part of the ongoing Life-Extension Program at the Bruce Power site, which began in 2016 and remains on track.

As the commissioning process continues there will be additional regulatory hold points to allow CNSC staff to confirm operational readiness of the Isotope Production System (IPS) prior to the start of Lu-177 production. Bruce Power will finalize documentation and CNSC staff will review commissioning test results to verify the IPS meets its design and safety analyses requirements.

Update: Kindergarten-Grade 12 and Postsecondary Education Standards Initial Recommendations Posted for Public Feedback

Update: The timeline for public feedback for the K-12 Education initial recommendations has been extended until November 1, 2021 (see below for updated language)

Standards Development Committees are responsible for developing and reviewing accessibility standards in Ontario. These accessibility standards help achieve the purpose of the *Accessibility for Ontarians with Disabilities Act*, 2005 (AODA), as Ontario moves forward on its journey to create a more accessible and inclusive province.

The Kindergarten-Gr. 12 (K-12) and Postsecondary Education (PSE) Standards Development Committees (Committees) were tasked with developing recommendations for proposed accessibility in publicly funded K-12 schools and PSE institutions. Both Committees are comprised of people with disabilities, representatives from disability organizations, and education sector experts.

The Government of Ontario is pleased to announce that the K-12 and PSE Committees' Initial Recommendation Reports have been posted online for public comment.
