### BY-LAW

2021-116

Being a By-law to Enter into an Agreement to Transfer Ownership of Two

(2) Municipally Owned Utility Poles Located on Havelock St.

**WHEREAS** the Municipal Act S.O. 2001, c 25, Section 5(1), as amended, provides that the powers of a municipal corporation are to be exercised by its Council;

**AND WHEREAS** the Municipal Act S.O. 2001, c 25, Section 5(3), as amended, provides that a municipal power, including a municipality's capacity rights, powers and privileges under Section 9; shall be exercised by By-Law;

**AND WHEREAS** The Council for the Corporation of the Township of Huron-Kinloss deems it expedient to enter into an agreement to transfer ownership of two (2) municipally owned utility poles located on Havelock St., Lucknow geographic Township of Kinloss to Westario Power Ltd.;

**NOW THEREFORE** the Council of The Corporation of the Township of Huron-Kinloss enacts as follows:

- 1.0 That The Corporation of the Township of Huron-Kinloss Council hereby approves entering into an agreement to transfer ownership of two (2) hydro poles on Havelock St., Lucknow to Westario Power Ltd. which is attached as Schedule "A" and forms part of this By-Law.
- 2.0 That the Mayor and Clerk are hereby authorized to sign on behalf of the Council for The Corporation of the Township of Huron-Kinloss, any contracts and other documents required to authorize the agreement to proceed, and to affix the corporate seal of the Township of Huron-Kinloss.
- 3.0 This By-law shall come into full force and effect upon final passage.
- 4.0 This By-law may be cited as the "Westario Power Ltd. Hydro Pole Transfer Agreement By-Law"

#### **AGREEMENT**

#### **BETWEEN**

#### WESTARIO POWER INC (Westario)

and

#### THE CORPORATION OF THE TOWNSHIP OF HURON-KINLOSS (Huron-Kinloss)

**WHEREAS** Huron-Kinloss is presently the owner of two existing poles referred to as EP2 and EP3 on schedule A hereto; (the poles).


**AND WHEREAS** the parties agree that Westario will assume ownership of the poles subject to certain terms and conditions set out hereafter.

#### NOW THEREFORE the parties agree as follows:

- Full consideration for this transaction is the sum of one dollar, paid by Westario to Huron-Kinloss and other good and valid consideration, the receipt of which is hereby acknowledged by Huron-Kinloss.
- 2. Upon execution of this document by both parties, Huron-Kinloss hereby transfers all right, title and interest in the poles to Westario.
- 3. Westario shall in its sole discretion be financially responsible for all maintenance, servicing and replacement of these poles hereafter.
- Huron-Kinloss will continue to operate, maintain, replace and be fully responsible for the streetlight attachments on the poles, including assuming any and all liability with respect to same.
- Westario may incorporate the poles into their electrical distribution system and may use the poles, and attach such equipment as Westario, in its sole discretion, deems reasonable and necessary for this purpose.
- 6. Huron-Kinloss hereby grants and acknowledges to Westario its right to an easement in perpetuity over the lands that it owns upon which the poles are located, and any adjacent lands, both prescriptive and ancillary, in order that Westario may maintain, replace, service, and operate the poles as a part of its electrical distribution system.
- This offer by Westario shall be open for acceptance by Huron-Kinloss by no later than 4:30 PM Friday, October 29, 2021 failing which it shall become null and void.
- 8. This Agreement including any Schedule attached hereto, shall constitute the entire Agreement between Purchasers and Vendor. There is no representation, warranty, collateral agreement or condition, which affects this Agreement other than as expressed herein. This Agreement shall be read with all changes of gender or number required by the context.
