1. Call to Order

Deputy Mayor Murray called the meeting to order at 7:00 p.m.

4. Delegations

4.1 Ontario Power Generation - Update to Municipal Council

Fred Kuntz, Senior Manager, Corporate Relations OPG, and Nuala Zietsma, OPG provided an update on Ontario Power Generation - Western Site Operations.

Mr. Kuntz explained that OPG has gone through a re-naming for OPG Nuclear Waste Management to Nuclear Sustainability Services to move away from the term "waste" as some of the by-products are not waste but can be valuable, this new name better reflects the mission to reduce their environmental footprint and embrace the three R's: Reduce, reuse, recycle through a multi-year program. This aligns with OPG's Climate Change Plan stating that nuclear is clean energy and vital to achieving net-zero goals.

Regarding operations, he noted that the western site has a strong safety performance with a 10 year continuous without a lost-time accident and through the pandemic were able to continue to keep operations going to supply electricity. In 2021, upgrades were performed to the incinerator and used storage buildings No. 5 and 6 were completed. OPG received Gold Certification from the Wildlife Habitat Council for biodiversity programs which they are very proud of.

OPG is planning to construct a new "Western Clean-Energy Sorting & Recycling" facility, at Bruce Energy Centre in Kincardine, with 42,000 square feet, tentatively employing 25 people which is good for the local economy. Mr. Kuntz explained that OPG remains committed to the safe and permanent disposal of nuclear by-products supporting the NWMO process to site a Deep Geological Repository for used fuel for all of Canada.

Going forward OPG is looking to see whether the 2020-21 federal review of the radioactive-waste policy framework identifies alternate solutions for the disposal of low and intermediate-level materials. Options for low-level materials may include a Near-Surface Disposal Facility. It was noted that any new site-selection process for a disposal facility would engage with stakeholders, Indigenous communities, and the public.

He explained that OPG launched the first-ever Reconciliation Action Plan with commitments to actions and timelines in 5 focus areas: Leadership, relationships, people, economic empowerment, environmental stewardship.

Council questioned what type of materials would be recycled at the new facility. Mr. Kuntz explained that it would be low-level radioactive waste including worker garments, mops, rags, small tools, and pumps, materials with low levels of contamination.

Comments were made regarding the renaming and the storage of used fuel at the current facility. It was noted that there are people supporting rolling stewardship and expansion of the facility at the Bruce so that waste is stored there and retrievable instead of buried.

Mr. Kuntz provided a response on rolling stewardship as what OPG is doing now, interim storage, not a permanent solution or disposal. He explained the problem with rolling stewardship is the risks are much higher in the long run to the environment because buildings and containers degrade over time and don't last forever, thus deferring the solution to the next generation when there is a solution today. OPG believes in living up to its responsibilities and handle the solution today.

It was noted that the world uses carbon to make its power, coal is abundant and that is what the developing nations are using for power which is having a negative effect on the planet, nuclear on the other hand has almost net-zero of carbon suggest getting nuclear as widespread as possible.

5. Public Hearing to Consider Drainage Report

5.1 Sutton Municipal Drain 2021

Steve Brickman, P. Eng, Headway Engineering presented the Sutton Municipal Drain 2021 Report. He explained it was authorized under Section 78 of the Drainage Act. The Sutton Drain was originally constructed under the authority of a report prepared by James A. Howes, dated 1956. There was one on-site meeting held on October 21, 2021, with affected landowners, the report is required because that the original alignment of the drain conflicts with proposed severances, this report will realign the portion of the drain on the Rick Smith Farm Ltd. property. Mr.

Brickman noted that the total cost for the drain is \$51,500 all the costs are assessed to the Rick Smith Farm property.
