Ongoing Recommendations

Water: Well Pump # 2 at Point Clark has been replaced but remains off-line. MCC replacement scheduled to begin in October. The Ripley Elevated Tank site is now on-line. Blairs Grove well casing has severe corrosion (beyond repair) and will be abandoned. BM Ross is assisting in acquiring the proper permits to use the monitoring well as a production well pending the outcomes of a well inspection by W.D. Hopper. A lawn watering ban has been issued to help alleviate the extra demands placed on our Point Clark site. Unannounced Ministry inspections of Lucknow and Whitechurch are in-progress. Site visits occurred on August 13th.

Wastewater: The Pine River Macroinvertebrate study has been completed and results are pending. A sanitary manhole inspection program is being developed.

Other: ACW locates: 0 (198 YTD). In response to the COVID-19 pandemic, Veolia staff has taken the following actions/protocol: Operators are conducting daily monitoring and documentation of their health and wellness. There are no group meetings or entry into private residences permitted. Operators have been assigned to specific work areas to avoid cross-contamination. Operators are to contact Township staff if they need to access shared spaces. New disinfection protocol is in place for vehicles and work areas, and use of PPE as required.
