Estimates suggest that 1/3 of Canada's faith buildings could be in danger of closing. The United Church of Canada reports one building closing a week while the Anglican denomination forecasts a trendline toward a complete loss of members around 2040. With the funding support of the Ontario Trillium Foundation and the City of Toronto, a collaborative team of institutional members designed and executed this survey & report to learn more about the impact of faith-building closures on nonprofit and community groups at a local level and now the conversation continues in this virtual conference.

This Virtual Conference will dive deep into the data collected in the Community Space, Faith Place, or No Space for Community two-year study, with a focus on Huron County and Rural Ontario. The Community Spaces, Faith Places virtual conference will discuss community and not for profit usage of faith buildings and how municipalities, communities, and individuals stop the loss of Faith Building infrastructure in our communities.

## Changes to Snowplowing

Starting this winter, Township of Huron-Kinloss Staff will maintain all roads along the Lakeshore and in Ripley rather than contracting these services as we have for many years.

Canadian winters can be harsh, and we appreciate your patience as our crews work to clear, maintain and provide safe routes of travel this winter.

Snow clearing times may fluctuate while we adjust; however, our staff will be working hard to maintain the same high-level of service.

The following roads will be maintained by Township staff:

- All local roads in the community of Ripley (not including Huron Street and Queen Street, which are maintained by the County of Bruce)
- All municipally owned roads west of Lake Range Drive, including Lake Range Drive

The portal is accessible in the blue bar at the top of every webpage.

To use the mobile account you will need to register an account – all you need is an email address, username and password (you can submit some requests anonymously and your information will not be used for any other purposes).

Submitting a request is easy. Touch the big orange button on the homepage of the app. Take a photo of the issue (if possible) and choose the problem from a list of categories. Provide as much information as you can so we can deal with the issue promptly and efficiently and leave the rest up to us! We'll keep you updated with the progress of your request and let you know when it's been resolved.

## No Parking Notice

To ensure Municipal Snow Plow Operators are able to properly clear snow from roads, Huron-Kinloss would like to remind residents there is no parking on municipal

roads from November 1, 2020 to April 30, 2021, between the hours of 1 a.m. and 6 a.m.

Neither the Township, nor the Snow Plow Operators will be held financially responsible for any damages to a homeowner's property deemed to be on Township road allowance when performing their daily maintenance operations. This includes, but is not limited to, damages involving fences, mailboxes, blue boxes, entranceways, and entrance signage. Please ensure that recycling and garbage is clear from roads not to interfere with snow plow operations. There is the possibility that as snow is cleared, it will accumulate in driveways.

## Fall Leaf Collection

Communities of Lucknow and Ripley - November 2 and 3.

Lakeshore Area – November 3 and 4.

The collection will start at the south end and working north.

- Leaves are to be bagged in paper bags only, placed at the curb by 7 a.m.
- Each street will only be done once.
- The collection is restricted to leaves only.
- Bags must not weigh more than 25 lbs. (11 kg).
- Inclement weather may delay collection to avoid wet & heavy paper bags.
- Leaves are accepted free-of-charge at the Huron Landfill Site year-round (2087 Concession 6 E).

## Temporary Yard Waste Depots Close

The Township of Huron-Kinloss will be closing the Temporary Yard Waste Depots in Point Clark, Ripley and Lucknow effective November 5, 2020.

The Huron Landfill will continue to accept brush and yard waste free of charge year-round.

The Kinloss Landfill will be closed for the winter after October 31 and will no longer accept brush and yard waste.




## **Fall Hydrant Flushing/ Blow Off Flushing**

**MEMORANDUM TO:** Municipal CAOs

**SUBJECT:** Court Security and Prisoner Transportation Program Review

---

The Ministry of the Solicitor General (ministry) is committed to keeping communities across Ontario safe, supported and protected.

As you may recall, in August 2020, the ministry communicated to stakeholders and municipalities that a Request for Services would be issued to retain an external vendor to review programs that support the delivery of court security and inmate transportation across the province, including the Court Security and Prisoner Transportation (CSPT) Transfer Payment (TP) Program. Under the CSPT TP Program, the ministry allocates funding to municipalities to offset costs associated with both court security and prisoner transportation services to and from courts.

The ministry has now retained an independent consultant, Goss Gilroy Inc. (GGI), with expertise in public safety and security to conduct the review, following a competitive procurement process.

In the upcoming weeks, Goss Gilroy Inc. will engage ministry stakeholders – including municipalities, police services and other justice sector partners – to help assess and identify improvements to the court security and inmate transportation process and the design of the CSPT TP Program.

The review will explore best practices and ways to improve the delivery of services, streamline processes and maximize effectiveness to ensure the continued safety of Ontarians. This continuous improvement effort is part of the government's ongoing work to build a more responsive and resilient justice system.



"Rural municipalities face many issues, ranging from affordable housing and broadband to funding for transit and infrastructure improvements," Robinson said. "I am pleased to serve on the ROMA Board as it works to represent the voice of rural communities on these key issues."

"In these unprecedented times, ROMA's advocacy on behalf of rural municipalities is more important than ever," said Lowry. "I'm honoured to work with my colleagues to deliver the best possible outcomes for Ontario's rural communities. I am particularly interested in rural gaps in broadband and healthcare/long-term care."

This fall, the Board will be setting strategic objectives for 2021. Communications is one of the top priorities and the ROMA Board also created a communications working group to ensure it reflects your interests, concerns and needs. ## What does full producer responsibility mean for rural communities?

The federal government's plan to ban single-use plastics was a reminder that plastics continue to take a toll on our environment - and waste diversion budgets. The crisis in plastics- from disrupted recycling markets to multi-layered packaging - have been key drivers in Ontario's move to full producer responsibility.

On the Blue Box, many ROMA municipalities deserve thanks for passing Council resolutions that helped ensure servicing for communities with populations less than 5,000 people, parks and public spaces. Under the regulation, producers will either provide the service directly to the public or they can negotiate commercial terms with a municipality to provide services on their behalf.

Municipalities will have to decide if they want to stay in the business of recycling. For many, that decision will be informed by negotiations with producers and/or their representative organizations on providing the service. This will drive some of the financial implications of opting in or out of service delivery.

Having good data on the cost of current programs - and making those programs as strong resilient and sustainable as possible - will help rural municipal governments navigate these decisions, according to Cathie Green, Public Works Assistant for Drummond/North Elmsley. Cathie has worked on both rural curbside and depot recycling programs. Green said that cost calculations needs to include hidden costs like finance, legal, customer service, maintenance, overhead and Clerk's Office resources.

Green noted that strengthening local programs now will put municipalities in a good position as the program transitions between 2023 and 2025. The most important thing is that by making the shift, producers and packagers will have a stronger financial incentive to make better packaging choices - which helps both the planet and residents. ## ROMA provides input on farm safety regulations

ROMA supported measures by the Ontario Government to help secure safety on farms, while respecting people's rights to express their views. Now, it is providing the Province with input on the regulation under the Security from Trespass and Protecting Food Safety Act. ROMA is advocating for clear definitions and rules that minimize red tape to achieve the Act's goals. Peaceful protests should also ensure the safety of farms, farm families and their staff, and our food supply.
