## BY-LAW

### 2022-83

---

Being a By-Law to amend the Consolidated Rates and Fees By-Law for  
Services Performed by the Township of Huron-Kinloss

---

**WHEREAS** *Section 391 (1) of the Municipal Act 2001, S.O. 2001, c. 25*, as amended, authorizes municipalities to pass by-laws imposing fees or charges on persons, for services or activities provided or done by or on behalf of it; for costs payable by it for services or activities provided or done by or on behalf of any other municipality or any local board; and for the use of its property including property under its control.

**AND WHEREAS** The Council of the Corporation of the Township of Huron-Kinloss deems it advisable to amend the Rates and Fees for Services By-Law regarding Rental Fees for the HUB private office space AND Licencing Fees for the Township of Huron-Kinloss.

**NOW THEREFORE** the Council of The Corporation of the Township of Huron-Kinloss enacts as follows:

- 1.0 That the Corporation of the Township of Huron-Kinloss Council hereby adopts the HUB Rental Fees as contained in the attached Schedule 'P' to this By-Law.
- 2.0 That Schedule 'H' is hereby repealed and replaced with the attached Schedule 'H' of this By-law.
- 3.0 That all other provisions of By-law No. 2022-15 remain in full force and effect.
- 4.0 This by-law shall come into full force and effect upon final passage.
- 5.0 That the By-Law may be cited as the "2022 Consolidated Rates and Fees By-Law Amendment By-Law (2)".
