Being a By-law to Accept a Proposal for the Development of a Parks and Recreation Master Plan for the Township of Huron-Kinloss

WHEREAS the Municipal Act S.O. 2001, c 25, Section 5(1), as amended, provides that the powers of a municipal corporation are to be exercised by its Council;

AND WHEREAS the Municipal Act S.O. 2001, c 25, Section 5(3), as amended, provides that a municipal power, including a municipality's capacity rights, powers and privileges under section 9; shall be exercised by By-law;

AND WHEREAS The Council for the Corporation of the Township of Huron-Kinloss deems it expedient to accept a Proposal for the Development of a Parks and Recreation Master Plan for the Township of Huron-Kinloss;

NOW THEREFORE the Council of The Corporation of the Township of Huron-Kinloss enacts as follows:

- 1.0 That The Corporation of the Township of Huron-Kinloss Council hereby accepts the Proposal for the Development of a Parks and Recreation Master Plan of prc Solutions in the amount of \$58,893.75 plus HST which is outlined and attached in Schedule 'A' and forms part of this By-law;
- 2.0 That the Mayor and Clerk are hereby authorized to sign on behalf of the Council for The Corporation of the Township of Huron-Kinloss, any contracts and other documents required to authorize the works to proceed, and to affix the corporate seal of the Township of Huron-Kinloss.
- 3.0 This By-law shall come into full force and effect upon final passage.
- 4.0 This By-law may be cited as the "Development of Parks and Recreation Master Plan By-law"
