During the meeting Keir discussed the workforce overview including the current nuclear industry supply chain and the MCR Project. Keir shared graduate numbers available from 2018 and the expected workforce demand in the three waves of the Project. Keir also explained the SWOT analysis that was completed on three different options that were developed to realize Project associated local workforce development, if the Project comes to South Bruce. The three options identified by Keir were; Do Nothing, Passive Investment, and Incubate and Cultivate. The presentation was concluded with Five Key Conclusions. Following the presentation, Keir addressed questions that were raised.

5. Recommendations Development Process

Rushton and Webster briefly discussed that this process will be looking at what the studies mean and where to go with them so that the most opportunity could be captured from this Project if it comes to South Bruce.

6. <u>Labour and Housing Recommendations Report</u>

Rushton and Webster shared the Growth Projections. They explained that the difference between the *metroeconomic* projections and the County projections is mainly reflective in the baby boomer population. It was identified that all the communities are expected to grow and the Project could

be apart of that growth. Webster then shared key takeaways that were learned from the Labour and Housing studies. Following the presentation, questions were addressed.

7. Additional Other Business

South Bruce and Brockton have received a letter from the Bruce County Federation of Agriculture about the study they will be conducting. Huron-Kinloss staff present at the meeting were not aware of the letter being sent to their Council as of this meeting date.

Watson indicated that Brockton would be interested in participating in the Municipality of South Bruce led Agriculture Business Impact Study.
